

# Selection criteria and process

# Eligibility criteria

To be eligible for consideration, the nominated event must:

- Is an Australian Money Tournament, Australian Junior Tour event or Australian ITF Junior event;
- Held the final day of the tournament between the award period
- Complied with all rules and regulations set by Tennis Australia
- Has offered players social activities and player amenities to a high standard allowing for a positive tournament atmosphere.
- Utilised Tournament Planner (TP) software program and Active Network online registrations system.
- Have a pro-active tournament committee
- Fulfilled all officiating requirements or gone above and provide their own accredited officials

#### Selection criteria

The selection panel will consider the following in assessing nominations:

• The award period is from 10 September 2015 – 9 September 2016. Only achievements/details from this period will be considered by the panel

1	The type, volume and level of success of media and promotional activities undertaken		
2	The type of social activities and the standard of player amenities provided, and how this contributed to a positive tournament atmosphere.		
3	The type and success of strategies engaging the local community with the tournament		
4	The standard of the tournament sponsorship program and the level of service provided to the sponsors		
5	The level of pro-activity shown by the tournament committee and the success of the pro-active actions		

#### **Selection process**

Only information provided by the nominee with their nomination form will be considered by the selection panel. Nominees should attach any relevant additional information with their nomination form.

All decisions in relation to the Most Outstanding Tournament award (including any questions in relation to eligibility) will be determined by the selection panel in its absolute discretion. All decisions are final, and no correspondence will be entered into.

Any matters which arise and which are not covered in this document will be determined by the selection panel in consultation with Tennis Tasmania management.
