#### **TOURNAMENT RULES & CONDITIONS**

- This tournament will be conducted in accordance with the "2017 Australian Ranking Tournaments Rules and Regulations" and Tennis Australia's "Member Protection Policy" (each as amended from time to time). By entering this tournament you agree to abide by the Tournament Rules and Conditions. Where the word "I" is used, this refers to you the entrant.
- Disciplinary Statement: "I acknowledge that as a participant in this Tennis Australia sanctioned event, I agree to comply with the ITF Rules of Play, the Tennis Australia Member Protection Policy, Tennis Australia's Code of Conduct(s) and Tennis Australia's Anti-Doping Policy.
- Spectator Behaviour Statement: Inappropriate spectator behaviour could result in denial of entry at future Tennis Australia and Member Association sanctioned events, and will be dealt with in accordance with these policies.
- Media Statement: "I consent to being involved in any publicity connected with a Tennis Australia sanctioned tournament, including media interviews, photographs and TV footage. Please inform the Tournament Manager if you do not wish to be involved in publicity.
- Data Usage Statement: "I consent to Tennis Australia and/or the organisers of Tennis Australia sanctioned tournaments using the details provided on the entry form to communicate information about this and future tournaments, via post, email or SMS.
- I acknowledge that all Tennis Australia policies can be readily viewed at www.tennis.com.au and that it is my responsibility to view these and seek clarification if required, from the Tennis Australia Tournaments & Competitions Department.
- 7. Play will commence punctually at times advised. Competitors must report to the Tournament Office and be ready to play 15 minutes prior to the scheduled match times. However, the Tournament Committee reserves the right to alter the times of play if necessary. Any player who does not play in a match when selected to do so by the Tournament Manager will be disqualified.

- 8. The Referee will be the sole judge as to whether the courts are fit for play and shall decide whether or not a match shall be continued or postponed.
- 9. Competitors may enter four (4) events but may only enter one (1) mixed doubles event.
- 10. All events are knockout and there will not be consolation for any events.
- 11. Men's and Women's Singles Championship of Goulburn Valley (Open singles events 1 and 3):
  - (a) Players entering in Open singles may enter Plate singles event 6 or 7.
  - (b) State Grade players are ineligible to play in Plate singles event 6 or 7.
  - (c) Players entering in Open singles who are not seeded may play in A Grade events.
- 12. In matches when an umpire is appointed, their decision on a question of fact shall be final, but an appeal shall lie to the Referee from the decision of an umpire on a question as the "laws of the game" or the application thereof, and in all cases the decision of the Referee shall be final.
- 13. The Referee and the Tournament Manager shall have the power to appoint a deputy, and failing such appointment, such power in each case where the need arises shall be exercised by the Tournament Committee. The Referee and the Tournament Manager also reserve the right to cancel an event or make any alterations considered necessary.
- 14. Competitors may be required to play on the Synpave courts or use outside courts at the committee's discretion.
- 15. If a competitor is still in four (4) events on the final day, the committee has the right in its sole discretion to scratch him or her from any event.
- 16. It is recommended for every player to have Personal Accident Insurance cover (available from Tennis Victoria).
- 17. The Slazenger Grasscourt tennis ball has been adopted for exclusive use at this tournament.
