It was noted that Clubs participating in the competition should be affiliated with Tennis Tasmania to ensure players, and committees are appropriately covered by insurance. Helen Courtney-Pratt moved to allow the AYC Committee to continue negotiating with Tennis Tasmania on their proposal and to seek ways to simplifying the rules of the AYC competition, including grading. Seconded by Gail Semelbauer. Motion **carried**.

Item 11. General Business

Ros Williams wished to thank Sue McKenzie for her years of commitment and dedication to the Association in her role as committee member and President over many years.

Paul asked if the committee would be asking for 4 or 6 player teams for this pennant. It was decided the committee would ask for 4 player teams for Division 1 and 2 with an option for handicapping in Division 1. The preference is for 6 player teams for the remainder of the divisions.

John Fletcher asked if the committee would look into one night per Division. It was agreed the committee would look at reducing the number of nights each Division played and would seek advice from Tennis Tasmania in moving to one night in future seasons.
