[Part 3 Registration of Teams]				
[Teams] 14. (1) A team must consist of 3 male nominated players and 3 female nominated players or 2 male and 2 female players as required by the Association.	Teams 14 (1) A team must consist of at least 4 players. Gender requirements may be specified for particular divisions which will be decided by the Tournament Committee and communicated to Club representatives by 1 August.			

This rule change is proposed to allow 4 person teams without specifying the format for those teams, whether they be non-gender based or 2 male/2 female players. It would also provide flexibility for the tournament committee to have 1 or more divisions consisting of 6 player teams should that be desirable.
