Discussion of rule change opened up to the floor. Alan was President of the AYC Association from 1997 -2006. He had a great interest in player statistics, grades and results and always made sure he was up to date with what was happening with the competition before attending meetings.

Alan's attention to detail and the need to have rules that generated a level playing field resulted in many necessary rule changes including those for fill ins in finals.

Alan won the John Drake Memorial Award for service to the association in 2006-07.

In 2012 He was presented with a Life Membership of the AYC. This was in recognition of his many years of service to the competition including his time as President when he was always available to help run Championships and grading nights.

I think all who knew Alan would agree with him that he played well for his age.

Sadly Alan passed away in February 2018.

### Ray Thompson

Ray Thompson and his wife Judy started playing AYC Tennis in 1963 for a team called Nettlefold's. After that Ray went on to play for Alexander between 1970 and 1976.
