VISA INFORMATION

All persons attending Australian Open 2022 in a playing or working capacity should apply for an Australian working visa.

Below are the three visa types for entry into Australia for AO22 as agreed between Tennis Australia and the Department of Home Affairs.

Please read through the below information to ensure that you apply for the appropriate visa type according to your role or activities at AO22. Any participants found to be holding an incorrect visa (eg. tourist - Visitor Visa, ETA, eVisitor) may be refused entry to Australia or have their visa cancelled.
