<b>Entry Restrictions</b>	Entry is open to all primary schools within Australia. This doesn't exclude P-12 schools.
<b>Competition Period</b>	<p>The Competition begins at 12:00 AM AEST on 15 October 2024 and ends at 11:59 PM AEST on 28 September 2025.</p> <p>Note, these dates represent the end of school term dates for each relevant State.</p>
<b>Entry Method</b>	During the Competition Period entrants must submit evidence (video or photo) of how the school and its pupils are participating in tennis through a designated form which will be accessible via the Tennis Australia website.
<b>Maximum number of entries</b>	Unlimited entries per school. Entrants are only eligible to win one prize.
<b>Prize Details</b>	<ol style="list-style-type: none"><li>1. A visit from Ash Barty to the school in Term 4, 2025.</li><li>2. A copy of a 'Little Ash' book for each student in the school, including surplus copies for the library.</li></ol>
<b>Notification of Winners</b>	The winner will be notified following the competition period via email. There will also be content published on social media, editorial and PR to promote the winner.
<b>Publication Details</b>	N/A
<b>Prize Claim Date and Time</b>	The Prize must be claimed within 14 days of notification.

#### **Tennis Australia Trade Promotion: Game of Chance – Terms and Conditions of Entry**

1. These terms must be read together with the Schedule for the Competition which defines certain terminology used in these terms and conditions. Entry into the Competition is deemed acceptance of these terms.

#### **Eligibility to Enter**

2. Entry is only open to schools in the Location who comply with the Entry Restrictions (if any). The Promoter reserves the right to request the winner to provide proof of age, identity, residential address and purchase of a ticket to an Event Day, in order to claim a prize. Proof of age, identification, address and ticket considered suitable for verification is at the discretion of the Promoter. If the winner cannot provide suitable proof, the winner will forfeit the prize in whole and no substitute will be offered. Entrants may submit the Maximum number of entries.

#### **Entry**

3. To enter the Competition, entrants must follow the Entry Method during the Competition Period. All entries received after this time are ineligible for entry into the Competition and no responsibility will be accepted by the Promoter for lost, late, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries claims or correspondence.
4. The winner will be selected by random draw.

#### **Prize**

5. The Prize is specified in the Prize Details.
6. The Prize is not transferable, exchangeable or redeemable for cash. The Promoter accepts no responsibility for any variation in the value of the prize after that date. Refunds will not be made in respect to unused services or prizes. Where the Prize, or part of the Prize, is unavailable, the Promoter retains the right to substitute the prize (or part) with a prize (or part) of equal or greater value subject to relevant State and Territory regulations.
7. If for any reason whatsoever the winner does not take an element of the prize at the time stipulated by the Promoter then that element of the prize will be forfeited by the winner and cash will not be awarded in lieu of that element of the prize.

Each entrant warrants that it has all necessary and appropriate consents to grant TA the rights contained in this provision.
11. Each entrant must ensure that any other person whose details have been provided by the entrant to the Promoter for the purposes of the entrant's participation in this Competition has given their implied or express consent for their details to be provided to the Promoter and any of its related bodies corporate and to be contacted by the Promoter or any of its related bodies corporate in relation to this Competition.

**Discontinuance and Disqualification of Competition**

12. The Promoter reserves the right to discontinue the Competition at any time and at its sole discretion may cancel, terminate, suspend or modify the Competition and/or, if necessary, to provide an alternative prize or prizes to the same value as an original Prize. Any change to or cancellation of this Competition, for whatever reason, is subject to the written direction of all relevant legislative departments in the Location.

Without limiting the foregoing, the Promoter reserves the right to verify the validity of entries and to disqualify any entry which, in the opinion of the Promoter, can be considered objectionable, profane, potentially insulting, inflammatory or defamatory, or any entrant whose entry is not compliant with these terms or who has, in the opinion of Promoter, engaged in conduct in entering the Competition which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the Competition and/or Promoter.
