

terms & conditions of accreditation

Accredited entry into Perth Arena (**PA**) for the 2013 Hyundai Hopman Cup (**HC**) is subject to the Hyundai Hopman Cup Ticket Conditions of Sale and Entry¹ and these Terms and Conditions of Accreditation:

- 1. Hopman Cup Pty Ltd (**HCPL**) reserves its right to withdraw accreditation at any time at its sole discretion.
- 2. Accreditation passes are non-transferable and must be worn correctly at all times with your photo clearly visible.
- 3. Your access to restricted areas within PA is limited to that necessary to perform activities directly relevant to the reason for your accreditation.
- 4. You must abide by all directions from HC and PA officials at all times.
- 5. You must not take unauthorised photos, video stills or video footage within restricted areas of PA or request autographs from players.
- 6. You must not leave any dependent children unsupervised at any time.
- 7. You must comply with the ITF Welfare Policy (available at www.itftennis.com).
- 8. You must comply with all the provisions of the Uniform Tennis Anti-Corruption Program (available at www.tennisintegrityunit.com) **including but not limited to** adhering to the prohibitions on gambling and betting outlined below and reporting any knowledge or suspicion of such behaviour to the Tennis Integrity Unit as soon as possible.
- 9. Players, "Related Persons" and "Tournament Support Personnel" must not directly or indirectly:
 - wager or attempt to wager on the outcome or any other aspect of any tennis match or competition;
 - provide for consideration information concerning the condition or status of players;
 - solicit or facilitate any other person to wager on the outcome or any other aspect of any tennis match or competition;
 - contrive or attempt to contrive the outcome or any other aspect of an event; or
 - solicit or facilitate any Player to not use his or her best efforts in an event.

A 'Related Person' is 'any coach, trainer, therapist, physician, management representative, agent, family member, tournament guest, business associate or other affiliate or associate of any Player, or any other person who receives accreditation at an Event at the request of the Player or any other Related Person';

Tournament Support Personnel' is 'any tournament director, owner, operator, employee, agent, contractor or any similarly situated person at any Event and any other person who receives accreditation at an Event at the request of Tournament Support Personnel.' This includes but is not limited to HCPL employees, agents, contractors and sub-contractors.

¹ To the extent that any conditions of the 2013 Hyundai Hopman Cup Ticket Conditions of Sale and Entry prevent you from performing the activities directly relevant to the reason for your accreditation, you are exempt from adhering to those conditions to the extent necessary to allow you to perform those activities.

- 10. If you are an employee, agent, contractor or sub-contractor of HCPL or the HC Tournament you must abide by the:
 - Hyundai Hopman Cup OH&S rules; and
 - any policies and procedures advised by HCPL from time to time.
- 11. You must adhere to PA Emergency Procedures at all times.
- 12. If requested by HCPL, you must provide evidence of background checks, including but not limited to national police checks.
- 13. Guest passes are available to players' legitimate guests (in good faith) and are subject to the 2013 Hyundai Hopman Cup Player Accreditation Policy. A player must not receive any direct financial or other benefit as consideration for nominating a guest for accreditation.
- 14. HCPL may alter these terms and conditions at any time if such changes are reasonably necessary to address safety issues or otherwise protect legitimate interests of HCPL or AEG O Ogden (Perth Arena) Pty Ltd.
- 15. By applying for accreditation to the HC, you consent to the collection and use of your personal information by Ticketek and HCPL and the disclosure of that information by Ticketek to HCPL for the purposes of ticketing and event marketing purposes in the promotion of the HC and related events. Where the information is used for marketing purposes you will be given the opportunity to 'opt out' from receiving further marketing material. You may contact HCPL (Lakeside 144 Northwood St, Leederville WA 6007) and Ticketek (at GPO Box 1610, Sydney NSW 2001) to request access to the information held about you.
- 16. You consent to being photographed, filmed and recorded as an HC patron, and consent to use of any such film, image or recording at the discretion of HCPL, its commercial partners or law enforcement agencies without compensation or notice.
