EXCERPTS FROM AND INTENT OF BY-LAWS

FORMAT (10e & 14a)

Teams of 4 women playing 6 x 6-game tie-break sets (tie-break at 6 all), in the sequence: 1&2, 3&4, 1&3, 2&4, 1&4, 2&3.

Match won by team winning more games. If games are equal, match won by team winning more sets. If games and sets are equal, match is a draw. 9 points shall be allocated for each Home and Away match. 3 points shall be awarded for winning the match, 1 point for each set won, and 0.5 point for each incomplete or not commenced set. If a match is a draw or not commenced, other than by a default of a team, each team receives 4.5 points. If a match is not completed and a result is not obtained, each team shall receive 1.5 points, 1 point for each set won and 0.5 point for each incomplete set. If a match is not commenced on account of the default of a team, the winning team receives 9 points and the team in default 0 points.

ONLINE ENTERING OF RESULTS

Winning team (Home team if no winner) must enter results online by 7pm Thursday after the match.

EMERGENCY PLAYERS (12g)

Prior to the commencement of the match on each occasion, 'E' must be written against a player who was not nominated on the Team Entry Sheet for that team or a team in a lower section and details of their standard written in the comments box on TROLS.

COMMENCEMENT and FINISHING (11b)

Starting time is 9.30am

Two courts are to be provided, play shall commence by 9.35am on both courts. If play has not commenced by 9.35am, the team in default shall forfeit the set(s) which has not commenced. The 3rd or 4th sets are not required to be forfeited until 10am. Thereafter, a team in default for more than 5 minutes after completion of the preceding set shall forfeit the set.

Matches are to finish at 2pm if not already completed. A game, including a tie-break, in progress at 2pm is to be completed.

DEFAULT (11g)

A team defaulting 3 times in a season shall be disqualified.

INELIGIBILITY (12d)

Players are ineligible for a section after playing 4 matches in a higher section. After playing 3 matches with a team a player cannot play with another team in the same section.

ELIGIBILITY FOR FINALS (12e)

Players are eligible to play in a final after playing 3 matches in that section or in lower sections, subject to by-law 12(c). Matches cancelled by mutual agreement without attendance and forfeited matches do not count as played matches.

SUBSTITUTE PLAYERS (12f)

Eligible substitutes may replace ill or injured players or other emergency provided continuity of the match is maintained.

HEAT (13a)

Matches are to be abandoned when the temperature reaches 31.5°C on www.bom.gov.au. Select Melb Obs, scroll down to Viewbank, note time on TROLS.

RAIN OR FROST (13a)

Matches can be cancelled due to rain or frost from 8am by mutual agreement between the 2 captains with or without attendance. If there is no mutual agreement to cancel, attendance is required. If play has not commenced and courts are not playable by 11am the match is cancelled and is a draw.
