Search for a (Coaching) Star - Scholarship Terms and Conditions

The Search for a (Coaching) Star Scholarship Program (**Scholarship Program**) is funded and administered by Tennis New South Wales Limited ACN 000 011 558 ('**Tennis NSW**'). The Scholarship Program is designed to give young persons interested in tennis the opportunity to kick start their tennis coaching career.

The following terms and conditions apply to the Scholarship Program:

- 1. Applications are open to individuals who fulfil the eligibility criteria as set out in the "Eligible Applicants" section of the Search for a (Coaching) Star Scholarship Program Guidelines ('Application Guidelines') available at www.tennis.com.au/nsw.
- 2. If an Application does not comply with these terms and conditions or the Application Guidelines, the application will be ruled invalid and withdrawn from consideration.
- 3. To apply for a grant, applicants must accurately and truthfully complete all sections of the Search for a (coaching) Star Application Form available online at www.tennis.com.au/nsw.
- 4. To be considered for the Scholarship Program, completed Applications must be submitted by the deadline set out in the Application Guidelines.
- 5. These terms and conditions are to be read in conjunction with the completed Application Form, the Application Guidelines and the eligibility criteria detailed in the Application Guidelines (collectively, 'the Application Documentation').
- 6. The Application Documentation form the terms of agreement for the distribution of the Scholarship.
- 7. As the number of responses may be substantial, not every application will necessarily receive a Scholarship. Tennis NSW has ultimate discretion as to who to award a Scholarship to, and Tennis NSW's decision is final.
- 8. In making decisions around the awarding of scholarships, Tennis NSW will be guided by the principles set out in the Application Guidelines.
- 9. By submitting a completed Application Form, applicants and successful grant recipients consent to Tennis NSW disclosing the information provided in the Application Form to other Australian Tennis Organisations (as defined in the Tennis Privacy policy located at www.tennis.com.au/privacy) for the purposes of conducting the Scholarship Program, reviewing, processing and awarding the Scholarships and any other matter connected to or incidental to the Scholarship Program.
- 10. Applicants and recipients may be contacted by Tennis NSW directly for the purpose of validation of information contained in the completed Application Form and due diligence. All completed Application Forms become the property of Tennis NSW.
- 11. Scholarships will be provided to recipients in the form of a subsidised Tennis Australia coaching course.
- 12. Scholarships must be used at the Tennis Australia Coaching Courses specified in the Application Guidelines. Recipients who are unable to attend the Tennis Australia Coaching Courses specified in the Application Guidelines may forfeit their scholarship at the ultimate discretion of Tennis NSW.
- 13. For the avoidance of doubt, a scholarship recipient will be entitled to a discount rate on the Tennis Australia coaching courses set out in the Application Guidelines. Tennis NSW will not be providing any money or funds to scholarship recipient.
- 14. Tennis NSW may vary the amount of the subsidy for the Scholarship at any time and at its sole discretion.
- 15. The recipient acknowledges the importance of maintaining the good name and reputation of Tennis Australia and Tennis NSW.
- 16. The grant recipient consents to Tennis NSW and its government and commercial partners taking images of the recipients as part of the Scholarship Program, and that any such photographs or

- video footage may be used by the above organisations for use in promotional, advertising or marketing materials, without any further notice or payment to the grant recipient.
- 17. The Scholarship Program can be suspended or terminated at any time by Tennis NSW without notice.
