

#### Overview

#### Heritage

Tennis NT was established in 1980 under the incorporated name of the Northen Territory Tennis Council.

The organisation changed its incorporated identity in 2005 to Tennis NT Incorporated and now trades simply as Tennis NT.

Its establishment was the shared vision of the founding President, Mr Max Horton OAM and a small group of interested tennis players.

Their vision foresaw the need for a 'parent body' to assume the role of governance along with the benefits of establishing relationships with the Northern Territory Government and Tennis Australia (TA).

#### **The Environment**

The Northern Territory has a strong tennis history underpinned by the hard work and dedication of many individuals. Testament to this heritage is the NT Open which began in 1920, making it one of the Territory's oldest annual sporting events, which quickly gained national recognition.

Most competitive and social tennis in the Territory revolves around the network of clubs and centres across the NT, and the relatively new state-of-the-art Darwin International Tennis Centre (DITC). In addition, the Top End has multiple public access courts which are predominantly owned by Local Government and schools. While these courts lack lighting or booking systems they are generally well maintained and well spread across residential areas, with relatively high usage.

#### Where Tennis NT fits in

Tennis NT is the peak body of tennis in the Northern Territory. Our role is to grow the number of people playing tennis more often, in a safe and welcoming environment.

Its role is to coordinate, manage and promote the sport of tennis in the NT and in so doing, support and service its affiliated clubs and centres.

Our national peak body is Tennis Australia (TA) which provides substantial funding, resources and other forms of support. However, Tennis NT is a separately incorporated organisation that reports to its own, local, Northern Territory Board.

The NT Government also provides substantial funding and is a key partner.

Tennis NT is located at the Darwin International Tennis Centre (DITC) at the Marrara Sports Complex.

It has affiliates across the Territory including in Alice Springs, Katherine, Nhulunbuy, Palmerston and Darwin.

## President's Report





#### It is an honour to serve the NT tennis community as President of Tennis NT

It has been a year of significant change for tennis in the NT. Whilst the year had many challenges, it also came with highlights and positive outcomes.

The Territory's interest in tennis is strong and has grown across FY22-23. We can see this from our data which shows larger NT audiences to all consumer-facing websites. The play.tennis.com.au website grew by 15%; Hot Shots Tennis website by 57%; and Cardio Tennis website by 86%. This demonstrates a healthy interest in tennis and national programs across the NT.

Additionally, we can see that clubs who use ClubSpark for court hire had a 12% increase in court hire bookings this financial year compared to the year prior.

Tennis in Schools also had a great year with a 12% increase in participants. The majority of that growth came from secondary schools.

We must capitalise on this interest by making it easy to get people playing at clubs. Three areas of focus to enable that are; to simplify how tennis is presented online; provide better support to clubs and centres and crucially, to grow the number of coaches delivering tennis at clubs and centres.

A key component of FY22-23 was staging a "relatively normal" year of tournaments and events, without the threat of covid-related disruptions. However, there were still challenges with scheduling and resourcing. A number of events moved on the calendar, and there were positive and negative variances in entry levels on an event-by-event basis. Overall, event entries grew by 39% in FY22-23.

We are committed to improvements in planning and communication of the overall competitive play calendar – and have been proactive in working with our stakeholders to do this for FY23-24.

From a talent perspective we worked closely with coaches within our NDS and Zone Squad programs. Participants were given the opportunity to learn from a range of industry professionals, and continued their focus on themes of professionalism, intensity, and culture.

Our NT teams went to the Gold Coast to compete in the 2023 National Teams

Championships in June; we thank our Top-End-based coaches, Alex Capill and Ben McLachlan for their support and commitment to manage these teams alongside Jessica Polack and Emily Ooms-Webb from Tennis NT.

I am pleased to report that, as you will see in the financial section of this Annual Report, Tennis NT has remained in a sound financial position. FY22-23 delivered a small operating surplus (before depreciation).

Following the departure of CEO Tom George back to his hometown of Canberra in February, we were lucky to have Simon Lavers take on the Acting CEO role for the second time before departing Tennis NT in April. Many thanks to Jessica Polack who stepped up as Acting CEO from April to June. We thank Jess for her stewardship of the team, her energy, and her assistance onboarding the incoming CEO, Tania Tandora, who started in June 2023. You have a bright future, Jess!

New CEO Tania Tandora certainly hit the ground running and has made a big impact in a short period of time. Welcome Tania, you are making a difference.

Tennis NT staff have weathered considerable change and answered the call to step in on areas above and beyond to fill resource gaps through the year.

We have farewelled much-loved Board members and staff-members and welcomed new people into the team through FY22-23. Benjamin Cunningham our Tennis Development Officer started in July 2022, and Sam Giess became our Tournaments, Competitions and Operations Manager in February 2023.

Jessica Polack, Emily Ooms-Webb, Ben Cunningham, Jason Wang and Sam Giess of the Tennis NT team. Your resilience cannot be overstated. Thank you for your commitment, leadership and team-work in the face of considerable pressure.

I would like to express my gratitude to the tennis community across the NT. Tennis relies on the passion of clubs, coaches, officials, teachers, players, volunteers and staff at all levels. The game asks a lot of you and cannot survive without you. Thank you. Let us grow these relationships and achieve our shared goals of growing tennis in the NT and seeing clubs thrive.

I would also like to recognise my fellow Board members. As the incoming Board members will find, governance of an organisation like Tennis NT is not easy, comes with many challenges and involves a lot of time and effort. Thank you. In particular, I would like to thank Vice President Alicia Boyle, who leaves the Board after reaching the end of her maximum tenure. Alicia has been a wonderful servant of the game for a long time and we will miss her greatly.

Lastly, I appreciate our major supporters Tennis Australia and the NT government. Their continued support and commitment to tennis in the NT enables us to plan a wonderful future.

## From the CEO of Tennis Australia

#### Game on for growing Australian Tennis together



As we look back on another successful year in Australian tennis, growth and teamwork are defining themes.

The Tennis Australia values of imagination, collaboration, humility and excellence were fundamental as we celebrated new milestones in participation, with more than 1.5 million Australians engaged in the sport.

It was collaboration, however, that was arguably most pivotal as we embarked on a major strategy to ensure our tennis community could build on those gains.

From coaches to volunteers, clubs to schools, administrators to officials and of course, all levels of players, every possible area of tennis was represented as we created the 'Game On' strategy. It carries a clear and simple objective to get more people playing tennis more often – regardless of how, where or what form of the game they play. In careful consultation with our tennis community, three key pillars are part of that plan.

Firstly, we aim to get more kids to start playing tennis. This sees us proactively targeting schools, supporting and developing more engaging coaches, and making it easy for parents to get their kids into the game.

Keeping kids and teens in tennis is also a focus with plans for a nationally branded social and team-based way to play, as well as the expansion of existing competitions.

Getting adults back into tennis is the third pillar, helped by the creation of compelling promotions for how, where and with who to play tennis. The rollout of complementary and easier-to-play formats – such as Padel, Pop and Pickelball – are strategically included as part of that promotional plan.

The overall good health of the sport in this nation provides an encouraging foundation for success. The latest Ausplay data shows a turnaround in the number of children playing the sport, which is up six per cent year-on-year. We've also managed to grow our total participation (1%).

When comparing our overall growth this year to last, it is important to remember that we grew more than 32 per cent since 2019 (pre-COVID) while most other sports lost participants during this period. On this basis, we are comparable in our growth.

As we welcomed the world's best players for the summer of

tennis, leveraging events to provide fans with memorable experiences further boosted participation goals.

While the United Cup, an innovative teams event, was staged for the first time in Sydney, Perth and Brisbane, the Adelaide International and Hobart International also helped patrons forge a stronger and more accessible connection to the sport.

And as the Australian Open returned to pre-pandemic operations, a memorable 111th edition generated both a new passion to experience tennis and funds that are invested into the development of our grassroots game.

Other milestones highlight our objective to make tennis a sport that's welcoming to all. Within our Women and Girls strategy, the goal to increase the representation of women coaches was happily achieved.

The 883 women coaches that are now delivering tennis at clubs, community centres and schools across Australia represent a 10 per cent increase, reaching our Australian Sports Commission target. Of course, we still want to do more.

Fostering engagement in other areas of the community is also key. The National Indigenous Tennis Carnival returned to Darwin in August 2022, allowing aspiring First Nations players with the first step in the potential journey to emulate heroes such as Ash Barty and Evonne Goolagong Cawley.

It brought together a record 230 participants from every Australian state and territory, providing the opportunity for general participation, national competition (in both 14/u and 18/u categories) as well as cultural activities off the court.

None of these achievements would be possible, of course, without painstakingly maintained venues and facilities, or the many valuable contributors to our sport.

We especially thank the 25,000 dedicated volunteers who facilitate the delivery of tennis at every level across the nation. There's a parallel appreciation for the coaches who are fostering connections to tennis, as well as the network of officials who are critical to the delivery of our sport.

Those combined efforts also ensure that competitive play opportunities continue to expand. With an awareness that

great competition not only breeds great competitors but also

great tennis communities, there have been numerous highs in club competitions, leagues, team tournaments and professional tour events throughout the past year.

Meanwhile, we can also celebrate the many Australian role models making career-best gains on the global tours. As numerous pro players set new ranking highs in both singles and doubles, Australian tennis proudly shone in team events as well.

John Peers and Storm Hunter notably combined to triumph in the US Open 2022 mixed doubles competition. Alongside Ajla Tomljanovic, Ellen Perez, Priscilla Hon and much-loved veteran Sam Stosur, Hunter also starred as Australia progressed to the Billie Jean King Cup Final, finishing runnerup to Switzerland.

Led by Australian No.1 Alex de Minaur, the Australian Davis Cup team contested a 48th final in the world team competition. Thanasi Kokkinakis, Max Purcell and Matt Ebden also featured in the team's inspired campaign, which was second only to Canada.

Another exciting breakthrough followed in Melbourne, when popular Australians Rinky Hijikata and Jason Kubler claimed the Australian Open men's doubles title. It marked a maiden major title for the local wildcards, who teamed-up at their home Grand Slam for the first time.

From grassroots to professional level, we can look back on a remarkable and transformative year in Australian tennis.

There's both much to celebrate and a huge passion to grow our sport even further through more participants, greater engagement and a generally thriving tennis community.

Most exciting perhaps, is that it has been a true team effort. Thanks to all of you who make our future bright.



## Schools and Tennis

Towards the end of the financial year, all schools that were registered as a partner school with Tennis NT/Tennis Australia were asked to complete the yearly School Participation Survey. This provided a summary of participant numbers, experiences, and satisfaction.

The reporting shows a year-on-year comparison for participants involved in school programs from both primary and secondary levels, as well as response rates.

NT saw a 12% participation increase in comparison to the previous reporting period, the majority of growth came from Secondary schools.

NT's growth bucked the national trend that showed a slight decrease in schools' participation.

Note that this data is based on completed survey numbers – it is vital for schools to participate in the survey to enable better data and outcomes for tennis.

In NT, the survey response-rate lifted from 68% in FY21-22 to 88% in FY22-23, well above the National response-rate which was 76%.

#### Teacher Professional Development

Tennis NT held several professional development opportunities for teachers to learn how to confidently deliver tennis as a sport for life within their school/s. The overarching theme – you do not need to be a tennis expert to deliver tennis in schools!

There was also a teacher PD held within the Darwin region last year in August 2022. These days provided an opportunity for teachers across regions to network and share their ideas about tennis in schools.



#### Interschool Sports

The schools within the Big Rivers Region came together in the first four weeks of Term Two, 2023 to get involved in fun interschool sports activities focused on tennis. Tennis NT was pleased to join in the final week of activities. A fantastic initiative by the schools within the region. Tennis NT would like to personally thank Rodney Gregg from Casuarina Street Primary School for facilitating the days, as well as Katherine Tennis Club for hosting over seven schools and an average of fifty participants each week.



#### Gala Days

Tennis NT partnered with the Department of School Sport Education NT and several of our clubs to coordinate three Tennis Gala days. Each of these days were focused on participation, enjoyment, and physical activity through tennis.

Gardens Tennis (Darwin Region), Tennis Palmerston (Top End Region) and Alice Springs Tennis Association (Central Region) each hosted a gala day. The gala days were a fantastic opportunity for participants across our regions to learn the basics of tennis in a fun and relaxed environment.

We thank School Sport NT and our clubs for helping facilitate these participation opportunities.

The gala days were held in each region and club on the following dates:

- Alice Springs Tennis Association / Central Region May 2023 > 70 participants across four schools.
- Tennis Palmerston / Top End Region May 2023 > 50 participants across four schools
- Gardens Tennis / Darwin Region June 2023 > 50 participants across four schools. There was also another tennis gala day held last year in September 2022 with >100 participants and 8 schools involved.



## Ballkids Program Launch

In late June 2023, Tennis NT held an information session for a proposed NT ballkids program. It was great to see kids interested in learning about what it takes to be a successful ballkid. There is also an opportunity to go to the Australian for one hard-working, purpose driven participant. Watch this space.



#### Digital

The Territory's interest in tennis is strong and has grown across FY22-23. We can see this from our data which shows larger NT audiences to all consumer-facing websites. The play.tennis.com.au website grew by 15%; Hot Shots Tennis website by 57%; and Cardio Tennis website by 86%. This demonstrates a healthy interest in tennis and national programs across the NT.

We are happy to report that all 7 clubs and centres have websites; 5 of those 7 clubs and centres support online transactions for relevant products at their club and 4 of those 7 clubs and centres make court hire purchase available to the public via their website on a casual basis.

For Clubs and centres who use ClubSpark, there are monthly training and Q&A sessions available via the Tennis Australia team, and additionally there is access to self-serve training on the system support site. The ClubSpark system has also had development since its launch, with a focus on improvements for coaches' use of the platform. Tennis NT will revisit this with coach operators in the coming year.

Holistically, Tennis Australia is working on a digital transformation roadmap. A key feature of this is integrated identity management. While Tennis NT is reliant on Tennis Australia for the overall Tech/IT roadmap delivery, the Tennis NT community have supported change by ensuring that all competitive players create a "Competitive Player Profile" (a Tennis ID + UTR account). This has improved data quality and will aid with future improvements to systems. The NT has a 93% uptake of Competitive Player Profile, and nationally have been the most effective with driving change.



## Customer Satisfaction Survey (Potentiate

Report)

Tennis Australia regularly commissions a customer satisfaction survey that goes to club, coach and council stakeholders nationally. From June 2022 to June 2023, NT fell from having the highest satisfaction rate nationally (8.4) to the lowest (6.7). A factor in this decline is the quality of the data collection, as the survey in June 2022 had 11 respondents, but only 7 respondents in June 2023. Additionally, it is clear that many being surveyed are not stakeholders, which has skewed results.

Notwithstanding, our intent is to take the spirit of the feedback and deliver positive change with regard to improved communication; understanding of the affiliation value proposition; marketing support; consistency of service. We also will be working closely with Tennis Australia to bridge the gap in coach development.

### Women & Girls





#### Women Leaders in Tennis 2022

The Women Leaders in Tennis participants graduated in November 2022, with each woman leader presenting their Action Learning Project as part of the second and final face-to-face day. The presentations covered a range of topics, selecting an interest area that was important to them or within their local community / club.

The program focused on building leadership knowledge, skills, and confidence, whilst also growing a network of like-minded women. Facilitated by Jahna Sedar from IPS Management Consultations and with Andrea Buckeridge from Tennis Australia overseeing the program nationally, it was a positive initiative for the environment with great collaboration amongst the group. The aim is to run a second program in 2024, to continue to grow the network of women in tennis in the Northern Territory.

#### **Gove Trip #NoLimits**

In May 2022, Tennis NT travelled to Nhulunbuy to visit the Gove Peninsula Tennis Club and experience on court sessions with Head Coach, Nicky Mayer, as well providing Coach Development. Nicky has been running the #NoLimits Girls' Squads as part of a national initiative to retain girls in tennis. Tennis NT co-delivered the Friday afternoon #nolimits' Girls' Squad with Nicky, offering insight into focus areas for further development. The girls were thriving in the environment and their confidence had soared since the beginning of the program. During the visit, Tennis NT delivered a Foundation Coaching Course, as well as being involved in the delivery of orange and green ball lessons, to provide information as to the level of the players comparatively with others across the Northern Territory.

#### Club Super Challenge



#### **Hot Shots Circuit**

The launch of the Hot Shots Circuit in April 2023, provided an opportunity to Green Ball players to compete towards gaining a spot in the 'Bolt to Brisbane' in QLD. Green Ball events were attached to every local tournament, with 25 local players competing for points, which accumulated towards an overall ladder. The top 4 players in the ladder qualified for the 'Bolt to Brisbane' event in QLD.





## 2022 National Indigenous Tennis Carnival

The National Indigenous Tennis Carnival returned as a national event in August 2022. Over 150 young Indigenous Australians travelled to Darwin to participate in a celebration of culture through tennis.

Participants travelled from across the NT, from communities such as Arlparra, Canteen Creek, Lajamanu, Jabiru, Tiwi, and Alice Springs and from across Australia, with all other states and territories being represented.

The 2022 NITC provided participants with an opportunity to develop their skills, with ball kid sessions delivered by Tennis Australia staff. The top performers were invited to the 2023 Australian Open as ball kids. NT player *Dylan Archer* from Palmerston was selected and attended as the sole NT representative.

The 2022 NITC also saw Deadly Awards being awarded to two young Indigenous Territorians. The winners from the Tiwi Islands and Canteen Creek were invited to travel to Melbourne and participate in *First Nations Day* at the 2023 Australian Open.

Following on from the success of the NITC, in 2023 all states and territories around Australia will be delivering lead-in events in their own environments which will further grow the profile of First Nations tennis and form an important part of the pathway for players earning selection to attend the National Indigenous Tennis Carnival in Darwin.



#### Tournaments



#### ITF WORLD TENNIS TOUR - AUSTRALIAN PRO TOUR. SEPTEMBER 2022

The Australian Pro Tour returned to Darwin in 2022 with back-to-back \$25,000 Men's and \$25,000 Women's events being held at the Darwin International Tennis Centre in September 2022.

The events brought over 100 players, coaches, supporters, and officials to Darwin and provided a great opportunity to showcase professional tennis to the Darwin public.

#### **ITF WORLD TENNIS TOUR JUNIORS. JUNE 2023**

The Darwin Junior International and NT Junior Internationals saw a decrease of 25 and 19 players respectively, however a greater proportion of players competing in 2023 were traveling compared to 2022.

Note regarding the upcoming FY2023-2024 calendar, the 2024 Darwin Open has been moved to occur prior to the 2024 ITF Junior events to provide players with an additional high tier competitive opportunity in the same swing of events.

#### **& SENIORS NRT – events across FY22-23**

The Australian Junior series and Australian Progress series arose from feedback obtained throughout 2022

following the National Competitive Play Review. These series combine ratings-based play with a year-long opportunity to qualify for National Masters events, which are played during December in Melbourne.

Australian Junior series and Progress series events held from the beginning of 2023 generally saw increased participation in comparison to their 2022 counterparts.

The Katherine Open had the highest participation of all events held throughout FY22-23 with 104 total participants across all events.

The NT Open followed the 2023 ITF Junior events and saw several players stay on to participate. The Darwin Open would follow later in 2023 as a lead into the Darwin and NT Internationals.

Thank you to all the players, officials and tournament staff who helped to make the 2022 – 2023 period a success.

Note regarding the upcoming FY2023-2024 calendar: the NT Open and Darwin Open will switch places in the calendar for 2024, placing the move prestigious 97<sup>th</sup> edition of the NT Open leading into the Darwin and NT Internationals.

Overall, FY22-23 saw an additional 313 entries compared to FY21-22, which was largely due to the additional events delivered compared to the previous 12-month period.

In December 2022 NT official and Katherine Tennis Club President, Greg Dickson, held an officiating information and Q&A session at the Darwin International Tennis Centre. Interested participants were invited to begin their officiating journey as court monitors in 2023.


In April 2023, six NT locals completed their training as Court Monitors and then received practical on-court experience with NT referee's Jenny Roe and Leanne Usher. The same six new officials then completed a line umpire training session with NT Chair Umpires Greg Dixon and Tarun Soni.

These new officials continued their development in May and June 2023 when they officiated practice matches between players in town for the 2023 ITF World Tennis Tour Junior events. The officials would continue their development in 2023 at several other local events, with the goal of working at the 2023 ITF World Tennis Tour (Pro Tour) events in September 2023.

### Pathways NDS & Zone Squads



#### **NDS and Zone Squads & updates**

NDS and Zone Squads continued to be structured around themes of professionalism, intensity, and culture. Players set new goals each Term, in collaboration with their private coach. These goals were set in line with player reporting areas: technical, tactical, physical, and psychological.

In Term 3, 2023, Alistair Murphy (Senior Physical Performance Coach, National Tennis Academy, Brisbane) visited Darwin to run NDS players through a range of physical testing.

Each player received an individual strength and conditioning program to complete in their own time. NDS players combined with the Zone Squad players for a sports psychology session with Liz Grylls; the session was centred around handling pressure and enjoying competition.

The Zone Squad experienced a second psychology session on-court, with Liz being present to take players through routines during point play.

Multiple camps were held in conjunction with local Pro Tour and ITF events, to provide an opportunity for players to be immersed in the atmosphere of elite tennis.

During the Pro Tour events in 2022, Zone
Squad and NDS players came together for an on-court training session, an agility session with Ash Barty's previous S&C coach,
Matthew Hayes, and a college information session with Michael Shepherd, a prior local junior tennis player. Zone Squad players were invited to watch the NDS players competing in the 2022 ITFs, completing analysis worksheets to direct their attention to specific aspects of the game.

#### **Super 10s (local event and National Camp)**

#### **Local seasons**

Twenty-eight players attended Darwin International Tennis Centre for the **Season Two, 2022** Super 10s trial day, for an afternoon of on-court training and competition. From here, 16 players were selected (9 boys & 7 girls) and placed into four teams to compete across the following two weekends, with a focus on footwork and intensity, sportsmanship and giving 100%.

Season One, 2023 Super 10s trial day welcomed 23 players for the trial day, with the four teams being comprised of 13 boys and 3 girls. Thank you to all coaches who managed teams across the seasons; it wouldn't be possible without your support and it's great for the players to have the opportunity to seek advice on court in a team environment.

#### **National Super 10s Camp 2023**

The Northern Territory had 6 players representing the Territory in Melbourne during the Super 10s National Camp, with 64 players in attendance from around Australia. This is a great opportunity for players to be immersed in the world of professional tennis, being inspired by their surroundings and being able to set new heights following competition against strong teams from interstate.

Caitlyn, Taylor, Layla, Hunter, Sam, and Alex went to Melbourne for the experience, competing in teams with players from different states and territories. They were lucky enough to have the opportunity to watch Australian Open matches on Rod Laver arena courtside and meet professional tennis players. Taylor and Alex even got to do a coin toss on Rod laver arena!



#### Coach Development



#### **Coach Development**

Coach development continued to run informally in the local environment, between the Talent Operations Manager and local coaches. Regular phone calls, meetings and club visits occurred, with coach development sessions delivered on requested topics. Player reports were provided to coaches for players in NDS, Zone Squad and Super 10s, identifying opportunities technically, tactically, physically, and emotionally. The Talent Operations Manager has been actively involved in squads at multiple local Clubs to proactively collaborate with local coaches. Providing opportunities to travel as a coach / manager also enabled local coaches to 'know the level' interstate. During the ITF's, a coach development psychology session was delivered by Liz Grylls and Nicole Kriz.

#### **Coaching Courses**

Five local participants graduated from their Junior Development Coaching Course in Darwin, under the guidance of Tennis Australia facilitator Sam Bradshaw. This is exciting for the local coaching environment, broadening the network of coaches and establishing a coaching pathway. The aim is to deliver multiple Community Coaching Courses across the Northern Territory in the next 12 months and to also provide another Junior Development Course opportunity locally.
