PRESIDENT'S REPORT





n behalf of the Board of Tennis Queensland, it gives me great pleasure to present the President's Report for 2016/17.

After an extensive consultation process with a wide cross section of the tennis community, our Board of Directors approved our new Strategic Plan for 2017-2020. The process of reflection, review and consultation resulted in the formulation of our key strategic objectives across the three key pillars of People, Places and Products. This plan will guide the future direction of our organisation and ensure our limited resources are used to deliver the best possible outcomes for our affiliates.

In September last year, long serving CEO Mr Cameron Pearson stepped down to pursue new opportunities with the Tennis Australia events team. Cameron leaves a lasting legacy and many friends across our state, however he will be best remembered for how he and his team developed the Brisbane International into a world-class sporting event. On behalf of board and management I thank Cameron for his dedication, professionalism and passion towards servicing the needs of Tennis in Queensland and we wish him all the best in the future. New CEO of Tennis Queensland Mr Geoff Quinlan was appointed in September 2017. Geoff was formerly the CEO of Tennis West, and brings with him vast experience in running a state sporting organisation as well as former Australian Open series event, the Hopman Cup. In the short time Geoff has been with us he has made improvements across a number of areas in the organisation and continues to drive and grow the Brisbane International in his joint role as Tennis Queensland CEO and Brisbane International Tournament Director.

During the year our board also saw the retirement of Mr Ross Rolfe. Ross is a life member of Tennis Queensland and has provided our board with more than 10 years of dedicated service. On behalf of the organisation, we thank him for his considerable contribution to the sport over the years. Ross was succeeded by Mr Michael James who was elected at our Annual General Meeting in October. Board Members, Regional Company Members and Judiciary Members play an important part in the governance of our organisation; providing their time and expertise on a totally voluntary basis. On behalf of the tennis community I thank them for their ongoing contribution.

I would also like to acknowledge the ongoing assistance Tennis Queensland receives from Tennis Australia, in particular Tennis Australia Acting President Mr Chris Freeman and CEO Mr Craig Tiley. Both work tirelessly at the highest level of our sport, and have made significant changes which benefit Queensland in the areas of the Emirates Australian Open Series, player development and various participation initiatives.

Financially Tennis Qld has performed well with a surplus of \$229,193 and reserves of \$4,480,585 at balance date. We are in a very sound financial position and we continue to maintain a conservative financial position as we balance the immediate priorities of the organisation against the future needs and requirements of the sport. The Tennis Queensland team have worked within tight budgetary constraints and delivered a high quality professional service to our stakeholders.

Reserves have surpassed \$4 million and our board has approved a Capital Management Plan that will provide our executive with guidance on how these funds should be invested in the sport moving forward. Tennis across Queensland has many competing needs for investment, and it is important this process is managed to ensure the best outcome for all.

Financial viability and sustainability of our affiliates is a prime focus for Tennis Queensland. Our strategy to assist club engagement within communities, and develop new and exciting programs that retain existing and attract new members is working. Registered player and ANZ Tennis Hot Shot numbers continue to grow and we are committed to ensuring a healthy uptake of players continues. Tennis Queensland is developing greater resources that will help clubs access and leverage the tools we have available. Additionally, our Participation Leaders, School and Leagues Coordinators are available to assist and support where necessary.

Our team also has a strategic focus on improving relationships with all levels of government. Last year we embarked on developing a State Facility Plan as well as individual plans with 11 local councils. Part of the plan saw the team conduct an industry first audit of every facility across Queensland to determine their immediate and future capital needs. Our team also used population data to determine areas that require servicing with new or upgraded facilities. These plans are assisting the development of long term strategies with government to enable targeted and increased levels of funding for Tennis.

In April, Brisbane hosted the Davis Cup tie between Australia and the USA with Australia defeating the USA 3:2. The event provided an excellent opportunity to promote our sport and engage with the community, government and sponsors over three days of electric tennis. The Tennis Queensland team performed exceptionally well in the delivery of the event and seizing the opportunity to showcase our sport.

The Brisbane International continued the success from previous years and saw Rafael Nadal visit Brisbane for

the first time. Attendance figures continue to be in the realm of 100,000, with a worldwide television audience. We thank the major sponsors, the Queensland Government and Brisbane City Council, for their support of this event. Tennis Queensland continues to work closely with the Brisbane International team to incorporate activities involving our registered players and affiliates, including the Queensland Money Race Finals, Brisbane International Schools Challenge, Queensland Coaches Forum, National Schools Partnership Program Teachers Workshop, Club Master Class and the President's Morning Tea.

During the Brisbane International we welcomed Mr Milton Rothman as a life member of Tennis Qld. Milton has contributed over his lifetime to our sport as a player, coach, administrator and volunteer and he was congratulated during an on-court ceremony during the Brisbane International by his past student John Millman.

Looking forward Tennis Queensland will continue to deliver on its strategic plan and continue making tennis Queensland's most engaging sport. I sincerely thank everyone associated with tennis in the state and look forward to continually giving my upmost to improve our sport in this great state.

t is with pleasure that I provide this CEO report, my first for Tennis Queensland, for the year through to 30 June 2017.

In the past 12 months we developed an ambitious Strategic Plan to take us through to 2020 to make tennis Queensland's most engaging sport. Our vision is to create a sport that delivers tennis experiences that engage all Queenslanders from ANZ Tennis Hot Shots kids starting their tennis journey, fans at the Brisbane International, performance players in our National Academy through to our thriving tennis senior's competitors.

I'd like to take this opportunity to thank the members, players, administrators and coaches who have contributed their voice to the 2020 Strategic Plan throughout it's development. We look to deliver this with all our partners, sponsors, government and volunteers, without whom, we couldn't deliver the sport. I encourage you to read through the Tennis Queensland Strategic Plan through to 2020 and consider how your club and organisation may best align to the priorities within. As we come to the end of the cycle of the Tennis Queensland Strategic Plan 2014-2017 we report against themes of Community, Places to Play and Champions:

COMMUNITY: Make tennis the most engaging and inclusive sporting community in Queensland

Over the three-year Strategic Plan, Queensland club membership has increased overall with 45,349 club members at the end of the 2016-2017 financial year.

The ANZ Tennis Hot Shots program continued to attract more kids to tennis, this result is truly meritorious as the options for kids today makes this area of our business very competitive. As part of our strategy to increase participation by focusing on schools, two School Development Coordinators were appointed to drive this strategy. Currently 443 Queensland primary schools have signed up to deliver ANZ Tennis Hot Shots through the Partnership program and a further 74 primary schools have signed up to deliver the Play program; In the 2016-2017 year alone registrations grew by 64% for the Partnership program and 117% for the Play program, exceeding a total of 69,000 Queensland school students participating in ANZ Tennis Hot Shots throughout the year.

Social media followers have increased well above expectation and digital channels continue to be the preferred method of engagement between the governing body and our players and deliverers. Throughout the year we have embarked on major projects to ensure our digital platforms are meeting the needs of the tennis comunity.

The Rally Kit was launched in November as an online resource to guide clubs through the development and implementation of tennis competitions and leagues. Critical feedback in the development of the 2020 Strategic Plan led to the objective of expanding the Rally Kit into a comprehensive club tool including all relevant areas for club health and participation growth that will be delivered in early 2018.

PLACES TO PLAY: More welcoming and sustainable places to play

The largest and only facility review of affiliated bodies

across the state was completed from February to April 2017. Tennis Queensland with the support of Tennis Australia's Places to Play team and our affiliates reviewed over 250 facilities and 1,500 courts.

Although the results are daunting, we now have a comprehensive view of the tennis infrastructure in Queensland. In summary Tennis Queensland has an \$80 million problem with the condition of our existing infrastructure. We also require \$54 million in investment to develop a number of Greenfield sites that primarily address our shortfall of courts in South East Queensland (SEQ). These greenfield site projects will be identified via the planning process, particularly within the 11 nominated priority LGA's.

It is well known that SEQ, in particular Brisbane has a severe shortage of tennis courts. At present we are approximately 400 courts behind the capital city average. Our analysis of the industry suggests that more than half (80) of the privately owned courts in Brisbane (140) are at risk, nearly one in five of the total number of courts in greater Brisbane. These factors along with an escalating population growth will put us further behind the demand for courts in SEQ. Complete strategic plans for facility investment, infrastructure needs and participation priorities based on the findings have been completed with priority LGA's. Completion of the Queensland Tennis Facilities Plan – 2028 will be critical to addressing the challenges of tennis infrastructure in Queensland.

We were able to surpass the target of 85 new courts built around Queensland for the 2014-17 Strategic Plan period.

The Book a Court online court booking initiative has five venues up and running and a further 10 systems in implementation phase. This initiative is genuine innovation in our sport, the first five pilot installations (all located within SEQ) are:

- / Redcliffe Tennis Association
- / Redland Bay Tennis Club
- / Kangaroo Point Health and Fitness
- / Sandgate District Youth Tennis Association
- / Burleigh Heads Tennis Club

CHAMPIONS: Foster and celebrate more champions for tennis than ever before

Queensland has consistently exceeded targets in the performance area, with 35% of national scholarship holders coming from Queensland and even more national athletes choosing to train and develop in Queensland due to the quality of the facilities and team available. As well as the training environments, Queensland continues to host the country's largest and most successful tournaments such as the Rod Laver Junior Championships and the Toowoomba Pro Tour - both of which have been presented national awards during the Strategic Plan period.

OUR PINNACLE EVENTS

A crowd of 96,107 fans poured through the gates of Queensland Tennis Centre to enjoy eight days of superb on-court action and off-court entertainment at Brisbane International 2017 presented by Suncorp. Four night sessions achieved record attendance, a coup for the growing popularity of this great event.

Grigor Dimitrov (BUL) and Karolina Pliskova (CZE) were crowned the men's and women's singles champions. Australian duo Thanasi Kokkinakis (SA) and Jordan Thompson (NSW) won the men's doubles title in their first tournament as a pairing whilst top seeds Bethanie Mattek-Sands (USA) and Sania Mirza (IND) were victorious in the women's doubles draw. The strongest field ever competed with five of the top ten men and five top ten women: Rafael Nadal, Stan Wawrinka, Milos Raonic, Kei Nishikori, Dominic Thiem, Angelique Kerber, Karolina Pliskova, Dominika Cibulkova, Garbine Muguruza and Svetlana Kuznetsova.

Following the Brisbane International in April we hosted a successful Davis Cup tie whereby Australia defeated the United States of America to advance to the semifinals of the World Group. The hugely successful tie was hosted at the Queensland Tennis Centre where over 16,400 fans created an exhilarating atmosphere at Pat Rafter Arena. We were able to host a significant number of stakeholders, deliver many activations and the feedback was overwhelmingly positive.

THANKS

Tennis Australia continue to provide shared services, including but not limited to: finance, legal, human resources, IT, marketing and media. Without this support we could not operate. I'd like to thank CEO Mr Craig Tiley for the ongoing support of Tennis Queensland and for his leadership in bringing Tennis Australia and the other Member Associations closer together to achieve our shared vision for tennis in Australia.

To the Board of Tennis Queensland, who are all volunteers and work tirelessly for the sport, thank you for your leadership and governance of our sport, we are in safe hands.

I'd like to acknowledge the work of Tennis Queensland President Mr Mark Bloomfield for his leadership, hard work, integrity, support and encouragement he has provided me and the Tennis Queensland team. Speaking of the Tennis team, and for clarity this includes the Tennis Queensland, Tennis Australia and Brisbane International teams that work out of Queensland Tennis Centre and within the regions as ONE TEAM, you would not meet a harder working, more dedicated or focused team in any sport. I'd like to recognize their work throughout the year and thank them for all the work, long hours and weekends they give willingly to tennis. Just over twelve months into my role as CEO of Tennis Queensland and Tournament Director of the Brisbane International and I am privileged to lead such a cohesive team.

Finally, I'd like to thank the tennis community in Queensland who have made me feel so welcome at every club I've visited and every tournament and competition I've attended. I know I've still got many clubs to visit, I truly look forward to getting around to as many as I possibly can, as soon as I can.

ennis is and always will be the sport for everyone. If you can pick up a racquet, it does not matter your race, gender, ability, age or sexual orientation, tennis will welcome you with open arms. Our sport has long been displaying the values of equality, inclusion and diversity.

We believe our sport, and indeed sport in general, is a very powerful vehicle for social change in this world. Earlier this year I had the privilege of addressing the 2017 Women's Empowerment Principles Forum at the United Nations in New York in a bid to further promote gender equality in sport and across all business sectors.

We have a lot to be proud of in Australian tennis, nonetheless, there is still more that can be done and we are determined to continue our pledge to influence real change.

This year has seen a renewed focus on the positive role that tennis plays in the community and no event highlighted this more than the 2016 Newcombe Medal and the Australian Tennis Awards. The night showcased community stories from around Australia and culminated with Dylan Alcott (VIC) being awarded the highest honour in Australian tennis. Queensland's Kimberley Birrell was awarded Junior Athlete of the Year on the night. Introducing the game

ANZ Tennis Hot Shots introduced record numbers of children to the game this year with 384,584 taking part in the program nationally – up 80 percent on 2015-16. Queensland alone managed a 94 percent increase of registered ANZ Tennis Hot Shots participants with 84,104 playing in 2016-17.

The Schools Partnership Program stimulated a lot of the growth which led to ANZ Tennis Hot Shots being recognised as the number one delivered Australian Sports Commission Sporting Schools Program in Australia. There are currently more than 2,000 schools nationwide, 459 in Queensland, participating in the School Partnership Program as part of their health and physical education curriculum.

Another highlight of this past year was former Grand Slam champions Todd Woodbridge and Alicia Molik leading an ANZ Tennis Hot Shots Racquet Roadshow during April to May 2017 to celebrate the delivery of 80,000 racquets to first year primary school students. They visited more than 35 schools, travelling more than 10,000 kilometres to meet 15,000 kids and drive awareness of the initiative and the Schools Partnership Program.

The competitive arm of the program, previously known as leagues, was revamped into ANZ Tennis Hot Shots Match Play this year. There are now more than 15,000 children taking part at 380 venues nationwide, with 432 schools registering to deliver it in the past 18 months. Queensland currently has 74 schools involved.

Daria Gavrilova and Thanasi Kokkinakis signed on as ANZ Tennis Hot Shots Match Play Ambassadors to help inspire the next generation of champions.

Opening up tennis

The Book a Court program continues to open up tennis across Australia by allowing casual players to book and pay for courts online. Book a Court was first piloted in 2015-16 and has been installed in 56 venues nationwide. This year there have been 37,834 bookings from 7,255 unique players generating \$249,029 in online payments unlocking new revenue streams for all clubs involved.

During this pilot phase of the program much focus has gone into identifying best practices to ensure a smooth roll-out over the coming years.

Inspiring others

We continue to grow the game and engage more fans through the promotion of our leading athletes.

The Australian Pro Tour is a great example of how we provide a platform to bring elite tennis to more towns and communities countrywide. Running from September to April and attracting strong fields, the series offers more than USD \$1.1 million in prize money and 15,000 valuable ranking points as added incentive. Queensland star Lizette Cabrera earned herself an Australian Open wildcard for her efforts in Pro Tour events.

The annual December Showdown tournament at Melbourne Park featured the most promising junior talents competing for national titles across 16 days and saw Queensland's Olivia Gadecki take out the 14/u girls' title and the boys from Queensland winning the 14/u team event.

Australia's John Peers and Henri Kontinen (FIN) claimed their maiden Grand Slam doubles title at Australian Open 2017 while Dylan Alcott won the quad wheelchair singles title for the third consecutive year in front of a huge crowd on Rod Laver Arena, the first time a wheelchair final was played on centre court at any Grand Slam. Rising superstar Daria Gavrilova won her way to the fourth round, the best performance of all main draw Australians.

Grand Slams to grassroots

The growth of our world class events continues to allow us to generate revenue to reinvest back into the sport.

A growing crowd of fans poured through the gates of Queensland Tennis Centre once again to enjoy a historic week of tennis at Brisbane International 2017 presented by Suncorp, where Grigor Dimitrov (BUL) and Karolina Pliskova (CZE) were crowned the men's and women's singles champions.

Thrillingly, for two of Australia's most exciting young stars Thanasi Kokkinakis (SA) and Jordan Thompson (NSW) beat Gilles Muller (LUX) and Sam Querrey (USA) to take out the men's doubles title in their first tournament as a pairing.

In the pursuit of becoming the world's greatest sports entertainment event, this year we increased our overall Australian Open entertainment, food, and tennis offerings and it paid dividends. A record 728,763 fans visited Melbourne Park during Australian Open 2017, smashing the previous record of 720,363 set in 2016. For the first time there were 503,382 attendees in the tournament's first week, breaking the half million barrier. While on the court, in arguably the most anticipated men's singles final in tournament history, Roger Federer won an unprecedented 18th Grand Slam title, overcoming nemesis Rafael Nadal in a five-set thriller. The 35-year-old Swiss maestro returned from a sixmonth injury lay-off to become the second oldest Grand Slam champion in the Open era, a victory that thrilled his many fans. It followed a historic women's final showdown between American sisters Venus and Serena Williams.

Serena took the spoils, claiming a 23rd Grand Slam title to become the most prolific Open era champion. News the 35-year-old was pregnant with her first child emerged several months later, making the achievement even more remarkable.

Investing into growth

The success of our events has allowed us to reinvest back into the sport and this year there has been 176 projects funded through the National Court Rebate Program. The total project value exceeded \$34 million and resulted in 342 new or resurfaced courts, including 155 ANZ Tennis Hot Shots mini-courts.

More than \$100,000 was distributed as part of the second round of AO Community Grants program in 2017. More than 30 recipients will use these grants to undertake projects that will deliver tennis opportunities to deserving communities in inclusive and engaging ways. This demonstrates how tennis can have a positive impact on local communities and be used as a vehicle to connect and engage individuals who face barriers to participation.

Our vision for the future

Much work has taken place behind the scenes as we work together across the nation bringing to life our strategic plan to make tennis the activity of choice in Australia.

As we continually push to connect more people to tennis, the next few years are particularly exciting for our sport. We believe that by continuing to deliver world-class entertainment with tennis at the core, we can drive revenue to reinvest back into growing the sport.

Our great partnership with Tennis Queensland has continued under the new leadership of CEO Mr Geoff Quinlan who took over from Cameron Pearson in the latter half of 2016. We'd like to thank Cameron for his dedication to tennis in Queensland and we look forward to working with all of you to achieve our shared vision.

ANZ TENNIS HOT SHOTS

The ANZ Tennis Hot Shots (ANZTHS) program introduces primary school aged children to tennis using modified rules and equipment tailored to their age and ability. A staple in open days, primary schools and club activations across the state, ANZTHS is an engaging entry point into the sport for kids 12 and under.

Registrations for ANZTHS grew almost exponentially with 85.022 recognised participants in the program. The significant growth can be attributed to the survey results of our Primary School Partners who have provided anecdotal participation numbers in the curriculum.

The foundation for the growth of the program has been in parallel to the accelerated growth within our delivery network. Currently there are 747 deliverers of the program that are made up of coaches, community play partners and school partners. The Sporting Schools program has been particularly successful with a further 109 schools partnering with tennis in Queensland, bringing the end of financial year total to 459.

Hot Shots Match Play

With ANZTHS now firmly established as a successful entry point to tennis, there's a renewed focus on encouraging kids to transition from a learning environment to competitive play, bringing about Tennis Australia's new initiative, Match Play.

A growing number of clubs and coaches are running ANZTHS Match Play at their centres; a flexible program that offers a valuable first team and competitive experience, without requiring commitment to an entire season. Match Play helps build the foundation for future stars and Grand Slam winners, as well as social players who can enjoy a life-long relationship with tennis.

Hot Shots Highlights

- / 11 clubs and 70 players participated in ANZTHS demonstrations on Pat Rafter Arena during Brisbane International 2017, presented by Suncorp.
 / Inaugural editions of inter-club ANZTHS leagues at Tennis Brisbane and Logan Tennis City with teams from six clubs respectively representing their centres to play against different players in a new competitive format.
- / 70 venues across the state offered ANZTHS Match Play opportunities to players transitioning them from learning the game to playing matches.
- / 54 Free Tennis Days hosted by affiliated tennis clubs featured ANZTHS

SOCIAL PLAY

Following on from the success of "Opening Up Tennis" in Victoria, Tennis Australia and Tennis Queensland began installing pilot Book a Court pinpad technology systems across five venues in the greater Brisbane and Gold Coast metropolitan areas. The Book a Court initiative is designed for the social player, offering an easy way to access their local courts through an online booking system.

Tennis Queensland successfully secured grant funding from the State Government and National Court Rebate Scheme to install a further 10 systems across the state. These installations are underway and should be completed by October 2018.

Tennis Queensland is in the process of applying for another grant in 2017-18 to install a further 15 pinpad technology systems across Queensland. If the grant opportunity is successful, it is anticipated the installations would be completed during 2018. Once there's a wider footprint of centres connected to the system, we can begin a widespread marketing campaign that promotes and encourages social tennis through the Book a Court venues.

Book a Court will provide better access to otherwise inaccessible (i.e. locked up) tennis facilities via an online court booking system that links to gate access and court lighting.

Once venues have had the opportunity to trial this innovative new technology and demonstrate its value, we will look to provide additional information, funding partnership and assistance opportunities for other clubs interesting in taking on the exciting new initiative.

COACHES


In Queensland, 468 registered Tennis Australia Coach Members continue to drive participation and performance across the state.

Over the past 12 months 60 workshops have been delivered to 821 coaches who attended professional development and networking opportunities throughout Queensland - the highest numbers nationally.





OFFICIALS

There were six Court Supervisor Courses in the 2016-17 period held to upskill new officials, with 13 new Court Supervisors accredited. Nine new Line Umpires were also accredited and several more are working towards accreditation. There is also one new accredited Level B referee.

Dalby, in the South Region, held a Court Supervisor Course with seven participants and all achieved accreditation. They are now completing their membership registration.

Tennis Australia has continued to provide more streamlined services and support to all officials, with Tennis Australia's officiating website giving access to policies, resources and officiating news.

It was a successful year for Rob Leak, who won the Queensland Tennis Awards Most Outstanding Official, along the Sporting Wheelies and Disability Official of the Year for his officiating at Rio Para Olympics 2016. Leak was also named a finalist for the Most Outstanding Official at the Australian Tennis Awards.

Meanwhile the 2017 Australian Open saw one of our respected ITF badge referee, Les Killer, announce his retirement as an AO Wheelchair Referee, a role which he has performed over many years at the elite, international level. Killer has had a significant contribution to officiating in our sport and will remain a mentor locally.

SPORTING SCHOOLS

Sporting Schools is an Australian Government initiative designed to help schools increase their children's participation in sport and to connect them with community sporting opportunities. Tennis Australia offers two programs as part of Sporting Schools for Primary Schools - the Partnership and Play programs. Both Sporting Schools tennis programs complement the already existing ANZTHS program.

Currently, 443 Queensland primary schools have signed up to deliver ANZTHS through the Partnership program as part of the school's curriculum. A further 74 primary schools have signed up to deliver the Play program; driving a focus on school competitions and match play. In 2016-17 registrations grew by 64% for the Partnership program and 117% for the Play program, exceeding a total of 69,000 Queensland school students participating in ANZTHS throughout the year.

PROFESSIONAL DEVELOPMENT

Teachers

During 2016-17, 18 ANZTHS in Schools Professional Development sessions were run across all regions of Queensland for 178 teachers. Five workshops were also conducted about the INtennisCITY technology platform and running intra-school competitions.

Coaches

A total of 62 coaches attended Tennis in Schools information workshops during 2016-17. Sessions focused on the updated Tennis in Schools curriculum resource, school program options for coaches and the updated guidelines for the Brisbane International Schools Challenge Red Ball competition.

PILOT PROJECT - SCHOOLS


A partnership between Tennis Australia, the Australian Sports Commission and Education Queensland lead to a pilot project in South West and North West Queensland to collect data on participation barriers in regional Queensland. The project's main priorty is to rejuvinate participation in regions where there isn't an established club or access to coaching. Equipment and professional development was provided to 48 interested schools, with participants completing pre and post project surveys to indicate whether the equipment and professional development assisted in removing barriers.

School Highlights

- / More than 50 teachers from partnered schools across Queensland attended the Teachers' Appreciation Breakfast during Brisbane International 2017, presented by Suncorp.
- / Inaugural School Education Program implemented by Tennis Queensland in partnership with the Turkish Embassy, Youth of Tomorrow and Mates 4 Mates. Four schools with a total of 200 students participated in the event which linked the commemoration of ANZAC Day with tennisbased activities and a showcase of the National Academy.
- / 9,281 Prep racquets donated to 164 schools with former Australian doubles Grand Slam champion and Davis Cup representative Todd Woodbridge. hand delivering racquets to prep students at Coomera Rivers State School, Mount Cotton State School, Calamvale Special School, Cannon Hill Anglican College, St. Joseph's Catholic Primary School (Biloela) and Gladstone West State School.
- / 120 students from 8 schools across Brisbane participated in the annual Inclusive Gala Day run by Tennis Queensland and Lifestream.
 This event led to an increase in Special School partner registrations from one to eight, with 50% completing repeat programs.

THE RALLY KIT

The Rally Kit was created in late 2016 as an online tool to assist clubs in creating or reinvigorating their established leagues. Its aim is to enable clubs to take a step back and evaluate their surroundings and available demograpghics before providing a step by step guide on how a league could be implemented to target these groups.

In essence, the Rally Kit is an online tool that has everything you need to reinvigorate your club. It can be used to create a new league specific to your club's needs, or enhance an already established league. The Rally Kit aims to guide your club through tried and tested formats to attract new members and increase participation.

The Rally Kit is now in an expansion stage to begin encompassing all aspects of club life within the site. It will become a one-stop-shop for affiliates to house and find information about tournaments, inclusion, business operations, grants, funding and much more in an interactive and engaging way.

LEAGUE MANAGER & MATCH CENTRE


A number of Queensland tennis clubs have started using the free national competition software League Manager. The software provides an easy way to administer competitions and publish draws, results and ladders online for all players to access.


The system provides a nationwide platform and aims to centralise all team tennis competition results from around the country. All state-wide competitions like the Brisbane International Schools Challenge, the Queensland Secondary Schools Team Tennis Competition or premier leagues such as the Brisbane, Sunshine Coast, Gold Coast and North Tennis League are also covered on the website.

New features like a National Player Rating have recently been introduced to assist with grading teams and further reducing administration burden for club volunteers.

BUILDING PLACES TO PLAY

During 2016-17, Tennis has placed a strong emphasis on the need to develop new tennis facilities in areas of identified need. This need is based on the ratio of publically accessible courts for the area and how far above the "target ratio" these regions are.

Queensland areas where the need is greatest include the greater Brisbane metropolitan region, and the rapidly growing corridors between Brisbane, the Gold Coast, Sunshine Coast and Ipswich. New facilities have become a focus when talking with all levels of government in these locations. However, all levels of government are also looking for additional evidence beyond the traditional population-tocourts ratio to justify the development of new facilities. Further details of how this is being addressed has been provided in the Queensland Facilities Development Strategy to 2028 section of this report.

Securing funding for new facilities and significant upgrading of existing centres is challenging for the sport, as the amount of grant opportunities has remained fairly static in recent years. There is also a need to ensure our existing facilities are properly maintained so they remain welcoming and attractive to new and existing players. Therefore, our ability to create new facilities for the growing population of Queensland is heavily reliant on the support of Local and State Governments.

For the ongoing maintenance of our facilities, we strive for our affiliates to be financial viable and sustainable to avoid reliance on grant funding. The success of some of our larger and busier facilities are great case studies of this, with Tennis and Government stakeholders using these examples to create successful practices at all new facilities moving forward.

NEW FACILITIES AND UPGRADES

This year saw 36 new courts constructed against a target of 35 as well as 275 courts upgraded. The total investment into these projects was approximately \$11.6 million. Some of the more significant new and upgraded tennis facility projects completed this year are listed in the following table.

PLACES TO PLAY



COURT TECH

Court Tech is a registered business within Tennis Qld that offers a wide range of development advisory and professional consultancy services. This can range from answering simple questions such as clarifying court dimensions and surfacing options through to more technical matters such as lighting design and base construction specifications.

Ten of the major projects listed in the previous table utilised Court Tech project management services. Design review services were also used for the development of the new major tennis facility in Darwin.

Consultancy fee proposals for other potential projects were provided in 2016-17 in conjunction with the State Government and the Gambling Community Benefit Fund grant programs. A number of these projects have successfully obtained the required funding to allow them to proceed to the tender award and construction phases. It is anticipated that some of the projects that were unsuccessful in securing grants in 2016-17 will reapply for funding in the next rounds of State Government and other grant funding programs in 2017-18.

HEALTHY FACILITY PRACTICES

The Places to Play (P2P) team has refined and developed additional tools and resources to ensure Club Operational Health Checks (OHC's), Operational Reviews and Participation Reviews are efficient and beneficial for affiliates. Where requested, the team met with affiliates to review their existing range of tennis programs and overall court utilisation, as well as their business arrangements and practices to identify where improvements could be made or additional services and products offered to enhance business.

During 2016-17 a total of 126 OHC's were completed by affiliates exceeding last year's total of 95, and achieving the target set for this year. These checks allowed Tennis Qld affiliates to benchmark themselves against other clubs and identify areas of their operation that were performing well or required improvement. The data from these checks will also be incorporated into Local Government Strategic Plans for tennis currently being developed with our highest priority Local Government Areas/ Authorities (LGA's).

Sporting clubs with leases have become more accountable for facility maintenance as funding provided by LGA's typically decreases or remains the same. Several LGA's have implemented reasonably detailed audit and review processes for facilities when leases are due for renewal. These audits include reviews of their governance procedures, business, marketing and communications plans, as well as risk management and Workplace Health & Safety policies. The results are taken into consideration when developing new leases with these clubs and the length of the tenure being offered. The P2P team provided assistance to a number of clubs going through this process with pre-audit and policy development preparation.

GOVERNMENT RELATIONS

Tennis Qld is now engaging directly with local governments across the state to help shape the delivery and growth of tennis in our communities. A Local Government Advisory Group has been formed with stakeholders from a selection of LGA's across a variety of departments including Sport and Recreation, asset maintenance and facility development. The group features advisors from a range of adminstrative levels including directors, managers and office staff. The aim is to gain feedback, input and advice from a variety of perspectives that will help shape tennis in Queensland from a local government perspective.

SHAPING SOUTH EAST QUEENSLAND (SHAPING SEQ)

The ShapingSEQ initiative was developed by the Queensland Government as a blueprint for developing sport and recreation opportunties across Queensland into the future. ShapingSEQ anticipates the region's population to grow by 2 million people by 2041, and more than double from 3.4 million over the next fifty years. This demands meticulous and collaborative planning by governments, businesses and organisations to ensure that quality of life for all community members is both preserved and enhanced. Tennis Qld made a submission to ShapingSEQ to ensure the needs and demands of Tennis will be met now and into the future for all Queensland communities.

TENNIS QLD FACILITIES DEVELOPMENT STRATEGY TO 2028

In August 2016, Tennis Qld commenced the process of developing a new Facilities Development Strategy (FDS) through to 2028. The purpose of the FDS is to implement strategic objectives to address the issues of tennis facility provision across Queensland as well as guiding direction for LGA's, State Government's Sport and Recreation Department (SRD) and Tennis Qld stakeholders. The FDS is scheduled for release in March 2018. TENNIS QUEENSLAND ANNUAL REPORT 2016/17

QUEENSLAND FACILITY REVIEW

In March 2017, Tennis Qld announced the launch of a Tennis Facility Review initiative to inform the FDS. All affiliated tennis venues in Queensland were visited by Participation Leaders and Places to Play staff who collected information on the facility and its infrastructure. The collection of this data generated a complete understanding of the current tennis facility provision, condition and need for renewal and/or redevelopment.

The project has provided vital information to consolidate, renew and gain important partnerships and financial support from all levels of government by accurately charting a course for future facility needs. The review has identified tennis facilities in all regions where significant tennis investment is required in the immediate future (within the next three years). This investment will allow Tennis to continue to deliver a range of social, community and health outcomes, while accommodating the statewide population growth.

LGA STRATEGIC PLANS FOR TENNIS

Individualised LGA Strategic Plans are being created based on the FDS to assist local councils with developing their tennis offering. Eleven have been completed so far for identified priority LGA's. The ShapingSEQ Plan, a SRD GIS tennis participation heat map, forecast population growth and identified critical need for facility infrastructure were all considered when prioritising councils. All other LGA's will be strategically targeted in the new financial year and into 2020.

SOCIAL RETURN ON INVESTMENT RESEARCH PROJECT

Tennis has worked with Victorian University's Institute of Sport Exercise and Active Living to research the true social return of tennis clubs nationally. The project comes in response to an increasing demand from project partners and funders to understand the health, wellbeing and social benefits of tennis to the community. To determine the Social Return on Investment (SRoI), researchers have measured the value gained to overall health from participating in tennis.

GRANTS AND LOCAL TENNIS FUNDING

HERITAGE BANK COMMUNITY TENNIS GRANTS

Now in its tenth year, the Heritage Bank Community Tennis Grants program invites clubs to apply for financial assistance for projects that enhance accessibility, sustainability and participation in tennis. This year, all eligible applications to the program were approved, with a total of \$25,000 donated to clubs across the state for projects that included lighting, signage, ANZTHS equipment and the cost of coaching courses.

RURAL SUSTAINABILITY GRANT

The Rural Sustainability Grant was launched in 2015 to tackle club sustainability in the rural areas of Queensland. Investment in this area has been in place for just over two years and is showing some great outcomes with many clubs taking steps to return to self-sufficiency.

The funding program has been developed to help with a number of barriers faced by regional clubs such as investment in home grown coaches, facility facelifts, grant assistance and club development.

More than 100 home grown coaches have participated in Community Coaching Programs over the past two years with course held in Moura, Emerald, Longreach, Richmond, Tambo, Roma, Warwick and Mareeba. More than \$60,000 has been invested back into clubs to improve facilities in the form of new kitchens, clubhouse facelifts and signage to make these club more inviting and user friendly. New facilities have affiliated with Tennis Qld due to the success of this program and previously affiliated bodies have also come back on board.

The amount of new and upgraded facilities across rural and regional Queensland is also improving, with Tennis Qld support and the National Court Rebate Scheme. Roma was a standout, with six courts upgraded substantially. Other clubs to have made significant improvements include Ingham, Charleville, Barcaldine, Longreach, Homehill, while Monto, Murgon, Isis, St George, Charters Towers are all about to start work.

DEVELOPMENT OF OPERATORS

The development of improved quality professional operators is critical to the sustainability of clubs. In recent years, potential candidates have been encouraged to enrol in the Tennis Australia supported Master Club Pro course offered through Deakin University. With an increased focus on this area, Tennis Qld (in conjunction with Tennis Australia) have explored such opportunities for development and ways we can support operators looking to expand their skills and knowledge to take on these roles.

A network of industry leaders have also been identified to create a continual pool of best practice operators that can assist to develop their peers.



he Brisbane International 2017 presented by Suncorp Odelivered world class tennis action to Queensland for the ninth year in a row, with attendance figures now consistently in the realm of 100,000 patrons over the eight days of the event. Thirty-six nations were represented among the 58 players competing in the singles main draw, including 18 Australians with seven Queenslanders featured in singles action.


In the women's event, world No.3 Karolina Pliskova (CZE) won her first Brisbane International trophy and ninth career singles title, defeating fourth seed Alize Cornet (FRA) 6-0 6-3. The women's doubles final saw Bethanie Mattek-Sands (USA) and Sania Mirza (IND) claim their second Brisbane International title together prevailing over Ekaterina Makarova and Elena Vesnina 6-2 6-3. Mattek-Sands and Mirza won their maiden Brisbane International Doubles title back in 2013. In an emotionally charged ceremony following the match, Mirza handed over the title of women's doubles world No.1 to her partner Mattek-Sands.

In the men's event, Grigor Dimitrov (BUL) claimed his maiden Brisbane International crown and eighth ATP title with a win over Japanese No.1 Kei Nishkori. The world No.11 overcame Nishikori 6-2 2-6 6-3 in his first win against the US Grand Slam finalist in just four meetings. The men's doubles final was dominated by Australians Thanasi Kokkinakis and Jordan Thompson, who won their first ever doubles title over Gilles Muller (LUX) and Sam Querry (USA) 7-6(7) 6-4.

In a Brisbane International first, the Wheelchair Exhibition finals match was held on Pat Rafter Arena preceding the Women's Singles final on Saturday 7 January. Featured players included 2016 Rio Paralympic gold medalist and Newcombe Medal winner Dylan Alcott.

In 2017, a total of 332 aces were served on Pat Rafter Arena, with tournament partner Treasury Casino & Hotel donating \$83,000 to Ronald McDonald House South East Queensland as part of the 'Aces for Hearts' initiative.

VOLUNTEERS AND STAFF

In 2017, 622 staff including 530 volunteers and 100 officials worked behind the scenes to deliver the event. Many of the voluntary staff for the event return every year, making up the 'blue army' (a workforce that is engaged in tennis, loves the event, and who become champions within the community). Volunteers come from a wide variety of backgrounds, from the young ball kids who often dream of playing on Pat Rafter Arena, to patron services staff who have returned for the ninth consecutive year because they love the event, have played the sport for decades and now want to give back. A number of volunteers have also been selected for full-time jobs within the sport after their

time with the event, a testament to the teamwork, excellence and professionalism of our volunteers.

CHAMPIONS OF QUEENSLAND TENNIS

The Queensland Champions presentation was held on Pat Rafter Arena on Monday 2 January, with special guests Mr Mark Bloomfield and Queensland hero John Millman recognising the wonderful achievements of 39 Queensland athletes in 2016. Athletes that had represented Australia at the ITF Senior World Championships, the Queensland team that won the Bruce Cup at the National Championships, athletes with an intellectual disability that represented Australia at the World Championships as well as athletes that had achieved finals or won ITF international events were all acknowledged before the first night match on Pat Rafter Arena.

SUNCORP KIDS TENNIS DAY

Suncorp Kids Tennis Day was held on New Year's Day, Sunday 1 January, and featured appearances from Grigor Dimitrov (BUL) and Angelique Kerber (GER) as part of the Pat Rafter Arena Extravaganza Show with entertainment from Aussie music act Bonnie Anderson and Nickelodeon favourites Dora the Explorer and Teenage Mutant Ninja Turtles. Kids Tennis Day provides children under the age of 16 the opportunity to engage with the sport, with an emphasis on highighting the ANZTHS program and encouraging them to join tennis. More than 9,000 patrons were exposed to the sport through Suncorp Kids Tennis Day in 2017.

MEDIA COVERAGE

The Brisbane International was a major success in terms of promotion, with 90 print, radio, television and photographic media providing detailed coverage of the tournament to fans around the world. It's a unique chance for the world's eyes to be on Brisbane heading into the New Year, with players fresh from a break and keen to start their summer of tennis campaign.





GRASSROOTS HIGHLIGHTS

With the aim to encourage more people to get into tennis as well as give support to our Queensland tennis clubs, the 'Have a Hit on Us' campaign was launched at Brisbane International 2017. Have a Hit on Us was an initiative that allowed all Brisbane International ticket holders the opportunity to redeem two hours free court hire at participating clubs across Queensland.







The Have a Hit initiative was advertised on all ezytickets, broadcast on the big screens at the event and a lift out was placed within the daily program. Clubs involved saw a variety of new people walk through their doors to redeem their free court hire.

During the Brisbane International, Tennis Queensland hosted an innovative activation booth at The Racquet Club which proved to be a hit with visitors, especially the young tennis fans. Event goers could immerse themselves in a virtual reality tennis match, mirroring their favourite players on Centre Court. Even big-serving Aussie Sam Groth had a go at the game then signed autographs for a herd of young admirers. The activation was accompanied by a prize for every visitor, with a chance to win tickets to Pat Rafter Arena, tennis racquets, amusement park tickets or a month's supply of ice-cream thanks to Streets.

CONFERENCES AND WORKSHOPS

As the hallmark event of the year for Tennis in Queensland, the Brisbane International provides Tennis Qld with a great opportunity to reward and say thank you to those who drive our sport in local communities across the year. Key stakeholders from TQ affiliates, schools and government representatives were all invited to attend various workshops and information sharing sessions during the Brisbane International as part of our reward and recognition program. As well as these, a number of opportunities to learn and engage with tennis were also provided through on-site event experiences in the custom built function marquee embedded in The Racquet Club. Over 215 guests from 91 affiliated tennis clubs attended the annual President's Morning Tea hosted by Tennis Qld President Mr Mark Bloomfield. Bloomfield and Tennis Qld CEO Mr Geoff Quinlan addressed clubs, plus guests were treated to an inside look into the personal and professional commitments made by Australian doubles player Casey Dellacqua and current coach of Sam Stosur, Josh Eagle. Membership Grants totalling \$10,000 were also awarded to a lucky few affiliates.

Affiliates and local government representatives were also invited to the Tennis Qld Club Master Class with a key focus on competitions, relationship building and participation pathways. More than 100 participants were presented with information on the importance of school partnerships in clubs, mutual engagement between clubs and LGA's as well as the competition opportunities available to affiliates and their members. Six clubs won two tickets in a Brisbane International Corporate Box during the event.

The annual Brisbane Interanational Teachers' Appreciation Breakfast was attended by over 50 Physical Education teachers from across the state. Teachers were treated to a networking breakfast in the Brisbane International Lounge and briefed on the upcoming opportunities in the competitions and sporting schools space for the school year.

More than 100 Tennis Australia Coach Members were in attendance at the Queensland Coaches' Conference headlined by two former WTA tour coaches, guest speakers Thomas Hogstedt and Kenneth Bastiaens. On Wednesday 4 January, Tennis Qld hosted the inaugural LGA Information Breakfast for priority LGA's. Each Mayor and CEO from Tennis Qld's 11 priority electorates were updated on their Strategic Tennis Plans and the consultation process to create these with communuties across the state. Guests were also given an update on Local Government Infrastructure and Participation Planning templates for the sport as well as the Book a Court innovation.

Saturday 7 January was the second Brisbane International Friends of Tennis Experience with nine representatives from Local, State and Federal parliament invited to attend. Guests jumped on court for a game of FAST4 Tennis and enjoyed an experience of dining in the player restaurant before watching the women's final on Pat Rafter Arena.

Also in 2017, Tennis Qld invited 50 key Industry Leaders ranging from court builders, suppliers and operators of tennis facilities to the inaugural Brisbane International Industry Information Breakfast. The breakfast acted as a relationship builder with Industry Stakeholders and an opportunity to update them on Tennis Qld's Strategic Plan. Following the session, stakeholders enjoyed a tour of the facility together followed by a session in Pat Rafter Arena.



BRISBANE HOSTS DAVIS CUP

n April 2017, the Queensland Tennis Centre was chosen as host venue for the Davis Cup by BNP Paribas World Group quarterfinal between Australia and the United States of America. It was a thrilling encounter enjoyed by 16,403 fans over three days, with the contest live and electric until the final day of play.

Australia lead early on day one, with No.2 player Jordan Thompson scoring a surprise win over USA's No.1 Jack Sock. Nick Kyrgios delighted fans when he extended Australia's lead with a straight sets win over John Isner.

Day two saw the USA fight back, with doubles pairing Jack Sock and Steve Johnson edging out Sam Groth and John Peers in a thrilling five set match, keeping the USA's campaign alive.

Day three sealed the deal for the Aussies, with Nick Kyrgios defeating Sam Querrey in straight sets in front of a full house at Pat Rafter Arena. A dead rubber between John Isner and Sam Groth was won by the USA, but Australia won the tie 3-2.

FOR THE FANS

To harness the excitement of fans during the event, Tennis Queensland activated a Fan Zone where the sport's youngest fans were able to play Virtual Reality tennis, Hit the Target, and have their face painted in their best green and gold request. ANZTHS courts were also set up to give fans a taste of playing and encourage them to pick up a racquet at their local club.

TALENT DEVELOPMENT CAMP

Australia's Junior Davis Cup Squad - which features Queensland's Dane Sweeney - took part in a week long training camp at the Queensland Tennis Centre during the Davis Cup tie. The squad of six was encouraged to soak up what life is like at the top level, watching the Australian team train as they themselves were put through intense sessions on court.

Also undertaking an intensive training camp during the Davis Cup tie at the Queensland Tennis Centre was Australia's Intellectually Disabled team, lead by Brisbane's Archie Graham. The squad was in training for the INAS world Championships in the UK, where they went on to win gold, including a defended singles title for Graham.

FLOOD RELIEF

One of Queensland's most devastating flood disasters occurred in the weeks before the Davis Cup tie, Cyclone Debbie, which lead to a major fundraising effort at the event. Proceeds from a day's worth of ticket sales - worth \$20,000 - was put forward and matched by Tennis Qld, Tennis NSW, and Tennis Australia, taking the total amount to \$80,000. The money raised was donated evenly between the Red Cross Disaster Relief and Recovery Fund and tennis clubs across the region that suffered extensive structural damage.

MEDIA COVERAGE

With Australia's winning result came a flood of positive media coverage from the event. Thompson's surprise singles victory on day one set the tone for what became a celebration of Australian tennis, and an event loved by fans. Also covered leading in and during the event were grassroot stories, with linespeople from Brisbane and the Gold Coast featuring in local papers, providing a chance for local communities to benefit from Davis Cup media.

BRISBANE INT. SCHOOLS CHALLENGE

Brookfield State School continued their impressive run in the event with a fourth consecutive win in the red ball category. The school also took home the orange ball trophy for the first time beating Gold Coast winner Somerset College. The fiercely contested green ball title went to the Sunshine Beach State School from the Sunshine Coast, who edged out St. Paul's School, Bald Hills and Coomera Anglican College. Teams were presented their prizes by ATP and WTA players Kei Nishikori, Laura Siegemund, John Millman and Gavin van Peperzeel and took home once-in-a-lifetime memories from their trip.

QUEENSLAND MONEY RACE

The Queensland Money Race offered over \$16,000 to athletes who had won the most prize money from Queensland AMT events in 2016. JUNIOR DEVELOPMENT SERIES

The Junior Development Series introduces aspiring juniors to competitions at a local level across the state. Queensland is divided into eight regions based on Regional Assembly areas. Each region selects a team across the year to take part in the state finals, which are held annually in Rockhampton. The number of events has remained stable year on year, with over 5,500 participants playing in the series annually.

ROD LAVER QUEENSLAND JUNIOR CHAMPIONSHIPS PRESENTED BY TENNIS & GEAR ONLINE

A total of 616 players from all states and territories in Australia attended the 2016 Rod Laver Queensland Junior Championships presented by Tennis & Gear Online. The event is the biggest Junior Tour event in Australia, with six venues and 77 courts across Greater Brisbane utilised for the week.

A total of 13 countries were represented at the tournament including Australia, Fiji, Germany, Hong Kong China, Italy, Japan, Northern Mariana Islands, New Zealand, Tahiti, Samoa, Singapore, Sweden and Vanuatu. There were 98 international players in the draw, with more than 70 players from New Zealand.

QUEENSLAND JUNIOR TEAMS CARNIVAL

A total of 348 players came to Brisbane for the annual Queensland Junior Teams Carnival which is held across five venues in the month of December. The event has been growing in popularity over the past few years with teams from New Zealand, South Australia, Northern New South Wales and Northern Territory all taking part along with the teams from six regions of Queensland. This year's edition saw Metropolitan Region taking out the Regional Shield with a combined team total of 5.23 ahead of Northern NSW 5.75 and Gold Coast 8.

QUEENSLAND SECONDARY SCHOOLS TEAM TENNIS

Ninety school teams competed in the annual Queensland Secondary Schools Team Tennis Competition. The regional winners in both boys and girls competitions faced off at Rockhampton Regional Tennis Centre in September leading into the State Age tournament. In the boy's competition, Brisbane Boys College (BBC) defended their title from 2016. The girls from Kelvin Grove State College outclassed defending champions St Hilda's School Southport in a tight final to claim their maiden championship.

Both teams went on to the national finals in Albury, NSW and secured podium finishes for Queensland. BBC claimed the silver medal, only beaten by a set countback in the final against Maribyrnong. Kelvin Grove State College finished third nudging past the same opponent in the bronze medal match.

HEAD QUEENSLAND STATE AGE

The Head Queensland State Age was held in Rockhampton during the 2016 September school holidays. The popular event attracted 311 participants with matches played at the Rockhampton Regional Tennis Centre and Yeppoon.

1. Reporting entity

Roval Queensland Lawn Tennis Association Ltd (the "Company") is a company domiciled in Australia. The Company is a company limited by guarantee. The address of the Company's registered office is: Level 9 123 Albert Street Brisbane, QLD 4000

The Company is a not for profit entity and the principal activities of the Company during the course of the financial year were the promotion and development of the game of tennis in Queensland.

2. Basis of preparation

(a) Statement of compliance

The Company applies Australian Accounting Standards - Reduced Disclosure Requirements as set out in AASB 1053: Application of Tiers of Australian Accounting Standards and AASB 2010-2: Amendments to Australian Accounting Standards arising from Reduced Disclosure Requirements.

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards - Reduced Disclosure Requirements of the Australian Accounting Standards Board (AASB) and the Corporations Act 2001. The Company is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected noncurrent assets, financial assets and financial liabilities. The amounts presented in the financial statements have been rounded to the nearest dollar.

The financial report is presented in Australian dollars, which is the Company's functional currency.

The financial statements were authorised for issue on 25 September 2017 by the directors of the Company.

(b) Income Tax

The Company is exempt from income tax under section 50-45 of the Income Tax Assessment Act 1997. Accordingly no provision for income taxes has been made in these financial statements.

(c) Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Amounts disclosed as revenue are net of returns, trade allowances, rebates and amounts collected on behalf of third parties.

The Company recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and specific criteria have been met for each of the Company's activities as described below. The amount of revenue is not considered to be reliably measurable until all contingencies relating to the sale have been resolved. The Company bases its estimates on historical results, taking into consideration the type of customer, the type of transaction and the specifics of each arrangement.

Revenue is recognised for the major business activities as follows:

Grants

Grant revenue is recognised in the statement of comprehensive income when the entity obtains control of the grant and it is probable that the economic benefits gained from the grant will flow to the entity and the amount of the grant can be measured reliably.

(d) Cash and cash equivalents

Cash includes cash on hand and deposits with an original maturity of three months or less.

(e) Financial instruments

Initial recognition and measurement

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions to the instrument. For financial assets, this is equivalent to the date that the Company commits itself to either purchase or sell the asset (ie trade date accounting is adopted). Financial instruments are initially measured at fair value plus transaction costs except where the instrument is classified 'at fair value through profit or loss' in which case transaction costs are expensed to profit or loss immediately.

Classification and subsequent measurement

Financial instruments are subsequently measured at either fair value, amortised cost using the effective interest rate method or cost. Fair value represents the amount for which an asset could be exchanged or a liability settled, between knowledgeable, willing parties. Where available quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Amortised cost is calculated as:

- (i) the amount at which the financial asset or financial liability is measured at initial recognition;
- (ii) less principal repayments:
- (iii) recognised and the maturity amount calculated using the effective interest method; and (iv) less any reduction for impairment.

The effective interest method is used to allocate interest income or interest expense over the relevant period and is equivalent to the rate that exactly discounts estimated future cash payments or receipts (including fees, transaction costs and other premiums or discounts) through the expected life (or when this cannot be reliably predicted, the contractual term) of the financial instrument to the net carrying amount of the financial asset or financial liability. Revisions to expected future net cash flows will necessitate an adjustment to the carrying value with a consequential recognition of an income or expense in profit or loss.

Financial assets at fair value through profit or loss (i) Financial assets are classified at 'fair value through profit or loss' when they are held for trading for the purpose of short-term profit taking, or where they are derivatives not held for hedging purposes, or when they are designated as such to avoid an accounting mismatch or to enable performance evaluation where a group of financial assets is managed by key management personnel on a fair value basis in accordance with a documented risk management or investment strategy. Such assets are subsequently measured at fair value with changes in carrying value being included in profit or loss.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost.

(iii) Available-for-sale financial assets

Available-for-sale financial assets are non-derivative financial assets that are either not capable of being classified into other categories of financial assets due to their nature, or they are designated as such by management. They comprise investments in the equity of other entities where there is neither a fixed maturity nor fixed or determinable payments.

Available-for-sale financial assets are included in non-current assets, except for those which are expected to be disposed of within 12 months after the end of the reporting period.

They are subsequently measured at fair value with changes in such fair value (ie gains or losses) recognised in other comprehensive income (except for impairment losses and foreign exchange gains and losses). When the financial asset is derecognised, the cumulative gain or loss pertaining to that asset previously recognised in other comprehensive income is reclassified into profit or loss.

Financial liabilities (iv)

Non-derivative financial liabilities (excluding financial guarantees) are subsequently measured at amortised cost.

Fair value

Fair value is determined based on current bid prices for all quoted investments. Valuation techniques are applied to determine the fair value for all unlisted securities, including recent arm's length transactions, reference to similar instruments and option pricing models.

Impairment

At the end of each reporting period, the entity assesses whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether an impairment has arisen. Impairment losses are recognised in the statement of comprehensive income.

Derecognition

Financial assets are derecognised where the contractual rights to receipt of cash flows expires or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are derecognised where the related obligations are either discharged, cancelled or expired. The difference between the carrying value of the financial liability, which is extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed, is recognised in profit or loss.

(f) Plant and equipment

Plant and equipment are measured on the cost basis less depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed annually by directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets employment and subsequent disposal. The expected net cash flows have been discounted to their present values in determining recoverable amounts.

Plant and equipment that have been contributed at no cost, or for nominal cost are valued and recognised at the fair value of the asset at the date it is acquired.

Depreciation

The depreciable amount of all fixed assets including buildings and capitalised lease assets, but excluding freehold land, is depreciated on a straight line basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable assets are: Class of Fixed Asset **Depreciation Rate** Plant and equipment 10% - 33%

(q) Leases

Operating leases are leases under which the lessors effectively retain substantially all of the risks and benefits of ownership of lease items. Payments under operating leases are charged as expenses on a straight-line basis over the lease term.

Leases of fixed assets, where substantially all the risks and benefits incidental to the ownership of the asset (but not the legal ownership) are transferred to the entity, are classified as finance leases. Finance leases are capitalised, recognising an asset and a liability equal to the present value of the minimum lease payments, including any guaranteed residual values. Leased assets are depreciated on a straight-line basis over their estimated useful lives where it is likely that the entity will obtain ownership of the asset. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

(h) Employee entitlements

Provision is made for the Company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled. Employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may not satisfy vesting requirements. Those cash outflows are discounted using market yields on national government bonds with terms to maturity that match the expected timing of cash flows.

(i) Trade and other payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the Company during the reporting period which remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

(i) Comparative figures

Where required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

When an entity applies an accounting policy retrospectively, makes a retrospective restatement or reclassifies items in its financial statements, which materially impact the financial performance or position presented, a statement of financial position as at the beginning of the earliest comparative period must be disclosed

(k) Goods and services tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

Cash flows are presented in the statement of cash flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows

(i) Impairment of assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the statement of comprehensive income.

Where the future economic benefits of the asset are not primarily dependent upon the asset's ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of an assets class, the entity estimates the recoverable amount of the cash-generating unit to which the class of assets belong.

Where an impairment loss on a revalued asset is identified, this is debited against the revaluation surplus in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that same class of asset.

(m) New and amended accounting policies

During the current year, the Company has reviewed the new and revised mandatory Australian Accounting Standards applicable to entities reporting under the Corporations Act 2001 and the Directors believe that none of the new and revised standards are applicable to the Company.

(n) New and amended accounting policies in future periods

The AASB has issued a number of new and amended Accounting Standards and Interpretations that have mandatory application dates for future reporting periods, some of which are relevant to the Company. The Company has decided not to early adopt any of the new and amended pronouncements. The Company's assessment of the new and amended pronouncements that are relevant to the Company but applicable in future reporting periods is set out below:

AASB 9: Financial Instruments and associated Amending Standards (applicable to annual reporting periods beginning on or after 1 January 2018).

The Standard will be applicable retrospectively and includes revised requirements for the classification and measurement of financial instruments, revised recognition and derecognition requirements for financial instruments and simplified requirements for hedge accounting.

The directors do not anticipate that the adoption of AASB 9 will have a significant impact on the Company's financial statements.

AASB 15: Revenue from Contracts with Customers and AASB 1058 Income of Not-for-Profit Entities (applicable to annual reporting periods commencing on or after 1 January 2019).

When effective, this Standard will replace the current accounting requirements applicable to revenue with a single, principles-based model. Except for a limited number of exceptions, including leases, the new revenue model in AASB 15 will apply to all contracts with customers as well as non-monetary exchanges between entities in the same line of business to facilitate sales to customers and potential customers.

The core principle of the Standard is that an entity will recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for the goods or services. To achieve this objective, AASB 15 provides the following five-step process:

- identify the contract(s) with a customer;
- identify the performance obligations in the contract(s);
- determine the transaction price;
- allocate the transaction price to the performance obligations in the contract(s); and
- recognise revenue when (or as) the performance obligations are satisfied.

This Standard will require retrospective restatement, as well as enhanced disclosures regarding revenue.

Although the directors anticipate that the adoption of AASB 15 may have an impact on the Company's financial statements, it is impracticable at this stage to provide a reasonable estimate of such impact.

AASB 16: Leases (applicable to annual reporting periods beginning on or after 1 January 2019). When effective, this Standard will replace the current accounting requirements applicable to leases in AASB 117: Leases and related Interpretations. AASB 16 introduces a single lessee accounting model that eliminates the requirement for leases to be classified as operating or finance leases.

The main changes introduced by the new Standard include:

- Recognition of a right-to-use asset and liability for all leases (excluding short-term leases with less than 12 months of tenure and leases relating to low-value assets);
- Depreciation of right-to-use assets in line with AASB 116: Property, Plant and Equipment in profit or loss and unwinding of the liability in principal and interest components:
- Variable lease payments that depend on an index or a rate are included in the initial measurement of the lease liability using the index or rate at the commencement date;
- By applying a practical expedient, a lessee is permitted to elect not to separate non-lease components and instead account for all components as a lease; and
- Additional disclosure requirements.

The company currently has an arrangement with Stadiums Queensland that provides centres at a reduced rental rate. AASB 16 is likely to impact these arrangements, however it is impractical at this stage to provide a reasonable estimate of such impact

(o) Economic dependency

The Company receives grant funding from the Queensland State Government and Tennis Australia Limited that forms an integral part of the revenue used by the Company to achieve its short and long term objectives.

At the date of this report the Board of Directors has no reason to believe the Queensland State Government and Tennis Australia Limited will not continue to support the Company.
