CALL FOR BOARD NOMINATIONS - TENNIS QUEENSLAND

Please be advised that elections will be held for the following *elected* board positions at the upcoming Tennis Queensland (TQ) Annual General Meeting, to be held on Saturday 24 October 2020:

- Two (2) Director positions (three-year term)
- One (1) Director position (one-year term)

Following these elections, the TQ Board of Directors will *appoint* two further board positions at their first meeting following the Annual General Meeting:

- One (1) Director positions (three-year term)
- One (1) Director position (one-year term)

With our very own Ashleigh Barty at the top of women's tennis, our sport in Queensland is enjoying a significant boost in profile and political support. The vision for Tennis in Queensland is to continue building on our strong position in Queensland culture. We aim to create a more playful world through tennis, and in doing so, tennis clubs will be thriving sporting hubs within their local community.

TQ's strategy to 2024 has just begun, and ensures end to end alignment from Tennis Australia through to our clubs. Sharing a vision is vital to the success of our sport, with each state playing a key role in encouraging growth and fostering imagination and success.

The TQ Board of Directors oversee that strategy, with a keen interest in progressing the priorities within it. Female engagement at all levels of the sport, thriving clubs as community hubs and building meaningful participation pathways are a few of the focus areas we are looking to achieve.

Elected Directors Eligibility for nomination

Nominees for Elected Director positions must be a Registered Player residing within Queensland who is at least 18 years of age, of good repute and character and who has met, when due, all fees and other sums of money owing by that person to Tennis Queensland.

A Regional Assembly Chairperson or a Regional Member cannot also be a Director of the Company. If a person is a Regional Assembly Chairperson or Regional Member at the time they are elected as a Director of the Company, that person must within 21 days of their election resign their position/s as Regional Assembly Chairperson or Regional Member.

Tennis Queensland is committed to diversity and inclusion. We encourage nominations from people of diverse backgrounds, gender, age groups and experiences to seek nomination. Our strengths lie in our differences, not our similarities.

Process for nominating

Nominees for both elected and appointed positions, should complete and return the following necessary documents to nominate:

- a. Director nomination form
- b. Covering letter, no longer than one page
- c. A Curriculum Vitae (CV) no longer than two pages

Consideration and review of the nomination

Tennis Queensland's Governance Committee is responsible for reviewing all nominations and determining eligibility. The Governance Committee, in the process of their evaluation will shortlist the nominations received and may engage candidates throughout this process, during the week commencing 21 September 2020. The Committee will then provide their recommendations to the Board as well as Members of the Company (Regional Members).

All eligible nominees will be placed on the ballot paper for the election process to be held at the Company's Annual General Meeting on Saturday 24 October 2020, unless you are notified otherwise.

Following the Annual General Meeting all remaining nominees who have indicated willingness or desire to be considered for the Board appointed vacancies will be assessed by the Board of Directors with appointments then made.

Location, Time Commitment and Remuneration

The Board currently meets six times each year. Additionally, Board sub-committees meet 2-6 times a year. All board and sub-committee meetings are held at the Queensland Tennis Centre (QTC) at Tennyson in Brisbane, with the capability and option for virtual attendance if preferred.

This is a voluntary role.
