

# PRESIDENT'S REPORT

It has been a year of significant triumph through challenge for tennis in Queensland. We have navigated a number of operational changes and moulded our workforce to better service the needs of tennis stakeholders in the future. We have also enjoyed celebrating the success of Queenslander Ash Barty as she won her maiden grand slam title and rose to world number one at the close of the financial year.

I am grateful for the support and assistance of my fellow board members Warwick Nicol, Allan Harris, Nadeena Whitby, Paula Robinson, Michael James, Noel Jensen, Richard Watson, Colin Caswell and Paul Horn. They are a dedicated group of professionals who have volunteered their time and expertise for the benefit of tennis and have undertaken their duties with the upmost of care and consideration. A special mention also to our outgoing director, Allan Harris who retired by rotation at our Annual General Meeting after six years of dedicated service to the board.

Additionally, I thank our regional company members who represent their respective affiliates in the regions, raise issues, share knowledge and greatly assist in the governance process. Also the thousands of volunteers throughout Queensland who drive participation within their clubs and communities as coaches, administrators, tournament directors and officials.

Our CEO, Mark Handley was officially appointed in June 2018 and began work on delivering outcomes for Tennis Queensland (TQ) and the Brisbane International, tasked with facing the event's greatest changes in its 11 year history. The imminent introduction of the ATP Cup brought with it months of uncertainty for Queensland's major event, however the collaborative work by Tennis Australia (TA), TQ and the Queensland Government paid off. In January it was announced the Brisbane International women's event will remain in its current form and the men will join them in Brisbane, with one of the ATP Cup group stages.

Under the #brisbanetennis banner, the combined ATP Cup and Brisbane International event provides an exciting, refreshed introduction to the world tennis calendar and will certainly focus the spotlight on tennis in Brisbane. On behalf of tennis in Queensland, I would like to thank TA, the Queensland Government and Brisbane City Council for their continued support of tennis through this great event.

Throughout the year TQ worked closely with TA and our affiliates on changing our service delivery model. Additional funding provided by TA allowed us to

"decentralise" our workforce which resulted in the appointment of additional team members located outside Brisbane. This restructure will enable us to better service our regions and ensure a higher level of support can be provided.

I would also like to acknowledge the ongoing assistance TQ receives from Tennis Australia, in particular TA President Ms Jayne Hrdlicka and CEO Mr Craig Tiley. Both work tirelessly at the highest level of our sport, and have made significant changes which benefit Queensland in the areas of the Australian Open Series, player development and various participation initiatives.

### **FINANCIAL MANAGEMENT**

Since the construction of the Queensland Tennis Centre (QTC), TQ has undertaken the slow process of re-building our reserves to a point where they stand at approximately \$4.5M. The TQ Board developed a capital management policy that will guide the future allocation of these reserves towards strategically important projects requiring contribution from TQ. TQ is in a very sound financial position as we continue to maintain a conservative financial position and balance the immediate priorities of the organisation against future needs and requirements of the sport. The TQ team have worked within tight budgetary constraints and delivered a high quality professional service to our stakeholders.

### **QUEENSLAND TENNIS CENTRE**

MWS Sports has been the operator of the Queensland Tennis Centre (QTC) since 8 July 2014, under an agreement with TQ. After an extended period of discussion regarding MWS' adherence to the agreement, it was terminated by TQ on 12 February 2019. TQ has taken full operational responsibility, including court hire, coaching, tournaments, leagues and the running of the café/pro-shop. TQ values the QTC as one of the many great places to play in Queensland and will continue to operate to set it up for future growth.

I would like to thank our CEO, my Board and the TQ team for managing this significant transition. I am pleased to report the facility is operating soundly and providing a positive financial return to TQ.

At the time of writing this report, TQ is negotiating a settlement with the former operator. All parties are hopeful of a positive outcome, nevertheless we have made provision in these financial statements for the entire outstanding balance owing under the agreement.

### **AFFILIATE SUPPORT**

The TQ "Rally Kit' has continued to be improved and provides a valuable online resource that can be used by our affiliates. This concept is being further developed by TA through the Bounce platform. I encourage all affiliates to work closely with their TQ staff representatives to understand the resources available through these platforms and utilise them in their club.

# **WORKING IN PARTNERSHIP**

Our team continues to improve and develop relationships with all levels of government. This is realised via the 20 Local Government strategic infrastructure and participation plans as well as our official State Government partnerships which include;

- Sport and Recreation, seeing Tennis be one of six priority partner Sports with the Government
- Queensland Health via the My Health for Life Program, with Tennis celebrated and offered as an all-inclusive sport for Queenslanders who can get out and get active anywhere, anytime
- Signed MOU with the Department of Aboriginal and Torres Strait Islander Partnerships (DATSIP)
- Education Queensland, with the first year of a three-year agreement injecting \$1.5M into State School tennis infrastructure. Tennis is the first sport to unlock school gates working alongside Education Queensland.

Most importantly, these partnerships align to the Queensland Government new all of Government ten year sports plan Activate! Queensland 2019–2029. This is the Queensland Government's 10-year strategy to further enrich the Queensland way of life.

As with TQ's 2017-2020 Strategic Plan, Activate! will channel support and investment to build and activate infrastructure alongside our social, club, school and performance environments within Queensland communities.

Improving accessibility is to be our focus in the short term to ensure there are enough functional, sustainable and available facilities for all Queenslanders to be able to play our great sport. A final document will be delivered to the State Government and all Tennis stakeholders over the Summer of Tennis in 2020.

### SPECIAL EVENTS

The Brisbane International continued to build on the success from previous years and saw headline players like Rafael Nadal and Andy Murray signed to play. Unfortunately, injury saw the withdrawal of Nadal and Murray lost in the second round. Crowd numbers remained high throughout the week as we saw Kei Nishikori defeat Daniil Medvedev. In the women's draw past champion Karolina Pliskova defeated the unseeded Lesia Tsurenko in a terrific three set match.

We thank the major sponsors, Queensland Government and Brisbane City Council for their support of this event. TQ continues to work closely with the Brisbane International team to incorporate activities involving our registered players and affiliates, including the Queensland Money Race Finals, Brisbane International Schools Challenge, Queensland Coaches Forum, NSPP Teaches Workshop, Clubs Master Class, Future Leaders, Women in Sport and the Presidents' Morning

### **AFFILIATE SUPPORT**

I was honoured to welcome Murray Whitbread and Julie Cleverly as life members of TQ during an oncourt presentation during the Brisbane International. Julie has dedicated a signification portion of her life to officiating and has held numerous roles in officiating governance over the past 35 years. Murray has served on the TQ Board, represented his region as a Company

Member and spent a lifetime as a player, coach, club volunteer and tournament director.

Immediately after the conclusion of this year's Australian Open, Brisbane hosted the Fed Cup semi-final against Belarus with Australia winning 3 - 2. Interestingly, three of the four Australian team players hail from Queensland. This event provided an excellent opportunity to promote our sport and engage with the community, government and sponsors over three days of electric tennis. The TQ team performed exceptionally well in the delivery of the event and seized the opportunity to showcase our sport with a particular focus on women in sport initiates.

Looking forward, TQ will be seeking input from stakeholders as we develop a new strategic plan for the period 2020-2024. I sincerely thank everyone associated with Tennis. I feel privileged to be a part of this Tennis family and look forward to watching the sport continue to thrive.

# (EO'S REPORT

Each year, significant milestones and accomplishments are recognized and applauded by our tennis community. This year one stood out amongst all else. The rise of Ashleigh Barty to the very top of the world; the first Queenslander to get there since Pat Rafter in 1999; and her victory on the clay of Roland Garros, the first Australian grand slam champion since fellow Queenslander Samantha Stosur's US Open victory in 2011.

What a year it has been for Queenslanders on the world stage. Ash has climbed to now sit at the top of the rankings, Archie Graham solidified his status as the world's best player with an intellectual impediment, closely followed by Queensland stablemate Mitchell James who would end the year at Number 4. Meanwhile, John Millman broke into the world's Top 50 for the first time and knocked over Roger Federer in a giant-killing run to the guarter finals of the 2018 US Open. He would ultimately succumb to world No.1 Novak Diokovic. Ash and John were not the only ones in this period to record career high rankings, the emerging trio of Lizette Cabrera, Priscilla Hon and Kimberly Birrell would all have breakthrough years that will set them up for success. Then there was Sam Stosur's success at the Australian Open by claiming the women's doubles title, it would be the sixth grand slam doubles title of her career.

Our national academy leadership combined with an implemented mentoring program of elite athletes and emerging talent has fostered an environment of positive on- and off-court performance and is ushering in a new wave of Queensland tennis champions. Six different Queensland athletes represented their country in World Junior teams, and at Junior Davis and Fed Cup events. We also had four singles and four doubles national champions and a further six reached the final of various national championships. Queensland players also topped the country with five players crowned Australia's Number one in their age brackets.

The reporting period also ushered in two significant changes to the way tennis is showcased throughout Queensland. The first one is a global adjustment, with the introduction of a new men's team event delivered by the ATP in partnership with Tennis Australia – the ATP Cup. This announcement is in some ways bittersweet, as it sees the Brisbane International deconstructed from the 11 year history it has developed as a combined men's and women's spectacle. Excitingly for Queensland fans however, a women's only Brisbane International event will continue on and coincide with the new ATP Cup. Essentially, this new look showcasing of our sport will still attract the world's best players to compete at the Queensland Tennis Centre – it's just delivered differently. An expansion on previous years from 13 sessions to now 18, a mix of individual and team sport, and a significant boost in player prizemoney with more than \$23M on offer across the two tournaments.

# **OUR STRATEGY**

"Tennis will support the State Governments vision of providing healthy and active communities, by using sport as the vehicle to enrich people's lives"

The vision to be Queensland's most engaging sport was at the core of our decision making and presented a platform in which to start thinking about what is on the horizon. We saw growth across our delivery network with net gains in affiliates, coach members, school partners and court booking systems. Across the network we reached a combination of recorded and anecdotal participation numbers of 175,000 – eclipsing previous participation numbers by 20,000. Whilst our club membership remained steady, recording small growth across metro affiliates, the increase was largely on the back of school participation numbers.

Our budget for the first time tipped over \$5M in revenue to the organization, returning yet another operating surplus to TQ. However, our retained earnings have slipped from \$4.5M to \$4.2M following the provision for doubtful debt attached to the operations of the Queensland Tennis Centre.

## **OUR STRUCTURE**

"Investment in a decentralized workforce to support our delivery network in the field"

Over eight clearly defined regions that form the backbone of our governance structure. For years our Regional Assemblies; led by delegates from our affiliate network; have been delivering local outcomes for tennis and their clubs. Following a review on how to accelerate progression and better service our regions, TQ in partnership with TA, re-engineered the regional servicing boundaries to create 'super regions'. In the process, Tennis has invested in bringing in capability on the ground. Dedicated Regional Tennis Managers have been recruited into the four super regions to build field teams that support our volunteer and professional delivery networks. These field teams will be responsible for supporting our regional assemblies to develop and implement strategies linked to their own environmental nuances.

In the office we have focused on creating an Executive Leadership team for TQ that is fully integrated across all business units of our sport. We took the opportunity to bring in and grow an events team that can deliver not only the ATP Cup and Brisbane International but also expand the capability and professionalism to our year-round grassroots programming. We are also the only Member Association to have 'whole of sport' representation, that includes the National Academy and our major events. We are blessed to have such an array of skill, expertise and dedication to drive the development of our sport and work hand in hand with the many who contribute to delivery across the state.

# **OUR MAJOR EVENTS**

It has been a huge year in events, kicking off with the 11th and final running of the Brisbane International as we know it. Over 86,000 fans attended eight days of competition which included seven grand slam champions and four Queenslanders in the main draw. Most notably, Kim Birrell recorded the biggest win of her career to date by ousting Daria Kasatkina, she would then go on to make the third round of the Australian Open. The event culminated with Japan's Kei Nishikori capturing his first Brisbane International title and Karolina Pliskova claiming her second Evonne Goolagong Cawley trophy to add to her 2017 victory.

The Brisbane International is also a great stage to drive the participation. Multiple community engagement and reward & recognition initiatives were hosted during the event that included the launch of the WTA Future Stars program, the

finals of the state wide Schools Challenge, teacher and club appreciation days, world-class coaches conference and plenty of inclusion and diversity activations. Notably, this included the staging of a wheelchair exhibition event that included five of the Top 10 male wheelchair players in the

Our leading women would be back in April to spearhead an Australian Fed Cup semi-final victory over the dangerous Belarussians. Led by Ash Barty and supported by Sam Stosur, the Aussies would claim victory in a nail-biting fifth and final rubber in front of a vocal home crowd.

2018 and 2019 were the first time Queensland has held the Pizzey Cup (secondary school's team event) and Bruce Cup (primary school's team event). Further underlying the strength and depth of our playing group superbly led and nurtured by a world-class coaches and coaching academy.

## **QUEENSLAND TENNIS CENTRE**

In February, TQ took over the management and operations of the QTC and will continue to do so for the time being. Management took on the task to stabilize the operations and have now positioned this business with an opportunity for growth. All key performance indicators are positive to this point and management have put in place a plan to drive that growth into the future. Significant adjustment and focus has been attached to ensuring the QTC is a viable business for TQ. With currently over 70% of our organisation's revenue fixed, an opportunity exists to make the QTC profitable, which will provide more discretionary revenue for TQ to invest back into our sport.



# **A MOMENTOUS YEAR**

As we reflect on the past 12 months in Australian tennis, it is Queensland's Ash Barty who is on top of the world. Her victory at Roland Garros was achieved with not only class, humility and by being true to herself but also by honouring her talent, her family and her team.

For all of us involved in the sport, it was incredibly heartening to see such a wonderful athlete and role model fulfil her dream of becoming a Grand Slam singles champion and the latest world No.1. Her ascension to the top of the singles rankings began when she captured the doubles title at the US Open with American CoCo Vandeweghe, the WTA Elite Trophy in Zhuhai and shared the Newcombe Medal with Alex de Minaur – the highest honour in Australian tennis.

Ash was not the only athlete achieving great heights. Victoria's Dylan Alcott continues to make history in wheelchair quads taking to the grass at Wimbledon for the first time in doubles, capturing his second US Open crown, returning to world No.1, winning his fifth consecutive Australian Open title and taking the inaugural singles title in Paris. He continues to be an inspiration and an incredible ambassador for our country and our sport.

The past year was filled with many on-court triumphs by our Aussie players in front of a home-crowd. Alex de Minaur's maiden ATP singles title at the Sydney International, Sam Stosur's doubles crown at the Australian Open, the largest contingent of Aussies competing in the singles main draw since Australian Open 2000, the Davis Cup team qualifying in Adelaide for the new-look finals format later this year and our Fed Cup team's 3-2 victory over Belarus in Brisbane sending Australia to the final for the first time in 26 years. Eyes around the country will be glued to Perth in November to watch our Aussie team, captained by Alicia Molik, take on France for a shot to regain the cup 45 years since our last one.

### A NEW ERA IN AUSTRALIAN TENNIS

Our major focus for the past year has been increasing resources on the ground through greater investment into regional development via our Member Associations. This has led to the creation of more than 50 new jobs across the country to deliver tennis to the next generation and attract more adults back to the sport through social play.

We all know that being able to hold world-class events with more opportunities for the top players to start their season here in Australia is one of the most important factors in inspiring future generations to the sport.

With this in mind we've completely reinvented the summer and next January will be the biggest launch of the global tennis calendar with the introduction of a brand new men's teams event, the ATP Cup in Brisbane, Perth and Sydney, the new combined men's and women's Adelaide International and improved women's events in Hobart and Brisbane.

All of this leading into the pinnacle event on our calendar, the Australian Open, and with it the rollout of our new Australian tennis strategy. We have some big ambitions to grow our sport even further over the next five years as well as introduce a women's teams event to the summer line-up. It's because of our team's hard work over the past decade that we are in such a strong position to do this.





Brisbane's John Millman caused a world-wide sensation when he defeated the 20 time Grand Slam Champion Roger Federer in the fourth round of the 2018 US Open.

Millman's stunning win became front and back page news across Australia. Tennis led national TV and Radio news bulletins and John's charismatic family appeared live across every major breakfast TV show.

The media filmed National Academy players and coaches watching Millman play Federer and Novak Djokovic. It was an opportunity to talk about TQ's junior pathway and highlight the state's tennis role models. This angle featured in most news coverage, including on the ABC's 730 Report.

# **Western Rivers Cup**

The inaugural Western Rivers Cup in partnership with SWIN and PCYC was held. Including players selected for the National Indigenous Tennis Carnival in Darwin based on their sportsmanship!



Ipswich's Ashleigh Barty became the first Australian to win the French Open in 46 years and only the fifth Australian to top the world rankings in a magical month in Europe.

Barty's inspirational story and humility created extensive opportunities to highlight her as a role model from Queensland with the State's Premier, Annastacia Palaszczuk appearing twice at Pat Rafter Arena to congratulate and celebrate Barty's achievements.

The month also involved a late night "Barty Party" in conjunction with the Ipswich Council and a series of media opportunities and interviews with former coaches, TQ CEO Mark Handley and President Mark Bloomfield.

# 30 Coaches in 30 Days

Featuring interviews with 30 of Queensland's most respected coaches, this digital campaign was created to improve social engagement and generate more acknowledgement of our delivery network. From Cairns to Caloundra, Townsville to Toowoomba, the team connected with the coaching community like never before – and even inspired coaches to do their own version in their local environments.

Nationally, the Coach Development team also engaged in Thank You Week for tennis coaches. Attracting over 40,000 likes on Facebook nationally, recognising the contribution, impact and sacrifice our local coaches make, rain hail or shine, 365 days a year!

# **Females in Tennis**

As part of TQ's ongoing commitment to increase the female participation on and off-court in Queensland, a number of women's initiatives that promoted empowerment and connectivity were delivered for women in the Tennis industry.

One of these, a Women in Tennis Community Coaching Course was delivered in February at the QTC, attracting 15 participants from across south-east Queensland, and injecting 15 new female Trainee Coach Members into the coaching community. A key strategy in our aces for all program is creating a platform to educate and empower coaches and clubs to run inclusive programs and provide both playing and non-playing opportunities.



# Indigenous and Culturally and Linguistically Diverse (CALD)

Through building indigenous sporting initiatives with local communities, TQ is working towards building a legacy of sustainable tennis development programs. These demonstrate the positives impacts of tennis. This state-wide approach culminates each year in playing and professional development opportunities at the National Indigenous Tennis Carnival in Darwin.





## **Remote Communities**

Through the Aces for All program TQ has mobilized tennis playing opportunities and provided these to people living in remote communities. The intended outcome of these visits is to improve the capacity of remote communities to conduct regular and sustained tennis activities and competitions. It also assists with supporting talented players with travel and accommodation costs.

- A major inclusive Gala Day was held at the QTC with 171 students with disabilities from 11 schools.
- An inter-school red ball competition was held over three weeks with Brisbanebased special schools, allowing 30 students with disabilities to compete. Redlands District Special School won the trophy this year, beating last year's winner Calamvale Special School.
- · For the first time, an inclusion focused ANZ Tennis Hot Shots program was delivered in Maryborough, to staff at two special schools.





# From Learning to Match Play

In an exciting new development on the Gold Coast, Red Ball and Orange Ball Tournament circuits have been established to give ANZ Tennis Hot Shots players practical competitive skill development opportunities. Each tournament is all encompassing of ITF court specifications and relevant equipment modifications.

The circuits started in 2018 and from then until 2019, participation numbers have increased from 350 players to more than 500 players. Four tournaments have been added to the calendar and three additional clubs can now call themselves tournament hosts. The region continues to use these tournaments as a platform to provide parent and player education on expected etiquette and to upskill club committee members and coaches into mentor and tournament director roles.

# **Brisbane International Schools Challenge**

In one of TQ's biggest participation events, more than 32 gala days were held state wide with 360 schools and 3500 students taking part. The state final featured 20 schools and 200 students (including a school from the NT for the first time) with over 1000 spectators across two days at UQ Sport Tennis Centre and the QTC during the Brisbane International. Brookfield State School won for a second consecutive year.





# **Spotlight on Sunshine Coast**

An Emerging Leaders program developed by TQ in conjunction with the local Regional Assembly (RA) gave eight participants from all areas of the Sunshine Coast a chance to complete their Community Coaching Course and gain life experience via a 30-hour volunteer project within their club. The program, which was also funded by the RA, featured a vast range of projects from fundraisers to club tournaments and on-court coaching to community awareness days.





The Sunshine Coast Girls Squad returned with a new look in 2018. The coast was also lucky to secure another passionate qualified female coach to mentor the squad. securing some great new presenters and working with local businesses to build the program heading into 2020.





TQ worked with the RA, local associations and tennis clubs on an inclusive model for inter-club team competitions known as the Sunshine Coast Tennis League. After a 12 month trial period, the associations decided to continue with the proposed model for the future entrusting TQ to administer the operation of the competition.

The Sunshine Coast Tennis League now includes a coast-wide junior competition with 100 teams, the traditional Monday night adult competition as well as the premier division at the end of the year. New playing opportunities have been added with an open division including a singles component, the Junior Grand Slam Series and the Mary Valley Challenge for smaller regional clubs at the coast.





# **Spotlight on Key Investments**

Significant new venues to open in 2018-19 with two or more courts included Northshore Hamilton (6 courts), Moggill Sports Park (4 courts), Bayview State School (2 courts) as well as additional courts at Pioneer Tennis (2 courts) and Ambrose Treacy College (2 courts).



More than 300 courts have now embraced LED lighting technology – providing improved lighting quality, significant life cycle cost benefits for clubs in terms of maintenance costs and electricity usage costs.



Federal Government (SportAus - Community Sports Infrastructure) grants were made available for the first time, resulting in almost \$1.5m distributed to tennis projects in Queensland.







# **Club Development Highlights**

134 Operational Health Checks were completed. The OHC is Tennis Australia's annual national survey of tennis facility operations assessing venue management, usage and sustainability. Survey data is used to produce industry benchmarks, which enables clubs and venue operators to compare results against their previous performance, and against other venues of a similar size.








# BRISBANE INTERNATIONAL IN REVIEW

This year the squad included kids from as far afield as Canberra and Sydney, as well as a great representation from many parts of Queensland.





**PEOPLE:** enhance the capabilities and satisfaction of the tennis industry; create safe, supportive and fun environments to learn and play; encourage diversity at all levels of the game.

**PLACES:** provide necessary facilities to promote and deliver tennis; embed sustainable operating models; foster strong relationships with government and industry.

The Company's objectives have been designed to complement the constitutional objects found in Clause 3.1 of the Constitution

#### 5. Operating and financial review

The Company's net result for the year ended 30 June 2019 was a loss of \$322,989 (2018: surplus \$115,919).

#### 6. State of affairs

The Company has complied with Australian Accounting Standards as issued by the Australian Accounting Standards Board. During the year the Directors determined that the underlying financial activities of the regional assemblies are 'controlled' by the Company pursuant to the Australian Accounting Standards and, as such their results and financial position should be incorporated into the company. There were no other significant changes in the state of affairs of the Company that occurred during the financial year under review.

#### 7. Indemnification and Insurance of Officers

#### Indemnification

The Company has agreed to indemnify the directors and officers of the Company against all liabilities to another person (other than the Company or a related body corporate) that may arise from their position as directors of the company, except where the liability arises out of conduct involving a lack of good faith. # NOTES TO THE FINANCIAL STATEMENTS

#### 1. Reporting entity

Royal Queensland Lawn Tennis Association Ltd (the "Company") is a company domiciled in Australia. The Company is a company limited by guarantee. The address of the Company's registered office is:

Level 9 123 Albert Street Brisbane, QLD 4000

The Company is a not for profit entity and the principal activities of the Company during the course of the financial year were the promotion and development of the game of tennis in Queensland.

#### 2. Basis of preparation

#### (a) Statement of compliance

The financial statements are Tier 2 general purpose financial statements which have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements and the Corporations Act 2001. These financial statements comply with Australian Accounting Standards – Reduced Disclosure Requirements.

This is the first set of the Company's annual financial statements in which AASB 9 Financial Instruments has been applied. Changes to significant accounting policies are described in Note 3 (n).

The financial statements were approved by the Board of Directors on 8 October 2019.

#### (b) Basis of measurement

The financial report, except for the cashflow, have been prepared on an accrual basis and are based mostly on historical costs.

#### (c) Functional and presentation currency

The financial report is presented in Australian dollars, which is the Company's functional currency.

#### (d) Use of estimates and judgements

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

In particular, information about significant areas of estimation, uncertainty and critical judgements in applying accounting policies that have the most significant effect on the amount recognised in the financial statements are described in the following note:

• Note 12 – property, plant and equipment (impairment assessment and determination of useful lives)

#### 3. Significant accounting policies

The principal accounting policies adopted in the preparation of the financial report are set out below. Other than the adoption of AASB 9, refer Note 3(n), these have been applied consistently to all periods presented in these financial statements.

#### (a) Financial instruments

#### (i) Recognition, initial measurement of derecognition

Financial assets and financial liabilities are recognised when the Company becomes a party to the contractual provisions of the financial instrument, and are measured initially at fair value adjusted by transactions costs, except for those carried at fair value through profit or loss, which are measured initially at fair value. Subsequent measurement of financial assets and financial liabilities are described below.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and all substantial risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

#### (ii) Classification and subsequent measurement of financials assets

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price, all financial assets are initially measured at fair value adjusted for transaction costs (where applicable).

For the purpose of subsequent measurement, financial assets other than those designated and effective as hedging instruments are classified into the following categories upon initial recognition:

- Amortised cost
- Fair value through profit or loss (FVPL)
- Equity instruments at fair value through other comprehensive income (FVOCI)

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables which is presented within other expenses.

Classifications are determined by both:

- The Company's business model for managing the financial asset
- The contractual cash flow characteristics of the financial assets

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables, which is presented within other expenses.

#### (iii) Subsequent measurement financial assets

#### Financial assets at amortised costs

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVPL):

- They are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows
- The contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding

After initial recognition, these are measured at amortised cost using the effective interest method. Discounting is omitted where the effect of discounting is immaterial. The Company's cash and cash equivalents, trade and most other receivables fall into this category of financial instrument as well as long-term deposit that were previously classified as loans and receivables under AASB 139. The Company do not currently hold any financial assets at FVPL or FVOCI.

#### (iv) Cash and cash equivalents

Cash and cash equivalents comprise cash balances and call deposits with maturities of three months or less from the acquisition date that are subject to an insignificant risk of changes in their fair value, and are used by the Company in the management of its short term commitments.

#### (v) Non-derivative financial liabilities

The Company has the following non-derivative financial liabilities: interest bearing liabilities, bank overdrafts and trade and other payables.

As the accounting for financial liabilities remains largely unchanged from AASB 139, the Company's financial liabilities were not impacted by the adoption of AASB 9.

Financial liabilities are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Company designated a financial liability at fair value through profit or loss.

Subsequently, financial liabilities are measured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss.

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within finance costs or finance income.

#### (b) Plant and equipment

#### (i) Recognition and measurement

Items of property, plant and equipment are measured at cost or deemed cost less accumulated depreciation (see below) and accumulated impairment losses.

Cost includes expenditures that are directly attributable to the acquisition of the asset. The cost of self-constructed assets includes the cost of materials, direct labour, the initial estimate, where relevant, of the costs of dismantling and removing the items and restoring the site on which they are located, and an appropriate proportion of production overheads. Purchased software that is integral to the functionality of the related equipment is capitalised as part of that equipment.

Where parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment.

Any gain or loss on disposal of an item of property, plant and equipment (calculated as the difference between the net proceeds from disposal and the carrying amount of the item) is recognised in profit or loss.

#### (ii) Subsequent costs

The cost of replacing part of an item of property, plant and equipment is recognised in the carrying amount of the item if it is probable that the future economic benefits embodied within the part will flow to the Company and its cost can be measured reliably. The costs of the day-to-day servicing of property, plant and equipment are recognised in profit or loss as incurred.

#### (iii) Depreciation

Depreciation is recognised in profit or loss on a straight-line basis over the estimated useful lives of each part of an item of property, plant and equipment.

The estimated useful lives in the current and comparative periods are as follows:

- Plant and equipment 3-10 years
- Motor Vehicle 3-10 years

The residual value, the useful life and the depreciation method applied to an asset are reassessed at least annually.

#### (c) Impairment

#### (i) Financial assets (including receivables)

AASB 9's impairment requirements use more forward-looking information to recognise expected credit losses - the 'expected credit losses (ECL) model'. Instruments within the scope of the new requirements include loans and other debt-type financial assets measured at amortised cost. The Company makes use of a simplified approach in accounting for trade and other receivables and records the loss allowance at the amount equal to the expected lifetime credit losses. In using this practical expedient, the Company uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses using a provision matrix.

#### (ii) Non-financial assets

The carrying amounts of the Company's non-financial assets, other than inventories, are reviewed at each reporting date to determine whether there is any indication of impairment. If any such indication exists then the asset's recoverable amount is estimated.

Any excess of the assets carrying amount over its recoverable amount is recognised in the profit or loss.

#### (d) Employee benefits

#### (i) Long-term employee benefits

The Company's net obligation in respect of long-term service benefits is the amount of future benefit that employees have earned in return for their service in the current and prior periods. The obligation is calculated using expected future increases in wage and salary rates including related on-costs and expected settlement dates, and is discounted using the rates attached to the Corporate bonds at the balance sheet date which have maturity dates approximating to the terms of the Company's obligations.

#### (ii) Short-term employee benefits

Short-term employee benefits are expensed as the related service is provided. A liability is recognised for the amount expected to be paid if the Company has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee and the obligation can be estimated reliably.

Short-term employee benefits are benefits that are expected to be settled wholly within 12 months of the end of the annual reporting period in which the employee renders the service or which the Company has no unconditional right to defer settlement for at least 12 months of the end of the reporting period.

#### (iii) Termination benefits

Termination benefits are expensed at the earlier of when Company can no longer withdraw the offer of those benefits and when the Company recognises costs for a restructuring. If benefits are not expected to be settled wholly within 12 months at the end of the reporting, then they are discounted.

#### (e) Provisions

A provision is recognised if, as a result of a past event, the Company has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are determined by discounting the expected future cash flows at a rate that reflects current market assessments of the time value of money and the risks specific to the liability.

#### (f) Revenue and other income

#### (i) Tournaments and activities, receipts, sponsorships and subsidies

This includes the following types of income:

#### (i) Sale of goods

Revenue from the sale of goods is measured at the fair value of the consideration received or receivable, net of returns and allowances, trade discounts and volume rebates. Revenue is recognised when the significant risks and rewards of ownership have been transferred to the buyer, recovery of the consideration is probable, the associated costs and possible return of goods can be estimated reliably, and there is no continuing management involvement with the goods.

#### (ii) Rendering of services

Revenue from services rendered is recognised in the profit or loss in proportion to the stage of completion of the transaction at reporting date. The stage of completion is assessed by reference to surveys of work performed.

#### (ii) Affiliation fees

Revenue from affiliation fees is recognised in the profit or loss in proportion to the stage of completion of the transaction at the reporting date. The stage of completion is assessed by reference to the period to which membership relates.

#### (iii) Grants

#### (i) Reciprocal grants

Grants received on the condition that specified services should be delivered or conditions fulfilled are considered reciprocal. Such grants are initially recognised as a liability and revenue recognised as services are performed or conditions fulfilled.

#### (ii) Non-reciprocal grants

Where a grant is received where there is no performance obligation or return obligation, revenue is recognised when the grant is probable that the economic benefits will flow to the entity & the amount can be reliably measured.

#### (g) Lease payments

Payments made under operating leases are recognised in profit or loss on a straight-line basis over the term of the lease. Lease incentives received are recognised as an integral part of the total lease expense, over the term of the lease.

#### (h) Finance income and costs

Finance income comprises interest income on funds invested. Interest income is recognised as it accrues in profit or loss, using the effective interest method.

Finance costs comprise interest expense on borrowings. All borrowing costs are recognised in profit or loss using the effective interest method.

#### (i) Income tax

The income of the Company is exempt from income tax under Div 50 of the Income Tax Assessment Act 1997, and accordingly, no provision has been made in the accounts for income tax payable. Withholding tax from other jurisdictions is provided when the liability is due and payable.

#### (j) Goods and services tax

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense. Receivables and payables are stated with the amount of GST included. Cash flows are included in the statement of cash flows on a gross basis. The GST components of cash flows arising from investing and financing activities which are recoverable from, or payable to, the ATO are classified as operating cash flows.

#### (k) Trade and other receivables

Trade and other receivables include amounts due from member associations as well as amounts received from customers for goods sold in the ordinary course of business. All receivables are expected to be received within 12 months of the end of the financial year and as such are classified as current assets. Accounts receivable are recognised at fair value, less any provision for impairment. Refer to Note 3 (c) for further discussion on the determination of impairment losses.

#### (I) Trade and other payables

Trade and other payables represent the liabilities for goods and services received by the entity during the reporting period that remain unpaid at the end of the financial period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

#### (m) New accounting standards and interpretations not yet adopted

The following accounting standards, amendments to accounting standards and interpretations have been identified as those which may impact the Company in the period of initial adoption. They were available for early adoption for the Company's annual reporting period beginning 1 July 2019, but have not been applied in preparing this financial report. The Company's assessment of the new and amended pronouncements that are relevant to the Company but applicable in future reporting periods is set out below.

AASB 15 Revenue from Contracts with Customers becomes mandatory for the Company's financial statements for the period beginning on 1 July 2019 and establishes a comprehensive framework for determining whether, how much and when revenue is recognised. The standard replaces existing revenue recognition guidance. The Company have undertaken an assessment of the impact of AASB 15 and anticipate that initial adoption of the Standard will not have a material impact on the Company's financial statements. The Company has decided not to early adopt this new standard.

**AASB 16 Leases** becomes mandatory for the Company's financial statements for the period beginning on 1 July 2019 and introduces a single, on-balance sheet accounting model for lessees. A lessee recognises a right-of-use asset representing its right to use the underlying asset and a lease liability representing its obligation to make lease payments. There are optional exemptions for short-term leases and leases of low value items. Lessor accounting remains similar to the current standardie. lessors continue to classify leases as finance or operation expenses.

The Company has completed an initial assessment of the potential impact on its financial statements but has not yet completed its detailed assessment. The actual impact of applying AASB 16 on the financial statements in the period of initial application will depend on future economic conditions, including the assessment of Company's incremental rate, the composition of the Company's lease portfolio at that date, the Company's latest assessment of whether it will exercise any lease renewal options and the extent to which the Company chooses to use practical expedients and recognition exemptions.

The initial adoption of AASB 16 will have a material impact on the Company. The Company has decided not to early adopt this new standard. The most significant impact identified is that the Company will recognise new Right of Use (ROU) assets and lease liabilities. The estimated impact on the statement of financial position will be approximately \$650,000 to \$850,000 as at 1 July 2019.

AASB 1058 Income of Not-for-Profit Entities becomes mandatory for the Company's financial statements for the period beginning on 1 July 2019 and establishes principles for NFP entities that apply specifically to transactions where the consideration to acquire an asset is significantly less than fair value principally to enable a NFP Company to further its objectives; and to volunteer services received. The directors have undertaken an assessment of the impact of AASB 1058 and anticipate that initial adoption of the Standard will not have a material impact on the Company's financial statements. The Company has decided not to early adopt this new standard.

#### (n) Changes in significant accounting policies

The Company has initially applied AASB 9 from 1 July 2018. AASB 9 sets out requirements for recognising and measuring financial assets, financial liabilities and some contracts to buy or sell non-financial items. This standard replaces AASB 139 Financial Instruments: Recognition and Measurement.

#### (i) ECL model

This new impairment model applies to financial assets measured at amortised cost, contract assets and debt investments at fair value through other comprehensive income. For assets in the scope of the AASB 9 impairment model, impairment losses are generally expected to increase and become more volatile. The Company has determined that the application of AASB 9's impairment requirements at 1 July 2018 did not have a material impact on the Company. As such, no restatement of the prior period balances has been made.

The effect of adopting AASB 9 on the carrying amounts of financial assets at 1 January 2018 relates solely to the new impairment requirements. The below table sets out the measurement bases of the Company's financial assets under AASB 139 and AASB 9. The change in categorisation has had no effect on their carrying amounts.

#### 23. Reserves

#### (a) Regional Assemblies Reserves

#### (b) Facility Development Reserves

The Company recognised a Facility Development Reserve as at 30 June 2018, for a contribution for the construction of the North Tennis Centre. This reserve was fully utilised during the year ended 30 June 2019.

#### 24. Regional Assemblies

The Company oversees, and provides minor funding for, the operations of 8 regional assemblies within Queensland. The role of the assemblies is to provide primarily for the promotion of the sport in regional areas as set out in the Company Constitution.

During the period the Directors determined that the underlying financial activities of the regional assemblies are 'controlled' by the Company pursuant to Australian Accounting Standards. This change in accounting treatment resulted in an initial amount of \$200,849 allocated to retained earnings to reflect the establishment of the net assets of the Regional Assemblies from 1 July 2018. The funds held in relation to the regional assemblies can be used at the discretion of the regional assemblies, and have been provided for as a reserve from the financial year ended 30 June 2019. It was determined that restatement of the prior periods was impracticable as oversight of the Regional Assemblies financial information commenced predominately in the current financial year.

#### 25. Subsequent Events

In the interval between the end of financial year and the date of this report there have been no matters or circumstances arise which significantly affected or may significantly affect the operations of the company, the results of those operations, or the state of affairs of the company in future financial years.
