

TENNIS SA AFFILIATION PROGRAM 2019 - 2020

Affiliation between 1 September 2019 to 31 August 2020



Association

An Association is a body that has met the criteria within the Tennis SA Constitution as being an Association. Associations that do not have eligible clubs under its affiliation, or are conducting itself in a similar manner as a club, will be considered a Club and charged as per the most appropriate category based on its location and number of courts it requires for insurance.

School Fee

(applies to junior school teams only)

The school fee covers schools that affiliate to Tennis SA and participate in Tennis SA affiliated competitions. The school fee does not cover Old Collegians clubs who will be required to pay the appropriate club fee that reflects their facility (court) size. A Certificate of Currency providing Public Liability cover for at least \$30 million must be submitted annually.

Small City and Hills Club

A Small City & Hills Club is a body that has met the criteria within the Tennis SA Constitution as being a Club and are affiliated or located within the boundaries of any of the city based associations, including the Hills Tennis Association. This category is for those clubs that require the use of 0-4 courts for their insurance coverage.

Small Rural Club

A Small Rural Club is a body that has met the criteria within the Tennis SA Constitution as being a Club and are affiliated or located outside the boundaries of any of the city based associations, including the Hills Tennis Association. This category is for those clubs that require the use of 0-4 courts for their insurance coverage.

Medium City and Hills Club

A Medium City & Hills Club is a body that has met the criteria within the Tennis SA Constitution as being a Club and are affiliated or located within the boundaries of any of the city based associations, including the Hills Tennis Association. This category is for those clubs that require the use of 5-9 courts for their insurance coverage.

Medium Rural Club

A Medium Rural Club is a body that has met the criteria within the Tennis SA Constitution as being a Club and are affiliated or located outside the boundaries of any of the city based associations, including the Hills Tennis Association. This category is for those clubs that require the use of 5-9 courts for their insurance coverage.

Large City and Hills Club

A Large City & Hills Club is a body that has met the criteria within the Tennis SA Constitution as being a Club and are affiliated or located within the boundaries of any of the city based associations, including the Hills Tennis Association. This category is for those clubs that require the use of 10 or more courts for their insurance coverage.

Large Rural Club

A Large Rural Club is a body that has met the criteria within the Tennis SA Constitution as being a Club and are affiliated or located outside the boundaries of any of the city based associations, including the Hills Tennis Association. This category is for those clubs that require the use of 10 or more courts for their insurance coverage.

Small Sporting Complex

The small sporting complex category is for venues that have an existing and shared insurance scheme for all of the participating tenants. Sole tennis clubs cannot access a proof of insurance fee and must pay the appropriate club size (courts) fee. This category is for those venues that have 7 or less courts at their tennis club. A Certificate of Currency providing Public Liability cover for at least \$30 million must be submitted annually.

Large Sporting Complex

The large sporting complex category is for venues that have an existing and shared insurance scheme for all of the participating tenants. Sole tennis clubs cannot access a proof of insurance fee and must pay the appropriate club size (courts) fee. This category is for those venues that have 8 or more courts at their tennis club. A Certificate of Currency providing Public Liability cover for at least \$30 million must be submitted annually.

TERMS AND CONDITIONS OF AFFILIATION

As per the Tennis SA Constitution, annual membership of associations, bodies and clubs to Tennis SA is enabled through these Affiliation Terms and Conditions.

Affiliates will agree to:

- 1. Be bound by the Constitution, Membership Guidelines, Member Protection Policy, By-Laws and Regulations of Tennis Australia and Tennis SA.
- 2. Declare that the information given in the application is true and accurate.
- 3. Certify that it is an Incorporated Body and is being run in accordance with its rules and all obligations associated with this status.
- 4. Pay the prescribed fee.
- 5. Complete all information relating to the club, club facilities and club members and volunteers (Member Registration see below) into the Tennis SA member database (i.e. MyTennis).
- 6. Provide a copy of their schedule of programs, competitions and tournaments.
- 7. Provide a copy of their most recent Annual Report, including Financial Report.
- 8. Accept the Privacy Statement (below)

Affiliates that apply through the "Sporting Complex" categories must provide proof of the following minimum insurance requirements to enable their application to be accepted.

- \$30 million Public & Products Liability
- \$10 million Professional Indemnity
- \$5 million Directors & Officers

Note: Affiliates wishing to apply for the Sporting Complex categories that are unable to supply these requirements will be required to pay the appropriate court based club category.

Privacy Statement

To assist Tennis SA in the provision of products and services, we need to collect personal information about you. When you provide personal information you agree that this will be used by Tennis Australia and Tennis SA under the terms of this statement, and the tennis privacy policy located at www.tennis.com.au/privacy, which contains information about how you may access and seek correction of your personal information or complain about a breach of your privacy, and how we will deal with that complaint. If you do not agree, you must not provide your personal information, you may be unsuccessful in receiving membership and may be unable to access all of our products and services.

Tennis Australia and Tennis SA may disclose your personal information to other parties, including our related companies, other Australian Tennis Organisations, and third parties who provide us services. From time to time, these third parties may be located (and therefore your personal information may be disclosed) overseas, including to the USA and the Netherlands and as otherwise specified in the tennis privacy policy. Tennis Australia and other Australian Tennis Organisations may use and disclose your personal information for direct marketing purposes regarding the products and services you are signing up to receive, unless you opt-out (which you can do at any time in accordance with the tennis privacy policy).

Member Registration

For the 2019/20 Affiliation Year there will be no individual player registration fee. All player participants and volunteers that are updated or entered into My Tennis will be covered for Personal Accident Insurance by the entity fee which is paid by the Affiliate upon their affiliation with Tennis SA.

All player participants and volunteers that are updated and registered on My Tennis for the 2019/20 Affiliation Year, will automatically be covered for Personal Accident insurance and will have access to all Tennis SA member benefits for the 2019/20 Affiliation Year.

Our aim is to significantly increase the number of people who are associated with the game and accurately report on the data. Entering all Affiliates' members into My Tennis, enables every Affiliate to maintain one database, making access and communication to all Affiliates' members simpler.

Affiliates can contact their Club Development Officer for more information about My Tennis, including training and using all of the system's features.

Blacklist

The Tennis SA Blacklist encompasses the names of members which have played in competition tennis at club and have become unfinancial. Once a member has been deemed unfinancial they are unable to participate in competitions, tournaments and events. They are also unable to move clubs and play in different competitions until their debts have been paid at their previous club.

The procedures a club needs to take to add someone to the Blacklist is:

- In writing to Tennis SA, state the reason for the nominated player to be added to the blacklist, including full contact details and which club is nominating them. Tennis SA will add this person to the Blacklist
- Tennis SA will inform the player, club and association, in writing, of this person's inclusion to the Blacklist.

For the person to be removed from the Blacklist:

- Tennis SA must be informed by the club, in writing, that the nominated player has paid their fee in full and therefore seeks to remove the player from the Blacklist.
- · Úpon receipt of the notice from the club, Tennis SA will remove the player and will inform the player, club and association, in writing.

The Blacklist is not publicly available.

Affiliation Method

- 1. All applications will be ratified by the Board of Tennis SA. Only applications that include payment and either a correctly completed form or have updated their affiliation through MyTennis, will be assessed by the Board.
- 2. As of 31 December any renewing affiliate that has not completed the fill requirements will be disaffiliated and therefore uninsured.
- 3. All new applications for Affiliation will be considered uninsured until a correctly completed form and payment has been received by Tennis SA.
- 4. The Affiliation invoice will be provided by Tennis SA. No additional player registration fees are associated with affiliation. The due date for payment as indicated on the invoice is the date in which Tennis SA will act upon late payment notices. The invoice may request payment prior to 31 December.
- 5. Payment of the Affiliation fee can be made via Cash, Cheque, Money Order, Electronic Payment, or in person at the Tennis SA office.
