Tennis Tasmania is committed to ensuing our governance is what is expected by our affiliated clubs and our stakeholders including local, state and federal governments. Amidst our optimistic outlook for the future, we recognised the substantial investments that had been dedicated to upholding the sport's prominence within the community and its continued advancement throughout the challenging pandemic years. Consequently, in collaboration with Tennis Australia and all States and Territories, we embarked on an inclusive nationwide consultation process from the grassroots upwards. This process was undertaken to shape a cohesive strategy for tennis that could be effectively implemented across diverse environments throughout the country. This comprehensive engagement process laid the groundwork for the 'Game On' Tennis strategy, reflecting the insights gleaned from this exhaustive

The year commenced on a joyous note as we gathered with the Tasmanian Tennis community in Launceston to hold the AGM and the prestigious annual Awards evening. This event was graced by the presence of guest speaker and esteemed Tasmania Tennis Hall of Famer, Helen Gourlay. Amidst the social atmosphere, we commemorated the achievements of winners and finalists, offering them due recognition. This occasion served as a wonderful opportunity to unite and extend our gratitude to the tennis community for their unwavering support and contributions to tennis over the past

#### **KIDS TENNIS**

The prowess of tennis within Tasmanian schools continues to thrive and flourish. Once again, this year has witnessed continued growth in the number of schools embracing tennis as an integral part of their curriculum, thereby introducing a larger cohort of students to the joys of the sport and solidifying their engagement through ongoing teacher-delivered programs.

The collaboration between coaches and schools remains robust, forging resilient partnerships that aid in the seamless delivery of tennis education and in elevating the teaching staff's proficiency. The cohesive efforts of the Tennis Tasmania team have been pivotal in providing support whenever necessary and fostering novel avenues

for tennis to forge deeper connections within the educational framework.

A heartening development is the burgeoning landscape of school-based tennis events and leagues, laying the foundation for young participants to seamlessly transition into broader leagues and events orchestrated by local clubs.

# COMPETITIVE PLAY: ELEVATING THE TENNIS EXPERIENCE

The realm of Competitive Play has been reshaped through an active and dynamic transformation, precipitated by a comprehensive nationwide review and implementation. These efforts have been directed towards enhancing the clarity of the competitive pathway, introducing a fundamental tennis rating system known as the Universal Tennis Rating (UTR), and carefully orchestrating our calendar of events and leagues spanning across the state. While the implementation will continue to be refined and added to, the transformation empowers players with the ability to better chart out their schedules in advance, enabling them to strategically target specific events.

This shift has contributed to an increase in participation opportunities, a testament to the resonance of the approach. Notably, the PMG Tassie Junior League has proven to be a significant success story. With over 440 young players participating each year, this league has emerged as a yearround platform for juniors to engage in consistent match play across Orange Ball, Green Ball, and Yellow Ball categories. Powell Motor Group's (PMG) steadfast

support has been instrumental for introducing players into competition, allowing their talents to develop and thrive in a safe learning environment.

The essential role played by officials in maintaining the integrity of the sport cannot be overstated. Their dedication to ensuring fair play across all levels of competition is invaluable. From local matches to international events, officials are the unsung heroes who contribute to the seamless flow of the game. This year, we have seen officials taking centre stage at events such as the Hobart International, showcasing their expertise on the global stage.

#### INCLUSION, EQUITY AND DIVERSITY

Central to our ethos is an ongoing commitment to creating an inclusive and diverse tennis community. Our collaborations with events like the Special Olympics have been pivotal in shaping a tennis landscape that welcomes all participants. This effort resonates with our broader vision - to make tennis a space where everyone feels welcome, safe and respected.

The introduction of the Women Leaders in Tennis (WLIT) program stands as a testament to our dedication to fostering diverse leadership within the sport. By empowering women in tennis through education, mentoring, and networking opportunities, we are actively shaping a more balanced and representative future.

Joining its place once again at the Hobart International in 2023, we welcomed the return of the highly anticipated Hobart Out tennis championships. This annual event attracts players not only from across the nation but also from around the globe. Notably, the growth in local Tasmanian participants has stood out as a remarkable highlight, underscoring the concerted efforts of Hobart Out Tennis Club and Tennis Tasmania in their unwavering commitment to championing and fostering the LGBTI+ community's engagement in tennis.

.Inclusion, Equity and Diversity

#### **COACHES**

Tennis coaches have always been the bedrock of player development, and the past year has witnessed a renewed focus on their empowerment. A pivotal step in this direction was the creation of the Coach Relationship & Education Manager role, entrusted to Alyssa Hibberd. This strategic move aligns with our commitment to supporting coaches both in terms of business and professional growth. With an array of projects aimed at enhancing their skills and capabilities, we are ensuring that coaches have the necessary tools to guide and shape the next generation of tennis players.

#### **STATE TEAMS**

Our State Teams representatives have served Tasmania proudly as these aspiring players to experience highlevel competition. Beyond the court, it has provided a platform for them to understand the dynamics of teamwork and start developing our own Tasmanian Team culture. These experiences, invaluable in shaping their holistic development, have positioned players to strive for excellence in the sport.

#### MAJOR TOURNAMENTS RETURN

The triumphant return of the Hobart International in 2023 marked a momentous event, captivating both local and global audiences. Held at the Domain Tennis Centre, this premier tournament showcased world-class tennis players from the WTA tour, including Grand Slam Champions and previous Hobart winners. The tournament's electric atmosphere was heightened by a passionate audience of over 14,000 attendees, enjoying not only thrilling matches but also live music. local food vendors, and engaging fan experiences. The 2023 Hobart International reasserted itself as a must-attend fixture on the global tennis calendar, elevating women's sport and leaving an enduring legacy that inspires and shapes the future.

The Caterpillar Burnie International, which graced our tennis calendar after a three-year hiatus due to the pandemic, rekindled the passion for world-class tennis on the North West Coast. The tournament, boasting a substantial prize pool, brought together players from various corners of the globe including Rinki Hijikata, who had come off the

back of winning the Australian Open Doubles title a few days prior. Notably, the addition of the Caterpillar Burnie International #2 extended the excitement for another week. The event was not only a showcase of tennis prowess but also a testament to the meticulous planning and community engagement that went into its execution.

In addition, players were presented with an extra chance to compete in the inaugural \$20k Devonport Signature Open. Serving as a prelude to the Burnie tournaments, this event drew the participation of top-tier players. The remarkable response from the Devonport Tennis Club, community, players, staff, and officials is a promising indicator of the tournament's potential growth in the upcoming year.

### UPGRADING FACILITIES: ELEVATING THE TENNIS

Infrastructure plays a pivotal role in fostering an enriched tennis experience, and the Kingston Tennis Club's impressive upgrade is a testimony to this belief. # FROM THE CHAIR AND CEO

### Because we believe playing makes life better ...

Creating a playful world through tennis for everybody, forms a powerful vision for our organisation. Everything we do stems from our passionate purpose to grow grassroots tennis. This means expanding our base of genuine interest and participation in the sport at the community level.

The seeds of long-term interest in tennis are sown early. We want the community to engage, to play socially and practise and compete regularly. We want that passion to continue to evolve to watching, coaching, officiating and administering the sport. And better vet, to volunteer to help run it. All of this builds a foundational player base from which generations develop and ultimately compete and win internationally. It also builds a community of ravenous fans, keen to follow their favourite players around the world and at home for our amazing summer of professional tennis. This of course culminates in January at the Australian Open, with Australians around the world hungry to watch and attend the event.

And it is a virtuous circle. Continued grassroots growth drives more

engagement in the sport, drives more homegrown professionals and enables the Australian Open to grow from strength to strength and be able to attract the world's best tennis players. That is our fly wheel and no one part of the system is more important than the other. It is a delicate balance that we love, nurture and invest in over time. And importantly, we all work hard to keep getting better, together.

This year more than ever, every age, every ability and every region of the nation was represented as we welcomed record numbers of players on court. Independent AusPlay data shows participation grew by 14 per cent to 1.514 million in the 2021 calendar year. Embedded in this number was a 20 per cent increase in the number of adults playing tennis.

Some enjoyed the health and lifestyle benefits of participating in the sport informally in social settings, other players were driven by the rewards of club-level tennis and regular competition. And while traditional forms of the game will always honour its rich heritage, complementary formats provided opportunities for existing players to experience tennis in a

new way or others to experience it for the first time.

While there are many measures of success looking back over the last year, the growing number of people enjoying the sport in clubs, community settings, schools and other venues is unquestionably the most important. We passionately believe that playing makes life better and it is our great honour to help bring richer life to communities across Australia.



Accessible, engaging and offering a range of enduring health benefits, tennis has long been known as a sport for life. And, it is important that learning to love the sport starts early in life. We are delighted to see that the metrics tell us we are doing a good job on this count.

More than 634,000 young players experienced Tennis Hot Shots, our official start-up program, in the past year. Another 40,000 kids enjoyed AO Holiday Programs delivered by 275 coaches at 450 venues in January. The Tennis Hot Shots Racquet Roadshow (a program which sees racquets gifted to first-year primary school students) delivered a milestone 200,000th racquet, which was delivered at Syndal South Primary School in Victoria. This is the fifth year of the program and those keen students are putting their modified equipment to good use.

For the sixth straight year, the Tennis in Schools program was the No.1 requested and delivered sport in the Sporting Schools initiative. This is a huge achievement and a stature to fiercely protect.

A range of offerings ensures that tennis remains readily accessible at any age.

While fostering safe and inclusive tennis communities, ongoing facilities development remains a constant priority. Since 2007, more than \$29 million has been invested into the National Court Rebate initiative, which partners with all levels of government and local communities. This investment continued throughout the past financial year, including to 20 flood-affected venues.

Support for quality governance at grassroots level was also enhanced through the launch of the innovative Health Indicator of Tennis (HIT) tool. Helping to improve the experience and accessibility of reporting on the performance of tennis venues nationally, it allows for information to be entered via online forms and submitted directly in the HIT platform. This in turn ensures greater data accuracy and richer insights.



There were also informal but compelling ways in which tennis was integrated into the wider community. Over the past financial year, the Hitting Wall art project was completed, with a wall in each state and territory reinvigorated by local artists. Attracting participants to the sport at a more casual level, the artistic project also promoted more than 450 Hitting Walls at affiliated Australian clubs and community settings.

# COMPETITIVE GROWTH

The natural progression from an expanding participation base is an increase in competitive opportunities for every age and ability. The launch of a new Competitive Play Framework, in January 2022, was one of our major initiatives. It helps players better understand their level on the pathway and in turn, identify

COMMUNITY

More than 3200 Tennis Australia coach members delivered a range of programs across the nation, with many progressing through our coach education initiatives. In the ln excess of 600 coaches enrolled in Tennis Australia courses over the 2021-2022 period; underlining the benchmark status of those educational pathways, and tennis a further 630 coaches from 31 nations participated in the virtual Grand Slam

competitive opportunities best suited to their standard. The number of endorsed events increased 70 per cent in the first six months to more than 300, with 11,934 players competing.

Meanwhile, the Australian Pro Tour, UTR tournaments and junior competitions returned to a more complete schedule following pandemicenforced interruptions, providing vital match play and development avenues for both emerging and professional players. The multiple pathways are designed for athletes aiming to thrive at a professional level. There were more than 5000 young athletes in Talent Development programs throughout the nation and 40 players, aged between 15 and 23, invited into the National Tennis Academy in Brisbane.

Change is never easy, but we believe we are on the right path and with the feedback and input of the community, important improvements in the model are underway.

# SUCCESS BREEDS SUCCESS

Many of our aspiring players in these pathways had no shortage of inspiration this year from those that have undertaken the development journey before them. For it was truly a marguee year for Australian tennis. Ash Barty memorably lifted the Daphne Akhurst Memorial Trophy at the Australian Open, becoming the first local player to claim the women's singles title in 44 years. There was also a thrilling Grand Slam breakthrough for Nick Kyrgios and Thanasi Kokkinakis, who defeated Matt Ebden and Max Purcell in an all-Australian men's doubles final. As well, Dylan Alcott was named Australian of the Year.

Rafael Nadal also triumphed in a thrilling men's final to seal a record 21st Grand Slam singles title. The tennis history books were substantially updated following AO 2022. We are all grateful to have created the stage that enabled such a phenomenal summer of tennis in Australia.

Both proven champions, Barty and Alcott retired while holding the world No.1 ranking, while many of their





colleagues also performed well on the world stage in 2022. In all, we celebrated seven Grand Slam champions in the 2022 season, Nick Kyrgios made the Wimbledon singles final and there were multiple milestone achievements from players in Slams and in ATP and WTA events.

In addition to the amazing tennis results at the AO 2022, we saw great fan engagement across the country. More than 185,000 attended lead-in tournaments in three capital cities and regional Victoria, before an unforgettable edition of the Australian Open. Despite some lingering pandemic-



related restrictions, Melbourne Park sparkled – with the final stage of the almost \$1 billion redevelopment completed, the 5000-seat Kia Arena show court was opened and the new multi-purpose Centrepiece venue utilised as a corporate, functions and media centre for the first time.

And as those achievements were celebrated in the global tennis spotlight, our commitment to innovation was also made clear. The Australian Open made an award-winning move into the Metaverse, with over 50,000 visitors exploring AO Decentraland. An AO Art Ball collection, linking an NFT collection



to line-call data, marked another world first. A second edition of the Techstar accelerator program had provided support for early-stage SportsTech companies, with four of the 11 companies selected activating at AO 2022.

Meanwhile, commercial success ensured vital funds were reinvested into the sport. While domestic and global broadcast reached record audiences, Kia celebrated its 21st straight year as the Australian Open's major partner; we thank Kia and other loyal partners – including Emirates, Luzhou Laojiao, Rolex, Ralph Lauren and Visit Victoria – for their valuable support.

#### **OPEN TO ALL**

Tennis is, above all, a sport that is open to everyone and our commitment to inclusion, equality and diversity continues to strengthen and grow. Following our inaugural First Nations Day at the Australian Open, Barty visited several communities in Central Australia in February. As she learned more about local culture, the proud First Nations Ambassador also hit with members of Indigenous communities at Mutitjulu School, from Pitjantjatjara Yankunytjatjara country in Uluru-Kata Tjuta National Park, and in Alice Springs (Mparntwe).

In August, the National Indigenous
Tennis Carnival returned to Darwin,
with more than 260 young First Nations
participants representing each state
and territory. The Australian Open also
featured the first AO Pride Day, a joyful
celebration of the diverse LGBTQ+
community; the international Glam Slam,
an LGBTQ+ tournament, followed in the
AO's second week.

Players with a disability could experience competitive opportunities at both local and international levels. The AO PWII (Players with an Intellectual Impairment) and AO DHOH (Deaf and Hard of Hearing) tournaments were staged at Melbourne Park in January.

A nine-person team represented Australia at the Virtus European Summer Games in Krakow, Poland, in June, and returned home with 11 medals, including five gold.

Women and girls initiatives also expanded, with the AO Inspirational Series, Coach Connect and Women Leaders in Tennis among programs that are helping ensure a stronger representation of females at all levels of the game.

Over the last twelve months, tennis in Tasmania made significant strides in promoting tennis participation and fostering a sense of inclusivity and community across the state. Notable achievements include continued steady growth in Junior League (Orange, Green and Yellow ball) players, resulting in a combined entry of over 399 enthusiastic young athletes.

To foster a competitive tennis environment, the state witnessed an increase in competitive play opportunities for players. More leagues, events, and regional challenges were organised, attracting 698 players registered with a Universal Tennis Rating (UTR), and contributing the number of players with a unique Competitive Player Profile. These initiatives have encouraged healthy competition and enhanced player engagement, while provide more avenues for players to hone their skills and compete against their peers.

Our engagement with schools also witnessed a notable growth, with over 3,000 participants joining in on the tennis action. We are delighted to see more teachers than ever before actively engaging with Tennis, demonstrating a genuine commitment to promoting the sport among the younger generation.

The support we provided to local clubs played a pivotal role in fostering their sustainability and attracting higher participation numbers. We implemented a range of Child Safety initiatives to ensure that our clubs provide a safe and inclusive environment for all members. These efforts have not only facilitated an increase in club participation but





At the national level, our State Team players showcased their talent and dedication as they competed against the rest of the country in the Australian Teams Championships. The return of the Bruce Cup Primary School and Bruce Cup High School competition was welcomed with both teams travelling interstate to compete on the National stage. Their performances were a testament to the effort and commitment our players put in all year, and the strength and skill present within our tennis community.

We were thrilled that one of our remarkable volunteers, Hendry Lukman, was nominated for the Volunteer of the Year and was a finalist. Hendry's unwavering commitment and dedication to Hobart Out Tennis Club and all their initiatives were recognised at the prestigious Newcombe Medal event in Melbourne late in 2022.

In summary, the period from 1 July 2022 to 30 June 2023 has been marked by significant achievements in tennis participation. We have seen steady growth again in our Junior League numbers, successful Pride Night events, increased Competitive Play opportunities, heightened schools' participation, enhanced club support, notable achievements in national competitions, and well-deserved recognition for our exceptional volunteers. These accomplishments reflect our ongoing commitment to promoting tennis and building a strong, inclusive tennis community across the state.

#### **NURTURING TENNIS ENTHUSIASM** IN SCHOOLS: BRIDGING **CLASSROOM TO COURT**

The Tennis in Schools program stands as a cornerstone in our efforts to engage young minds and hearts with the sport of tennis, capitalising on its expansive reach and influence within the school setting. This strategic approach has demonstrated its efficacy, offering an avenue to connect with a substantial number of children and youth in a single day. By introducing tennis at an early age through school programs and ensuring avenues for tennis progression outside the classroom, we enhance the likelihood of sustaining their involvement over the

Tennis Tasmania has remained steadfast in its collaboration with schools, fostering connections that extend beyond the classroom to connect with local tennis coaching, club-based programming, and competitive prospects. The pivotal role played by the Sporting Schools funding initiative, provided by the Federal Government, cannot be understated in our ability to establish touchpoints with schools throughout the state. This funding has enabled over 1,600 Tasmanian school-aged children the state have engaged in tennis clinics facilitated either by Tennis Tasmania, local coaches, or teachers during their weekly HPE lessons.

Amidst the commendable tally of 1,600 participants, an even more remarkable feat has unfolded: the unwavering commitment of teachers and coaches who persist in running integrated school programmes, effectively engaging schoolchildren throughout the entire state. Beyond this achievement, an impressive 25,000 additional children have enjoyed a teacher or coach delivered tennis experience, expanding on those already engaged through the Sporting Schools initiative. This cumulative endeavour translates to an impressive 27,344 children having embraced tennis during this reporting period, across a network of 152 schools. This compelling statistic underscores the dedication and passion of our educators, resonating with the ethos of our overarching initiative.

Our schools engagement initiative serves as a conduit bridging the classroom with the tennis court, fostering lasting interest and participation. With a solid foundation laid by the Sporting Schools, we are poised to instil a lasting passion for tennis within the young generation, underpinned by the dedication of our coaches and educators.



A noteworthy accomplishment during this period involved conversations with every club and venue across the state to collect information and data to form a baseline Health Indicator of Tennis (HiT) rating. These engaging dialogues served as valuable avenues for gathering insights into critical aspects including infrastructure expenditure, participation metrics, coaching engagement, financial dynamics, and club management efficiency. The accumulation of this data facilitated a robust assessment of club and venue health. This comprehensive approach provides a solid foundation for devising future strategies aimed at optimising venue performance and propelling the sustainable growth of tennis in the foreseeable future.

The ongoing dedication to ensuring the safety of our most vulnerable

community members, especially the youth, remains of utmost importance. To fulfil this commitment, we have implemented a range of child safety initiatives, encompassing the distribution of poster kits, online educational modules, and workshops. These proactive actions have effectively empowered our clubs to create and uphold secure environments, thereby safeguarding the well-being of all participants.

Significant attention was dedicated

to refining court hire functionalities.
Upgrades were implemented for
venues equipped with 'Book A Court'
technology, and six new venues were
outfitted with Igloohome Padlocks,
thereby augmenting court accessibility
via online platforms. In line with this,
Tennis Tasmania extended support
by supplying signage to these clubs,
thereby elevating their visibility within
the community. This enhancement

continued to streamline the court booking processes and significantly bolstered court hire revenue.

Embracing digital platforms emerged as a pivotal driver in efficiencies in club operations and enhancing member experiences. A growing number of clubs now manage their programs, events, and memberships through Clubspark, the national platform for affiliated member clubs. This transition has facilitated online booking and payment processes, significantly alleviating the administrative burden on volunteers responsible for annual club management.

Despite the absence of the 'Improving the Playing Field' State Government infrastructure grant during this reporting period, our clubs have displayed remarkable resourcefulness in exploring alternative funding avenues. Support from State Government equipment grants, Local Council contributions,



Tennis Tasmania investment, and funds available through Tennis Australia's National Court Rebate Scheme played a pivotal role. The outcome of these collective efforts is evident in the substantial improvements made to 13 venues, encompassing crucial enhancements such as court resurfacing, lighting upgrades, and fencing renovations.

The Launceston Tennis Community and Events Centre (LTCEC) continued to occupy a central role in our priorities. Although faced with challenges such as escalating costs and heightened demands on local infrastructure, progress on this project persevered. Ongoing engagements with the Federal Government, including discussions with Federal Sports Minister Anika Wells and Tasmanian Senator Helen Polley, along with steadfast support from the City of Launceston and the Tasmanian Government, have set the course for a way forward. As we continue working with funding partners, the LTCEC holds the promise of becoming a vibrant hub for tennis enthusiasts, catalysing further growth within the sport.

Across Tasmania, tennis coaches continue to play a pivotal role in fostering participation and advancing our sport. Their dedication, expertise, and enthusiasm are indispensable assets to the tennis communities throughout the state's diverse regions. Over the past year, the coaching team has undertaken a range of initiatives aimed at enhancing coaching practices. One of the initial steps has been the creation and appointment of the Coach Relationship & Education Manager position, which was filled by Alyssa Hibberd in December 2022. Alyssa's role encompasses supporting current coaches and their businesses, as well as nurturing and guiding the upcoming





The central focus of this new role revolves around several key coach projects:

- Enhancing stakeholder engagement to facilitate sustainable coaching business growth.
- Incorporating regional coaching courses within the Coach Education calendar.
- Cultivating a culture of continuous learning and personal development.

## FOSTERING COACH CONNECTIONS

Building upon insights from the nationwide coach review, Tennis Tasmania and Tennis Australia is embarking on a journey to establish deeper connections with coaches through coach exchanges. This approach fosters meaningful conversations, prioritising the coach and their business within the Tasmania landscape, and jointly collaborating and problemsolving for positive outcomes for the sport. These exchanges aim to provide

targeted support to coaches while enriching the coaching landscape. The initial response from coaches has been highly positive, appreciating the dedicated efforts to understand and address their specific needs.

#### NURTURING TRAINEE COACHES AND SKILL DEVELOPMENT

Within the first six months of this role, it has become evident that a significant concern among head coaches is the scarcity of trainee (assistant) coaches to support their operations. Accordingly, a major focus has been on aiding head coaches through trainee development sessions across the state. Moreover, a collaboration with the women and girls lead at Kingston Tennis Club has led to the pilot of an extended development program for three women coaches,

an effort that could have far-reaching

positive implications. This program has provided opportunities for the trainee coaches to deliver programs and ensure activity funnels through the club, while being mentored by senior coaches.

#### EMPOWERING THROUGH WORKSHOPS AND COURSES

The drive for continuous learning is at the core of our coaching philosophy. By offering a diverse range of workshops, we encourage coaches to engage, grow, and network on a regular basis, providing a platform for sharing individual stories, experiences, and expertise. The Tennis Australia certified courses and qualification pathway have been carefully adjusted to align with the distinct needs of our coaching industry. The focus now turns to monitoring how these enhancements will inspire and equip our future coaches to lead our sport with distinction.


The return of the Hobart International once again

# PLAYER DEVELOPMENT

#### NATIONAL DEVELOPMENT SQUADS

In a stride indicative of our commitment to nurturing tennis talent, the National Development Squads (NDS) are conducted across all four school terms, welcoming a select group of athletes. Over the past year, players have maintained a steady presence in competitive arenas, consistently elevating their Universal Tennis Rating (UTR). Notably, a growing number of players across the state are advancing to Zone Squads and the Super 10s program, while many are embarking on the transition to the NDS squad.

The NDS presents a dynamic blend of on-court and off-court sessions, which encompass strength and conditioning training led by certified professionals. With the holistic growth of players in mind, squad members also enjoy interactive workshops led by facilitators, delving into vital aspects such as nutrition, anti-doping, sports psychology, cyber safety, and more.

Parallel to the National Development and Zone squads, our performance team has introduced State squads, with a dedicated focus on honing athletes for the Australian Teams Championships. These initiatives cater to eligible athletes within the 11/U, 13/U, and 15/U age

Recognising the need for cultivating competitive prowess on a national

stage, an emphasis has been placed on a younger age group. Following the successful inauguration of the state squads, an 8/U squad was introduced as a stepping stone towards the Super 10s program. This strategic move aims to identify and foster potential highperforming athletes from an earlier age.

Among our accomplished NDS members, Alicia Dale was bestowed with the privilege of a two-week training stint at the Rafa Nadal Academy in September. During this period, Alicia underwent rigorous training with two daily court sessions, complemented by strength and conditioning regimens and recovery sessions. Furthermore, athletes delved into the Rafa Nadal Foundation's principles, training alongside peers from Europe and beyond, forging bonds of camaraderie. Raphael Durek's role as the boys' manager during this venture allowed him to closely observe the training, interact with coaches, and subsequently contribute insights to enhance local training practices in Tasmania.

#### NDS by the numbers:

- 28 athletes engaged across 3 squads, spanning match play and Strength and Conditioning sessions.
- Each athlete enjoys access to 2 squads, 1 match play, and 2 Strength and Conditioning sessions.

#### ZONE (REGIONAL) DEVELOPMENT SQUADS

Turning to the Zone Development Squads, these programmes extend their influence across the state, offering players the opportunity to train under Player Development-appointed coaches. These sessions, which complement private training, provide a high-level environment for likeminded squad members to elevate their skills and connections with others. Serving as a crucial juncture on the Player Pathway, Zone Development Squads bolster players aspiring for the NDS. These programs are an indispensable part of the regional offerings, held across the North and North West of Tasmania. Although coach transitions affected the north-west offerings, the momentum remains steadfast, while the north squads have continued without interruption.

The tournament attracted an impressive lineup of talented and established players from the WTA (Women's Tennis Association) tour. Grand Slam Champions Sloane Stephens (USA) and Sofia Kenin (USA) headlined, along past champions Elise Mertens (BEL) and Alize Cornet (FRA), and a host of renowned stars including Marie Bouzkova (CZE) and more, creating an exceptional field of competitors. These high-profile players all took to the courts adding an extra level of excitement and prestige to the tournament, captivating fans locally and worldwide through the international broadcast.

Each match provided fans with a world class display of skill, agility, and mental fortitude as the competitors battled fiercely throughout the week.

The final saw Lauren Davis (USA) take out the women's singles title defeating Elisabetta Cocciaretto (ITA) 7-6(0) 6-2. The doubles event was won by the European pairing of Kirsten Flipkens (BEL) and Laura Siegemund (GER) who overcame Viktorija Golubic (SUI) and Panna Udvardy (HUN) 6-4 7-5. Off the court, Hendry also recognises the vital role HOT plays in promoting inclusivity and equality in sport. His volunteer activities extend to participation in inclusion activities, including bringing together HOT members to march in the Tas Pride parade, attending Working It Out breakfast and events, and attending IDHOBIT day at the University of Tasmania where he assists in running the HOT stall.

As a club without a home, Hendry has been pivotal to the creation of arrangements with two clubs: Lindisfarne Tennis Centre, who housed social events for HOT in the latter months of 2021; and the creation of a contract with the Domain Tennis Centre guaranteeing courts for tournaments and social play.

Tasmanian Tennis Hall Of Fame Inductee Harold Lewis Barclay

## TENNIS TASMANIA INCORPORATED NOTES TO THE FINANCIAL STATEMENTS

#### 1. REPORTING ENTITY

Tennis Tasmania Incorporated ('the Association') is an Association domiciled in Australia. The Association is incorporated under the Associations Incorporation Act 1964. The address of the Association's registered office is:

Tennis Tasmania Incorporated

2 Davies Avenue

Glebe TAS 7000

Tennis Tasmania is a not-for-profit entity and the principal activities of the Association during the course of the financial year were the promotion and development of the game of tennis in Tasmania.

#### 2. BASIS OF PREPARATION

In preparing the financial report, the Directors have made an assessment of the ability of the Association to continue as a going concern, which contemplates the continuity of business operations in the ordinary course of business and at the amounts stated in the financial report. The Association incurred a net surplus of \$12,005 for the year ended 30 June 2023 and has a net current asset position \$80,620 at 30 June 2023.

On 23 August 2017, the Association entered into an Operational Agreement with Tennis Australia, effective 1 July 2017. The Association continued to offer services to tennis clubs and tennis bodies in Tasmania and as such the Association continued to collect the affiliation fees and Tennis Australia in conjunction with Tennis Tasmania delivered the participation and operational services in Tasmania.

On this basis, the directors have formed the opinion that the Association's financial statements should be prepared on the going concern basis.

The financial statements were approved by the Members of the Board on 3 August 2023.

#### (a) Statement of compliance

The financial statements are Tier 2 general purpose financial statements which have been prepared in accordance with Australian Accounting Standards - General Purpose Financial Statements - Simplified Disclosures For-Profit and Not-for-Profit Tier 2 Entities and the Associations Incorporations Act 1964. These financial statements comply with Australian Accounting Standards - General Purpose Financial Statements - Simplified Disclosures For-Profit and NotFor-Profit Tier 2 Entities . In the opinion of the directors, the Association is not publicly accountable.

#### (b) Basis of measurement

The financial report has been prepared on the historical basis.

#### (c) Use of estimates and judgements

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

#### **3. SIGNIFICANT ACCOUNTING POLICIES**

The principal accounting policies adopted in the preparation of the financial report are set out below. They have been consistently applied to all periods presented in these financial statements.

#### (a) Financial instruments

(i) Recognition, initial measurement of derecognition.

Financial assets and financial liabilities are recognised when the Association becomes a party to the contractual provisions of the financial instrument, and are measured initially at fair value adjusted by transactions costs, except for those carried at fair value through profit or loss, which are measured initially at fair value. Subsequent measurement of financial assets and financial liabilities are described below.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and all substantial risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

#### 3. Significant accounting policies (continued)

#### (a) Financial instruments (continued)

#### (ii) Classification and subsequent measurement of financial assets.

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price, all financial assets are initially measured at fair value adjusted for transaction costs (where applicable).

For the purpose of subsequent measurement, financial assets other than those designated and effective as hedging instruments are classified into the following categories upon initial recognition:

- Amortised cost.
- Fair value through profit or loss (FVPL).
- Equity instruments at fair value through other comprehensive income (FVOCI).

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables, which is presented within other expenses.

- The Association's business model for managing the financial asset.
- The contractual cash flow characteristics of the financial assets.

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables, which is presented within other expenses.

#### (iii) Subsequent measurement of financial assets.

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVPL):

- They are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows.
- The contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

After initial recognition, these are measured at amortised cost using the effective interest method. Discounting is omitted where the effect of discounting is immaterial. The Association's cash and cash equivalents, trade and most other receivables fall into this category of financial instrument. The Association do not hold any financial assets at FVOCI.

#### (iv) Cash and cash equivalents.

Cash and cash equivalents comprise cash balances and call deposits with maturities of three months or less from the acquisition date that are subject to an insignificant risk of changes in their fair value, and are used by the Association in the management of its short-term commitments.

#### (v) Non-derivative financial liabilities.

The Association has the following non-derivative financial liabilities: trade and other payables.

Such financial liabilities are recognised initially at fair value plus any directly attributable transaction costs. Subsequent to initial recognition these financial liabilities are measured at amortised cost using the effective interest rate method.

Subsequently, financial liabilities are measured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss.

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within finance costs or finance income.

#### (b) Impairment

#### (i) Financial assets (including receivables).

The Association makes use of a simplified approach in accounting for trade and other receivables and records the loss allowance at the amount equal to the expected lifetime credit losses. In using this practical expedient, the Association uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses using a provision matrix.

#### 3. Significant accounting policies (continued)

#### (b) Impairment (continued)

#### (ii) Non-financial assets

The carrying amounts of the Association's non-financial assets, other than inventories, are reviewed at each reporting date to determine whether there is any indication of impairment. If any such indication exists, then the asset's recoverable amount is estimated.

#### (c) Provisions

A provision is recognised if, as a result of a past event, the Association has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability.

#### (d) Revenue and other income

#### (i) Sale of goods

Revenue from the sale of goods is measured at the fair value of the consideration received or receivable, net of returns and allowances, trade discounts and volume rebates. Revenue is recognised when the significant risks and rewards of ownership have been transferred to the buyer, recovery of the consideration is probable, the associated costs and possible return of goods can be estimated reliably, and there is no continuing management involvement with the goods.

#### (ii) Rendering of services

Revenue from services rendered is recognised in the profit or loss in proportion to the stage of completion of the transaction at the reporting date. The stage of completion is assessed by reference to surveys of work performed.

#### (e) Finance income

Finance income comprises interest income on funds invested. Interest income is recognised as it accrues, using the effective interest method

#### (f) Income tax

The income of the Association is exempt from income tax, and accordingly, no provision has been made in the accounts for income tax payable.

Withholding tax from other jurisdictions is provided when the liability is due and payable.

#### (g) Goods and services tax

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated with the amount of GST included.

Cash flows are included in the statement of cash flows on a gross basis. The GST components of cash flows arising from investing and financing activities which are recoverable from, or payable to, the ATO are classified as operating cash flows.

#### (h) Significant accounting policies

No new accounting standards, amendments to accounting standards and interpretations have been identified as those which may impact the Association in the period of initial adoption.

#### 4. DETERMINATION OF FAIR VALUES

A number of the Association's accounting policies and disclosures require the determination of fair value, for both financial and non-financial assets and liabilities. Fair values have been determined for measurement and/or disclosure purposes based on the following methods. Where applicable, further information about the assumptions made in determining fair values is disclosed in the notes specific to that asset or liability.

#### Trade and other receivables

For receivables with a remaining useful life of less than one year, the notional amount is deemed to reflect the fairvalue. All other receivables are discounted to determine the fair value.

With respect to the Launceston Regional Tennis Centre, Tennis Tasmania's 20 year lease with the City of Launceston (which commenced in February 2011 and was to expire in February 2031) was transferred to Tennis Australia. During the financial year ended 30 June 2023, \$0 operating lease expense was recognised in the statement of profit or loss and other comprehensive income (2022: \$0).

- (a) the financial statements and notes set out on pages 3 to 10, are in accordance with the Associations Incorporation Act 1964, including:
  - (i) giving a fair presentation of the Association's financial position as at 30 June 2023 and of their performance, and
  - (ii) complying with Australian Accounting Standards and the Associations Incorporation Act 1964;
- (b) there are reasonable grounds to believe that the Association will be able to pay its debts as and when they become due and payable.
