



TENNIS TASMANIA BOARD VACANCY Public Call for Expressions of Interest

OVERVIEW

Tennis Tasmania is calling for nominations to fill vacant Director positions in accordance with the Tennis Tasmania Constitution.

ABOUT THE ROLE

The Board, comprising 6 elected and up to 3 appointed directors, is responsible for overseeing the governance and strategic direction of Tennis Tasmania.

The board typically meets 6 times per year, across Tasmania or remotely via Teams from 4.30pm – 7.30pm on a Wednesday. Board members are expected to attend the annual general meeting (AGM), club and community forums, and the awards function that follows the AGM.

Director positions are voluntary.

SELECTION PROCESS

Interviews may take place with suitable candidates following the EOI process. Candidates with the optimal skills and experience will be considered by the Nominations Committee. Candidate information will be provided to all members for completion of an election process, if required, by the 2023 AGM.

Tennis Tasmania supports and encourages a diverse range of applicants to express interest in the roles. The Board seeks to have a broad representation (including but not limited to gender, age, regional representation, diversity, skills, and experiences) of Directors to represent tennis in Tasmania.

All Directors are required to hold a current Working with Vulnerable People (Children) Card (TAS) and National Police Check (or show proof of application), and sign any required policy of Tennis, including, but not limited to, the Member Protection Policy declaration.

A Director with experience in governance, an understanding of board governance, and strategic and public policy.
