Clubs are reminded that The Entire Team is required to umpire each finals match – a minimum of four umpires are to be supplied.

Please check all matches to ensure your clubrooms are open if they are required for a finals match and check carefully to ensure you are aware of all your teams responsibilities.

Clubrooms to be open by 10am.

- Collection of team sheets consisting of personnel of teams in correct order of play.
 - Collection of the balls from opposing captains
 - Transferring of names from each sheet and recording results of the sets as completed.
 - Umpiring the sets concerned.
 - Ensuring that the match is conducted in accordance with the Code of Conduct.

- 2.8.6 Umpires/referees are in sole control of the match and their decisions are final.
