Umpiring the sets concerned.

Ensuring that the match is conducted in accordance with the Code of Conduct.

2.8.6 Umpires/referees are in sole control of the match and their decisions are final.

Top grade, Tennis Victoria approved, coloured new balls shall be provided as follows:

**SIX PLAYER TEAMS:**

Finals Matches: Two pair by each team

**FOUR PLAYER AND THREE PLAYER TEAMS:**

Final Matches: One pair by each team

Either team may provide an additional pair of new balls at any stage of the match.
