Collection of the balls from opposing captains
Transferring of names from each sheet and recording results of the sets as completed.
Umpiring the sets concerned.
Ensuring that the match is conducted in accordance with the Code of Conduct.
- 2.8.6 Umpires/referees are in sole control of the match and their decisions are final.
- 2.11 **BALLS:**
Top grade, Tennis Victoria approved, coloured new balls shall be provided as follows:
SIX PLAYER TEAMS:
Finals Matches: Two pair by each team
FOUR PLAYER TEAMS:
Final Matches: One pair by each team
Either team may provide an additional pair of new balls at any stage of the match.
