### VACCINATION REQUIREMENT AT ITF WORLD TOUR EVENTS IN AUSTRALIA

In order to be allowed to participate in the tournament, all players and player support team members must be fully vaccinated and must be able to show our Pro Tour team acceptable evidence as follows:

- if they received their vaccines in Australia, their COVID-19 digital certificate printed or displayed through the Medicare app, Check-In Qld app or equivalent smartphone wallet; or
- if they received their vaccines outside of Australia, their:

Australian International COVID-19 Vaccination Certificate; or

a paper or digital certificate (in English or accompanied by a certified translation) issued by an overseas government authority or accredited overseas government vaccination provider that shows:

- their name as per their passport;
- their date of birth or passport number;
- the vaccine brand name, which is approved or recognised by the Australian Therapeutic Goods Administration; and
- the date of each dose or the date on which the full course of immunisation was completed.
