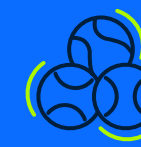

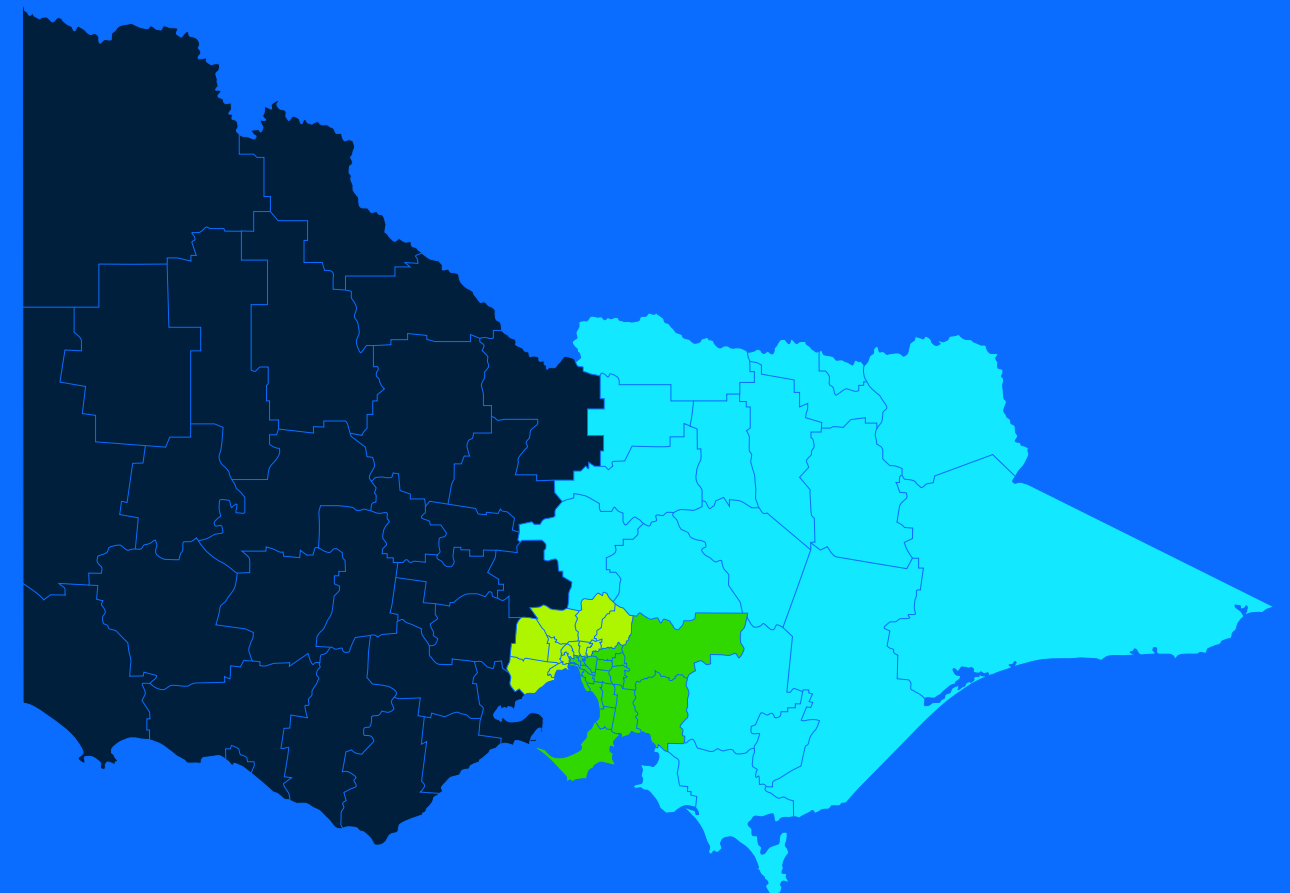

Safeguarding Children

Tennis Victoria has a zero-tolerance approach to any form of child abuse and is committed to ensuring the sport of tennis is a safe and friendly environment for children and young people.

We commit to ensuring the sport of tennis is a safe environment for all children and young people, including Indigenous children, those from culturally and racially marginalised backgrounds and all abilities.



Safeguarding Children Requirements

Tennis Victoria must comply with, and ensure compliance with the Tennis Australia National Policies, including but not limited to, the Member Protection Policy and Safeguarding Children Code of Conduct. Tennis Victoria member associations, clubs, and centres in turn should ensure compliance of their members.

Appoint a Member Protection Information Officer

Every affiliate is required to nominate a Member Protection Information Officer (MPIO), who is the dedicated person who serves as the first point of contact for any concerns or issues in relation to children and young people participating in tennis at their venue or within their competition and activities.

The role is also responsible for providing information and support to persons with concerns and complaints and providing advice on policies and procedures, including the Tennis Australia National Policies and the Tennis Australia Integrity Hotline.

Formally adopt Tennis Australia National Policies

Affiliates of Tennis Victoria are bound by, and must comply with, the Tennis Australia National Policies, including but not limited to the Member Protection Policy and Safeguarding Children Code of Conduct.

Ensure all committee members, coaches, and volunteers have a valid Working with Children's Check and maintain a register of Checks

The Working with Children Check (Check) enforces a mandatory minimum checking standard for people who work with children in either a paid or volunteer capacity, and it is a legal obligation for anyone over the age of 18 that is planning to do child-related work and are in direct contact with children to obtain a Check, unless exempt.

Tennis Victoria strongly encourages everyone involved with delivering tennis in Victoria to abide by the legal obligations as individuals, and as sporting organisations.

Utilise Safeguarding Children Resource Kit - A Safer Game Plan

Tennis Australia's national education and awareness campaign, A Safer Game Plan, aims to provide resources to help promote and support the tennis community with their responsibilities for safeguarding children on and off the court.

Tennis Victoria affiliates are expected to be familiar with the Safeguarding Children Resource Kit as part of A Safer Game Plan, which has been developed to assist volunteers and administrators create safe, friendly environments for all children and young people. National Insurance Program

Member associations, clubs, and centres of Tennis Victoria will enjoy coverage under the Tennis Australia National Insurance Program.



The coverage includes:

1

Public Liability Insurance

This insurance can help protect your club against the financial risk of being found liable to a third party for death or injury, loss of or damage to property or 'pure economic' loss resulting from negligence.

2

Management Liability

This insurance can help cover a range of financial risks for your club's directors and officers including some of the costs associated with any fraudulent activity.

3

Personal Injury Insurance

This insurance is designed to help offer some peace of mind to members, participants, volunteers etc. of your club by having protection against costs related to an injury sustained whilst involved in a tennis match.

Records of all registered players must be kept. In the event of an injury claim, Tennis Victoria are required to verify claimant membership to Howden. We recommend ensuring all participants are registered in ClubSpark each year to streamline this process.

Membership Categories

Association

An incorporated body comprised of three or more association member clubs for the purpose of competitions.[^]

Country Tennis Association

Means a Tennis Body which is an aggregation of 3 or more Country Tennis Clubs.

- » Small Country Association (3-29 member clubs)
- » Large Country Association (30+ member clubs)

Metropolitan Tennis Association

Means a Tennis Body which is an aggregation of 3 or more Metropolitan Tennis Clubs.

- » Small Metropolitan Association (3-29 member clubs)
- » Large Metropolitan Association (30+ member clubs)

[^] Where an Association has tenure over a venue, they will be categorised and charged according to the Club definitions i.e. based on their location and the number of courts at their venue.

Club

An incorporated body comprised of club members.

Country Tennis Club

Means a Tennis Body which is a tennis club situated within the State of Victoria and located within a regional Victoria local government area as recognised by the State Government from time to time, including the Mornington Peninsula Shire.

- » Country 1-4 Courts
- » Country 5-9 Courts
- » Country 10-19 Courts
- » Country 20+ Courts

Metropolitan Tennis Club

Means a Tennis Body which is a tennis club situated within the State of Victoria and located within a metropolitan local government area as recognised by the State Government from time to time, excluding the Mornington Peninsula Shire.

- » Metropolitan 1-4 Courts
- » Metropolitan 5-9 Courts
- » Metropolitan 10+ Courts

Commercial Centre

Professionally administered tennis business/venue with formal business registration. For the purpose of membership, commercial centres will be categorised per the Club definition (see above).

Restricted Associate

Any unincorporated Tennis Body under the authority of a larger organisation (e.g. an unincorporated church-based club under the authority of the Melbourne Catholic Archdiocese), that does not meet the definition of an Association, Specialist Body, Club or Commercial Centre and within the Constitution. Restricted Associate Affiliates do not have voting rights and are not covered under the Tennis Australia National Insurance Program but are eligible to access all other benefits and services unless otherwise specified in By-Laws.

Professional Club Business

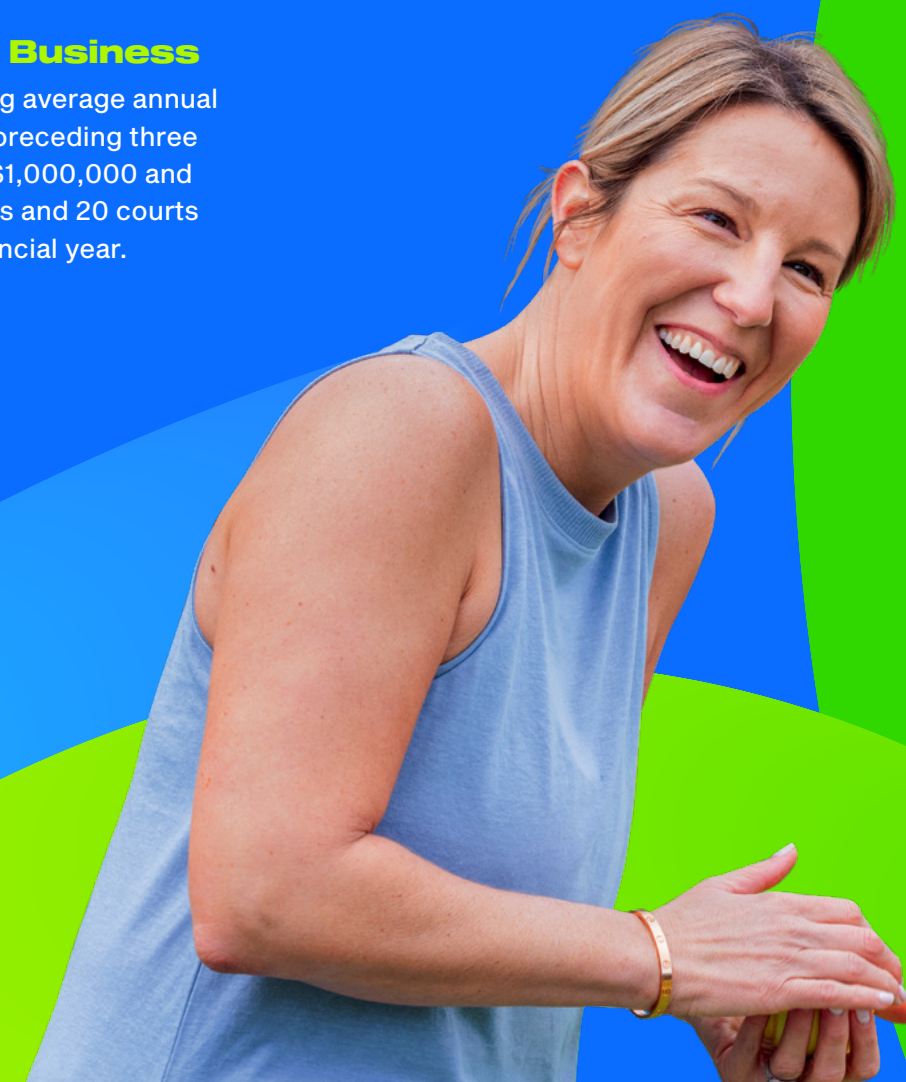
A tennis club with a recurring average annual operating revenue over the preceding three financial years in excess of \$1,000,000 and with 3,000 or more members and 20 courts or more, in the previous financial year.

Associate

Schools, and any other Tennis Bodies that do not meet the definition of Association, Specialist Body, Club or Commercial Centre as contained above and within the Constitution. Associate Affiliates do not have voting rights but are eligible to access all other benefits and services of affiliates unless otherwise specified in By-Laws.

Specialist Body

Tennis Officials Australia - Victoria, Tennis Coaches Association - Victoria, and Tennis Seniors Victoria.



Securing your membership



Collect

Ensure you have applicable legal status evidence (i.e. incorporated association certificate or ABN) and accurate contact details for three representatives (i.e. President, Secretary, Treasurer).



Ensure

Ensure you have records of members/participants prior to taking to the court for insurance purposes and safeguarding children requirements are being met.



Submit

Membership renewals open from June and close and pay by August 31 2025. Renewing members will be sent a membership renewal link directly.



Payment

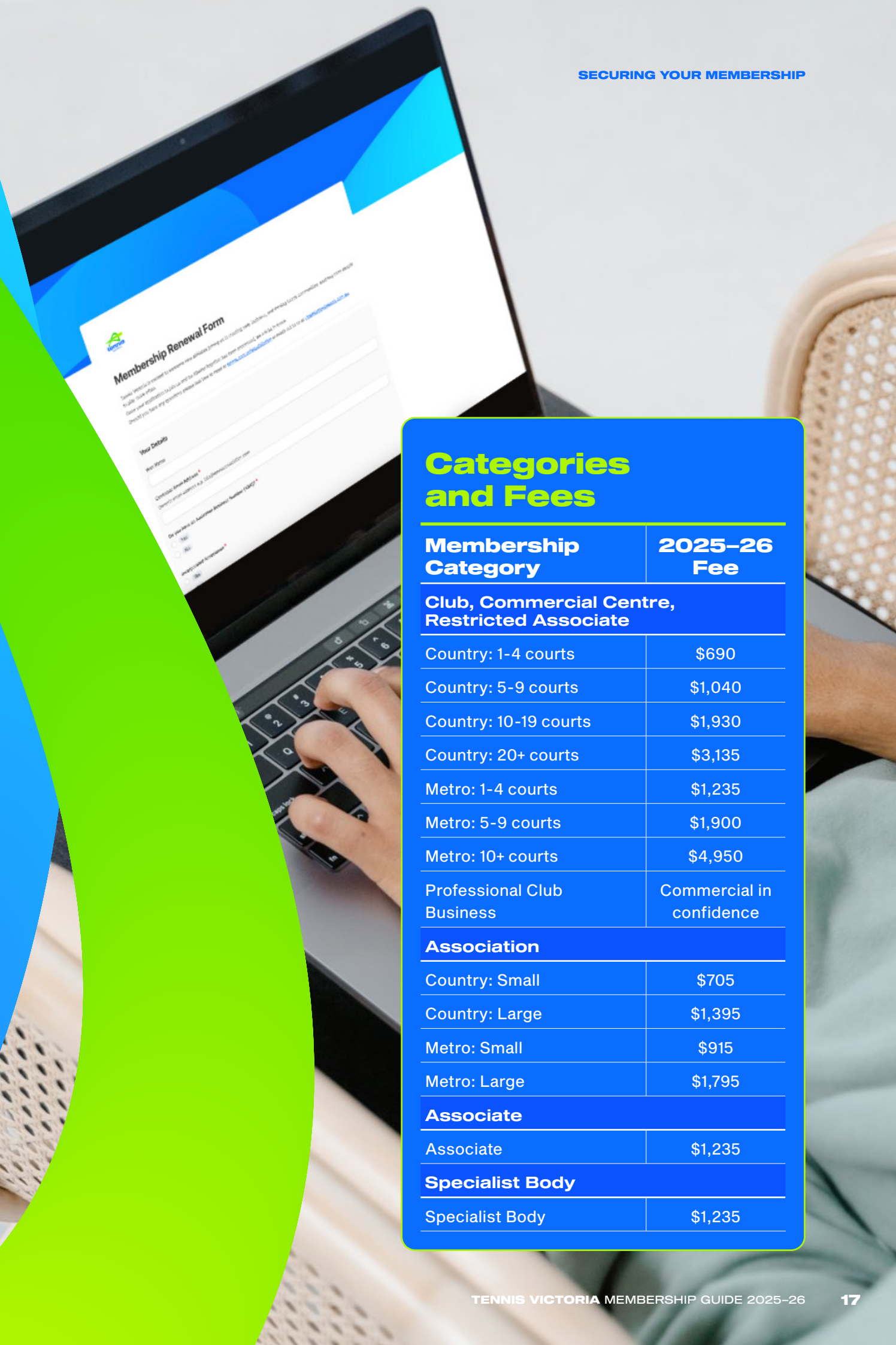
Pay your membership fees in full by the due date of August 31 2025. Invoices will be distributed from July 1 2025, once your membership renewal application form is received.

Non-compliance with any of the above or the payment due date, may result in players being uninsured and your membership ineligible. Any association, club, or centre with outstanding membership fees[^] at August 31 2025 will no longer receive access to membership benefits, including ClubSpark, and your eligibility to participate in Tennis Victoria Leagues and Events, will cease.

A Certificate of Currency will not be issued without full payment[^] of invoice and completion of the membership renewal.

Should you encounter difficulty in paying your invoice, please contact your Associations Liaison or Tennis Development Officer. Only members who register to pay by direct debit will have the option to pay in instalments or be considered for payment plans.

[^] Members paying by direct debit will be considered a paid member at August 31 2025.

Paying by direct debit

Paying your fees with Tennis Victoria has never been easier with our new direct debit program.

We understand that more time on paperwork means less time on things that really matter – acing your delivery of tennis.

So, take the stress out of manually paying your invoices and leave the payment processing to us, and you can focus on your success on and off the court.

Why pay by direct debit?

- Avoid the hassle of making manual payments, especially if more than one signatory is required – your direct debit will roll over each year, unless you tell us otherwise.
- Tell us how you want to pay your annual membership fees – you can choose to pay your invoice in one or two instalments.
- Along with paying your membership fees by direct debit, you can now elect to pay any Tennis Victoria invoice by direct debit. We will be sure to let you know prior to taking any payments.

Setting up direct debit

To set up direct debit, simply follow the steps below:



Download Direct Debit Request Form

Ensure all information provided is accurate and all sections are complete on the **Direct Debit Request Form**.



Submit Form

Completed Request Forms must be submitted on your membership application form by August 13 2025 to ensure payment is secured prior to the August 31 2025 deadline.

When you set up a direct debit arrangement with us, that arrangement is subject to the **Direct Debit Request Form** you provide and governed by our **Direct Debit Request Service Agreement**.
