We can't predict which organisations may be successful. Keep in mind that we are after quality applications that meet the criteria, and not quanitity. If your organisation is eligible to apply, and your project idea meets the assessment criteria listed in the guidelines, we'd encourage you to submit. Organisations can submit multiple applications, and form partnerships that submit applications, provided that each project idea submitted is distinct .

We're not able to comment on which stream has the best chance of success, what is funded will depend on the quality of applications that we receive. Importantly, VicHealth Partnership Grants are extremely competitive, and we expect to receive far more eligible applications than can be funded. If your organisation is eligible to apply, and your idea addresses a priority population group and theme, we encourage you to submit.
