



Welcome to Tennis Victoria Country Week !

To help ensure all entrants enjoy this great tennis event, conditions of participation are provided below

By entering and/or participating in Tennis Victoria Country Week (**Event**), entrants agree to abide by the following conditions:

1. Entrants acknowledge that the Country Week Event Conditions and Rules apply to all matches at the Event. Entrants acknowledge that they have been provided with a copy of, and read, the Country Week Event Conditions and Rules and all entrants agree to be bound by such Conditions and Rules.
2. Entrants acknowledge that they will be exposed to certain risks when participating in the Event, including but not limited to physical injury and death. All entrants enter participate in the Event at their own risk.
3. Entrants declare that they are medically and physically fit and able to participate in the Event. Please notify Tennis Victoria (**TV**) of any change to your medical condition, fitness or ability to participate.
4. To the fullest extent permitted by law, you agree to release and discharge Victorian Tennis Association / TV and its directors, officers, employees, volunteers and agents from all liability in respect of any loss or damage you may suffer.
5. Entrants authorise TV to obtain medical assistance, treatment and transport as deemed reasonably necessary by TV and acknowledge that they will be responsible for any costs associated with any such medical treatment and/or transportation.
6. Entrants agree to abide by and comply with all of Tennis Australia's national policies which can be obtained at <http://www.tennis.com.au/about-tennis-australia/reports-and-policies/policies>;
7. Entrants must behave appropriately and follow the lawful directions of TV and event staff at all times.
8. Derogative comments, abusive language and inappropriate or disruptive behaviour will not be tolerated.
9. Entrants are responsible for their own property at all times. TV does not accept any responsibility for any property that is stolen, lost or damaged at the Event.
10. Entrants must wear appropriate attire at all times.
11. Entrants consent to TV and its government and commercial partners taking your image while participating in the Event, and further agree that any such photographs or video footage may be used by the above organisations in resources, reports and in promotional, advertising or marketing materials, without any further notice or payment to the Entrant.
12. Entrants acknowledge that if they breach these conditions of participation, TV may take action including, but not limited to suspending or defaulting you from the Event.

WARNING UNDER THE AUSTRALIAN CONSUMER LAW

Under the Australian Consumer Law (Victoria), several statutory guarantees apply to the supply of certain goods and services. These guarantees mean that TV is required to ensure that the recreational services TV supply to you are rendered with due care and skill; and are reasonably fit for any purpose which you, either expressly or by implication, make known to TV; and might reasonably be expected to achieve any result you have made known to TV. Under section 22 of the Australian Consumer Law and Fair Trading Act 2012, TV is entitled to ask you to agree that these statutory guarantees do not apply to you. By participating in Tennis Victoria Country Week, you will be agreeing that your rights to sue us under the Australian Consumer Law and Fair Trading Act 2012 if you are killed or injured because the services provided were not in accordance with these guarantees, are excluded, restricted or modified in the way set out in this form.

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on TV's part. Gross negligence, in relation to an act or omission, means doing the act or omitting to do an act with reckless disregard, with or without consciousness, for the consequences of the act or omission. See regulation 5 of the Australian Consumer Law and Fair Trading Regulations 2012 and section 22(3) (b) of the Australian Consumer Law and Fair Trading Act 2012.
