Criteria

- BOYS - at least 4 of the nominated players must have a UTR higher than 8.9
- GIRLS – at least 4 of the nominated players must have a UTR higher than 5.9
- Affiliated club have a strategic objective fit with talent development programmes
- Capacity to resource a strong junior state league team
- Club support
- Coaching level, player-performance pathways, leverage talented player development
- Venue suitability including seating, changerooms and spectator shade
- Availability of personnel & volunteers
- Availability of screened Match Supervisors

Age Restrictions- age taken at the 1st day of Round 1 for the 2024-2025 season.

- 18 years and younger
- Minimum age for players of 13 years

4 Courts per fixture (recommended)

- If this is not possible due to court allocation issues, the club MUST advise Tennis West of solutions and plan to finish matches in the time schedule.





Court Monitors

- It is mandatory that all State League Clubs provide an Officially trained 'Court Monitor'. Training is provided [here](#).

Encouragement of Clubs Collaborating to Create a Team

- The aim is to ensure competitive matches suited to the development of talented players. Therefore, as there are only a certain number of players of the appropriate standard, we encourage Clubs to collaborate to form a team. E.g. Blue Gum Park/Midland

- Team uniforms are encouraged to enhance the team experience.
