

Fitness Trainer Membership – Terms and Conditions

I understand and agree:

1. If my application for Fitness Trainer Membership is accepted, I will be subject to and bound by all relevant Tennis Australia Limited (**TA**) policies and by-laws (as developed and/or amended by TA from time to time) including but not limited to the Member Protection Policy, the relevant Coaches Membership Policies and the Anti-Doping Policy. These policies are available at tennis.com.au/coaches/membership/policies and tennis.com.au/about-tennis-australia/reports-and-policies/policies.
2. In order to protect the integrity and safety of the sport of tennis, I acknowledge and agree that all applicants must comply with and meet TA's screening requirements and any insurance eligibility requirements before their application is processed and accepted and insurance is provided. I understand that Fitness Trainer Members must meet the Australian WWC or National Police Check requirements that apply to them and must read, complete, sign and return a Member Protection Declaration with their application.
3. As a Fitness Trainer Member I must:
 - a. act in a professional and lawful manner at all times;
 - b. promote and support TA's programs and activities;
 - c. not do, or have previously done, anything that may, in TA's reasonable opinion, bring TA or the sport of tennis into disrepute; and
 - d. only use TA's branding and program materials in relation to TA endorsed activities and not for any other purpose.
4. TA reserves the right to reject my application, accept my application but impose certain conditions, and/or suspend or cancel my existing membership during the term based on any of the following:
 - a. the results of TA's screening processes or information about criminal activities that TA subsequently becomes aware;
 - b. my failure to meet TA's membership and insurance requirements;
 - c. my breach of a policy or by-law referred to in item 1; and/or
 - d. my breach of this agreement,provided that decision is not contrary to any applicable laws.
5. Membership fees are non-refundable (even if a membership is suspended or cancelled) and membership is personal and not transferable.
6. A Fitness Trainer Member must have fitness training qualifications recognised by TA. I must provide evidence of my qualifications with my application if I am not an existing TA Member.
7. A Fitness Trainer Member must be affiliated with a Tennis Australia qualified coach member who has purchased the Cardio Tennis upgrade within Coach Membership, unless otherwise approved by Tennis Australia in its absolute discretion (which consent may be subject to conditions such as the requirement to conduct the Cardio Tennis Program at a venue affiliated with Tennis Australia or to affiliate with a Tennis Australia qualified coach member who is subsequently nominated by Tennis Australia).
8. If joining TA Fitness Trainer Membership for the first time, a pro-rata portion of the annual membership payment will be accepted (as calculated by TA). Pro-rata payments are not otherwise applicable or accepted.
9. Where the Fitness Trainer provides any personal information relating to a tennis program participant (**Participant**) to an Australian Tennis Organisation, the Fitness Trainer must ensure that:
 - a. the Participant's personal information is accurate, complete and up to date; and
 - b. the Participant (or, if the Participant is under 18 years of age, their parent or guardian) has consented to the provision of that information to the Australian Tennis Organisation and understands that their information will be used in

accordance with the tennis privacy policy located at www.tennis.com.au/privacy and privacy collection statement located at www.tennis.com.au/privacy-statement.

10. TA reserves the right to vary these terms and conditions from time to time by replacing them on its website.
