## Participation Coaching Course Learning Outcomes

A great way to start your coaching journey, the Tennis Australia Participation Coaching Course is suitable for those who would like to begin coaching Tennis, or who are currently coaching, under the guidance of a qualified coach. This course trains coaches to assist in conducting safe Hot Shots Tennis activities under the direct supervising of a qualified coach.

The course is delivered on-court with participants actively learning to assist in delivering coaching sessions where players serve, rally and score using modified balls, racquets, nets and courts appropriate to the developmental needs of junior players.

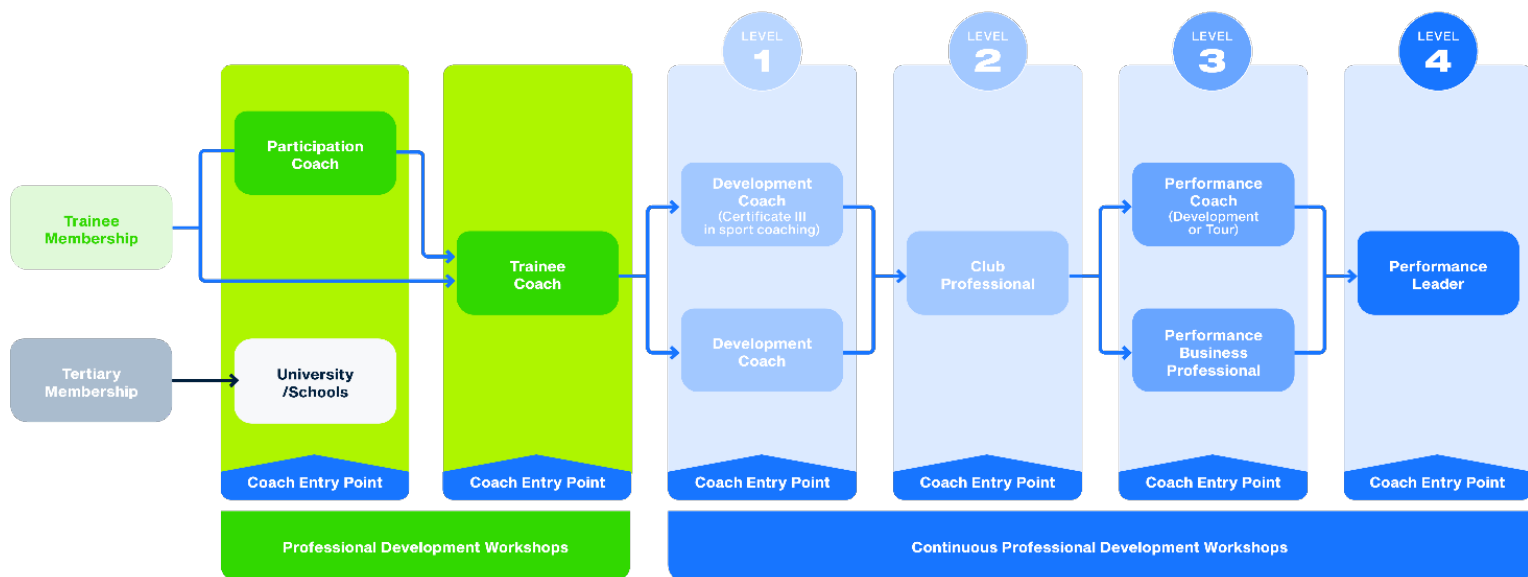
- Assist in conducting safe Blue Stage and Red Stage Hot Shots Tennis activities under the direct supervising of a qualified coach
- Awareness of contemporary coaching methodology
- Awareness of Tennis Australia national policies (eg. Member Protection policy and Child Safety guidelines), the Coaches Code of Conduct, and the legal & ethical responsibilities of a Tennis coach.

The course is scheduled over:

1. An online self-paced Safeguarding Children course via our online learning platform Bounce
2. One 6-hour on-court day.

After completion of the; Safeguarding Children course, and on-court session, applicants will receive a certificate of course completion and Trainee Tennis Australia Coach Membership.

## Tennis Australia Coach Education Pathway



The Tennis Australia coach education pathway provides flexible entry options with the online Participation Coaching Course, the Trainee Coaching Course and the Development (Level 1) Coaching Course, this enables applicants to commence at the level most suited to their prior learning and experience.

Applicants can also enter a specialist field of education in the areas of Business & Venue Management, Padel, POP Tennis or Pickleball.

## Participation Coaching Course Entry Criteria

To gain acceptance into the Tennis Australia Participation Coaching Course applicants are required to meet the following criteria:

- Be a minimum of 16 years of age at the commencement of the course. <sup>1</sup>
- Maintain a suitable physical fitness level to complete the practical components of the course. <sup>2</sup>
- Comply with all requirements of the Tennis Australia Member Protection Policy. Requirements vary around Australia, details can be found at the Tennis Australia [Coach Membership policies on the TA website](https://www.tennis.com.au/coaches/membership/policies) (tennis.com.au/coaches/membership/policies).
- Obtain and provide Tennis Australia with suitable screening requirements based on the applicants state/territory and age. For more details on these requirements, please see 'Screening Requirements' listed on page 3. For applicants aged 18 and over, they will be required to provide evidence of the following during the online application process: <sup>2</sup>
  - A copy of a current Working with Children Check (WWCC) or state/territory equivalent.
  - A copy of a National Police Check (NPC). A suggested provider is [National Crime Check](https://www.nationalcrimecheck.com.au) (nationalcrimecheck.com.au) at a cost of \$58.90 (Inc. GST).
  - A signed Tennis Australia Member Protection Declaration (MPD), this declaration is completed online as part of the application process.
- Complete and [submit an application online via the TA website](https://courseapplications.tennis.com.au) (courseapplications.tennis.com.au) before the application closing date. <sup>3</sup>
- Payment of \$135.00 (Inc. GST) course fee, which will be requested after the application has been accepted into the course. Successful applicants will be advised within 7 days of the closing date. <sup>4</sup>

Notes:

1. Please note to deliver the Tennis for Primary Schools or Secondary Schools program, applicants must be 18 years of age.
2. Additional information can be obtained by contacting the Course Coordinator. Their contact details are listed on page 1.
3. The application closing date is listed on page 1.
4. Participants aligned with a Qualified or Business Tennis Australia Coach Member are eligible for a 30% discount off the full course fee. The reduced fee will be \$95.00 (Inc. GST). A copy of the 'Supervising Coach Form' is available on page 5. Additional scholarships or subsidies may be offered to eligible recipients. Scholarships or subsidies may be offered to eligible recipients. There are more details listed on page 4.

## Screening Requirements

A copy of the applicants screening documents will be required to be submitted with their online application, and we recommend that applicants obtain the required documents before commencing an online application. Receipts of lodgement of the documents can be uploaded during the online application process, in place of the completed check.

## Selection

All applicants will be notified of the status of their application by email within 7 days of the closing date.

In some instances, there are a limited number of positions available in the course. Course applicants will be admitted to the course based on their application and their ability to meet the course entry criteria.

## Scholarships & Subsidies

Scholarships or subsidies may be offered to eligible recipients.

Tennis Australia provides a President's Women In Tennis Scholarships to eligible applicants into the Participation Coaching Course and higher. Tennis Australia recognises that Women are underrepresented in the coaching community and are determined to increase the number of Women coaches in Tennis. The scholarship provides several benefits to the applicant, including a discount in the course fees. An application form will be available on the ['Course & Workshop Calendar' on the TA website](#).

## Compulsory Attendance

If accepted into the course, applicants must agree to attend all the sessions, including any online learning sessions. In the event of non-attendance applicants will be required to attend contact days at a future course to make up the sessions missed. If applicants are unable to attend due to illness, a medical certificate is required.

## Refund Policy

Upon acceptance into the Tennis Australia Participation Coaching Course, applicants are required to pay the full course fees prior to the first day of the course.

Fees paid by applicants may be refunded in the following circumstances and time frames:

- For withdrawals received in writing, after accepting a place in the course but before the first day of the course, fees will be refunded less a \$50.00 (Inc. GST) administrative fee.
- For withdrawals received after the course start date, no payments will be refunded.

## Tennis Australia Coach Membership

On completion of the Tennis Australia Participation Coaching Course, applicants may be eligible to receive a complimentary Trainee Tennis Australia Coach Membership (if not already an existing member). Complimentary membership is valued at up to \$218.00 (Inc. GST) and will be valid for up to 24 months. On going membership after 24 months can be continued at no charge if the applicant is working under a Tennis Australia Coach Member with a Business package or \$49.00 (Inc. GST) if the applicants head coach is a Qualified Tennis Australia Coach Member.
